TELEPHONE COURTESY

You can prompt courtesy in others by your own manners; and you can facilitate your business as well.

Teletips

1. Be sure of the number you are calling.
2. Allow time for people to answer.
3. Place calls direct.
4. Answer promptly.
5. Identify yourself — Don't say "Hello."
6. Be friendly.
7. Speak in normal tones.
8. Be helpful.
9. Explain delays if you leave the telephone.
10. Be attentive.
11. Be tactful.
12. Don't bang the receiver.

Friendliness generates friendliness.

DIALING INFORMATION

CAPITOL TELEPHONE SYSTEM

1. Always be sure of the number you wish to dial.
2. Always listen for the dial tone.
3. To place inter-departmental calls to those State Capitol numbers having the prefix 892, dial the four digit extension numbers as listed in the State of Colorado Directory.
4. To place an outside call, you must first dial "9", which gives you an outside trunk line. Listen for the outside dial tone then dial the appropriate number as listed in the Metropolitan Denver Telephone Directory.
5. Authorized long distance calls may be placed by dialing "9" which gives you an outside local trunk line, and following the Direct Distance Dialing instructions given on page 6 of the Mountain Bell Directory. After you have completed dialing, the Mountain Bell operator will ask for your number.
6. To obtain numbers not listed in the State of Colorado Telephone Directory, call the Capitol operator by dialing "0".
7. To report service difficulties or equipment trouble on the Capitol telephone system, dial 2200 for the Chief Operator.
8. Save time and expedite your calls by advising agencies outside the Capitol telephone system that they may dial direct by using the prefix 892 and your extension number.

TRANSFERRING CALLS

If you wish to transfer a call to another number simply depress the plunger in the receiver cradle once. This will alert the Capitol switchboard operator who will answer.

TANDEM SERVICE

Tandem service provides a direct trunk line to the number you wish to reach, by-passing the switchboard and eliminating the need for operator assistance.

To use a tandem line, dial the tandem number, then dial the extension number you wish to reach.

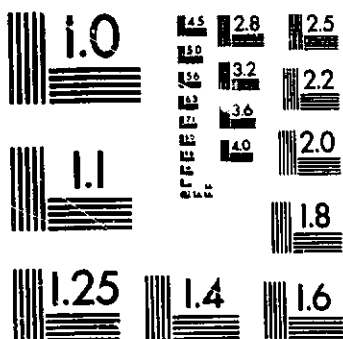
