Office of Planning and Analysis

The Office of Planning and Analysis exists within the Colorado Department of Corrections to provide research, information and data analysis services. The office also monitors population projections, analyzes legislative impact studies, oversees the administrative regulations, and conducts program and system evaluations as directed by statute or executive priority.

General Statistics, Reporting and Evaluation Unit

The General Statistics, Reporting and Evaluation Unit within the Office of Planning and Analysis analyzes data, evaluates programs and conducts research for internal management and external criminal justice use. This unit gathers, compiles and analyzes data for a multitude of agencies and purposes. These findings are typically reported only to the requested party and not disseminated to internal staff or management.

About this Bulletin

This publication is intended to provide an overview of statistical information and findings generated by this unit. Dissemination of this information to staff and other interested individuals will be provided through this periodical publication.

Comparison of Admissions and Releases for Fiscal Years 1998 and 1999 (Preliminary)

A comparison of the number of admissions and releases for the adult prison system in Colorado for fiscal years 1998 and 1999 (preliminary) is provided on the next page. Youthful Offender System (Y.O.S.) admissions and releases are also reported for the same time periods.

The quarterly average for fiscal year 1998 is computed for comparison to the quarterly figures for fiscal year 1999. The 1999 figures are preliminary and reflect only admission data which will differ slightly from the sentencing data reported later in the annual statistical report.

- The number of adult admissions increased over 7% as a result of increased parole returns for both technical and new felony convictions.
- All other admission types including new court commitments excluding parole returns remained stable.
- The increase in adult prison releases of 8.5% is attributable to the increase of 41.7% in mandatory releases to parole.
- Admissions to Y.O.S. were down 3.37% to 86 in fiscal year 1999 while releases from the program increased 33.3%.
- Fourth quarter 1999 figures indicate a continued increase in the number of parole returns and a decrease in the number of releases to discretionary parole.

⁽²⁾ The number of technical parole returns is overstated and the number of returns with a new felony is understated for FY 1999 as the new felony conviction may be delayed. The admission type is changed to parole return-new felony when the conviction is received.

⁽³⁾ Other admissions include returns from a prior release to probation, court order discharge or appeal bond; interstate compact, and Y.O.S. terminations.

⁽⁴⁾ Other releases include releases to probation, court order discharge, appeal bond, and deceased.
