


About this Bulletin


>> Prison Admissions and Releases by Fiscal Year*

Recent trends on the number of admissions and releases for the adult prison system and the Youthful Offender System (Y.O.S.) are reported in this bulletin. Fiscal years 2005 and 2006 figures are preliminary and reflect admission data, which differs slightly from sentencing data reported later in the annual statistical report.

⁽¹⁾ FY05 & FY06 admission numbers are based on the date added to the backlog which may differ from sentencing numbers which reflect the date sentenced by the courts.

- Adult admissions in fiscal year 2006 increased 8.8%.
 - New court commitments increased 7.7%.
 - Total parole returns were 10.0% higher.
- Adult releases increased 8.5% in fiscal year 2006.
 - Total parole releases increased by 14.3%.
 - > Total discharges from incarceration were 11.4% lower.
- Y.O.S. admissions increased by four offenders (7.4%).
- Y.O.S. releases were 11.8% lower.

⁽²⁾ The number of technical parole returns is overstated and the number of returns with a new felony is understated for FY05 & FY06 as the new felony conviction may be delayed. The admission type is changed to parole return-new felony when the conviction is received.

⁽³⁾ Other admissions include returns from a prior release to probation, court order discharge or appeal bond; interstate compact; and Y.O.S. terminations.

⁽⁴⁾ Due to the decrease in community transportation services, the Department implemented a procedural change in December 2005 with regards to releasing inmates on weekends. As a result of this change, discretionary releases have increased and mandatory releases have decreased.

⁽⁵⁾ Offenders revoked by the Parole Board reparole on a set date established by the Board, previously reported in discretionary parole.

⁽⁶⁾ The Colorado Supreme Court decision on July 2001 resulted in the discharge of sex offenders who would have released to parole previously.

⁽⁷⁾ Other releases include releases to probation, court order discharge, appeal bond, and deceased.


