

THE COLORADO DEPARTMENT OF CORRECTIONS RECEIVES \$3,172,006 FOR FISCAL YEAR 2008 SCAAP PAYMENT

The Colorado Department of Corrections recently received notification that the department was awarded \$3.2 million for the fiscal year 2008 SCAAP payment. The State Criminal Alien Assistance Program (SCAAP) is a payment program designed to provide federal assistance to states and localities for the costs of incarcerating certain criminal aliens who are being held as a result of state and/or local charges or convictions. The Bureau of Justice Assistance (BJA) distributes payments to many jurisdictions including city and county jails and state prisons. A total of 875 applications were submitted and approved for FY2008 with a total of \$386,215,610 distributed to eligible states and local jurisdictions.

*GENERAL RESEARCH AND STATISTICS *

In order to participate in the SCAAP Program, the Office of Planning and Analysis has established databases and criteria needed to submit all required information to the BJA for payment. The General Statistics and Research Evaluation Unit (GSRE) provides resources to track and extensively monitor offender data with special emphasis on key identity tracking fields. The tracking ensures the highest level of matching with federal and homeland security databases used in the SCAAP data verification process. Aggregate correctional officer salary and employment numbers obtained from the Business Office are also key elements submitted by the Department of Corrections each year. The Colorado Department of Corrections has participated and benefited from the SCAAP since 1995, receiving a total of \$48,721,104 in funds over the past 14 year period though the true cost of incarcerating these offenders is drastically higher than the reimbursements received.

- The number of inmates included in the submission rose 7.3% in 2008.
- Funding received in 2008 was over 4 times the amount received in 1995 (\$773,343).

The 2008 award showed a 4.1% decrease with SCAAP applications increasing from 808 in fiscal year 2007 to 875 for fiscal year 2008.

***STATE DOC PAYMENT COMPARISONS ***

BJA is continually enhancing and updating their review and verification process. Some highlights in the comparison of the state jurisdictional funding, excluding counties and cities, are listed below with a chart breakdown for the top 12 states who received funding.

- A total of 49 state DOC's received SCAAP funding in 2008. Only one state, West Virginia, did not receive reimbursement funds under the program.
- The State of Colorado ranked 11th in fiscal year 2007 and 12th in fiscal year 2008 showing a disproportionately high SCAAP payment when compared to other states of comparable size and geographic location.
- Of the top 12 states, New York (14.7%) and Massachusetts (15.5%) had the largest decreases for fiscal year 2008.

***PERCENTAGE OF DISTRIBUTION ***

The following table shows a yearly breakdown of the SCAAP distribution since fiscal year 2000. The number of jurisdictions has increased steadily since 2004, as well as the total SCAAP distribution. The average percent of the federal distribution for Colorado is 0.84% with the highest percentage occurring in fiscal year 2004.

COMBINED STATE AND LOCAL JURISDICTION COMPARISON

The SCAAP grant includes payments to state prisons, county jails, and city jails. The total of \$6,889,339 was paid out to all the jurisdictions in the State of Colorado for this year's payment. The following bullet points and chart show specific differences when comparing the overall jurisdictions of Colorado compared to other states.

- Colorado ranked 10th overall in total SCAAP payments received by all jurisdictions (state and local combined) although the state is 22nd in state population.
- A total of 28 county and city jails in Colorado received \$3,717,333 in funding. Two new jurisdictions, in the state of Colorado, were added for fiscal year 2008.
