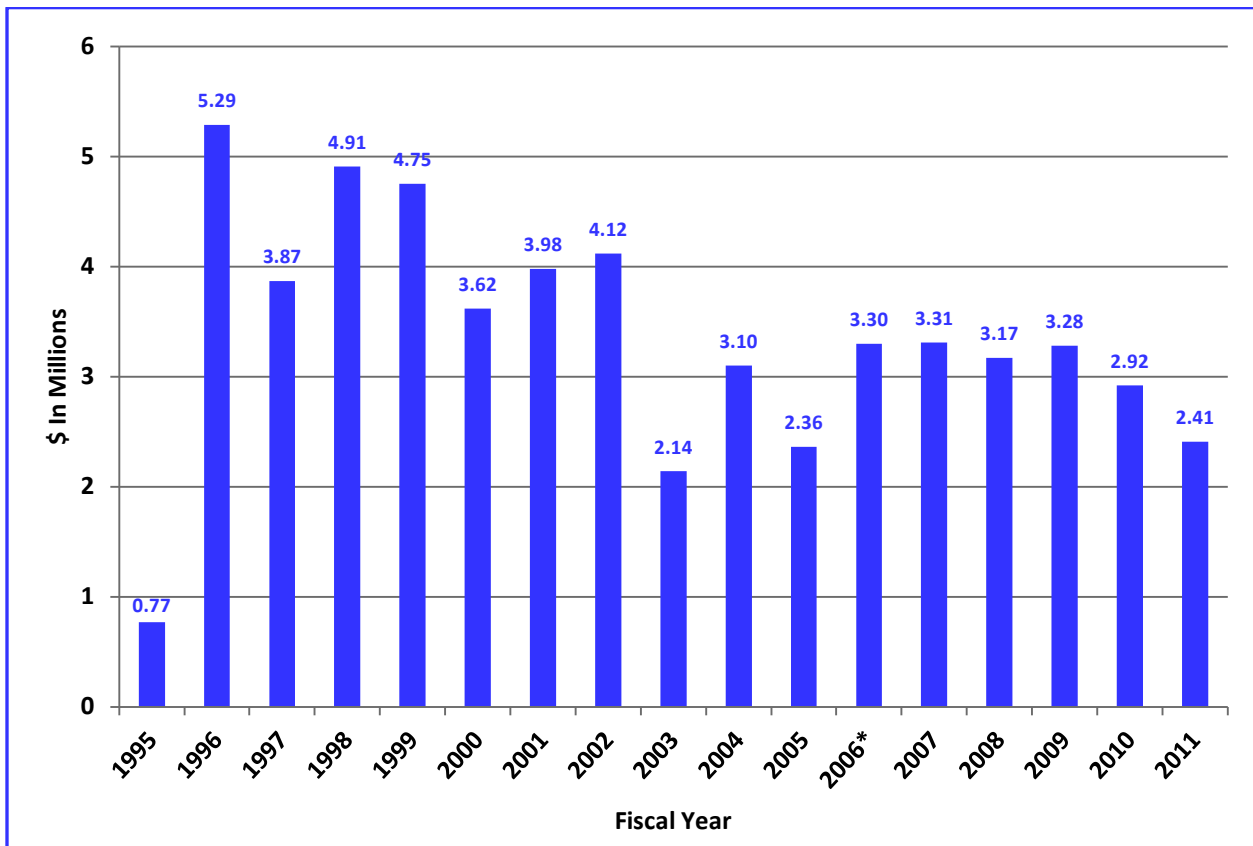
About this Bulletin

The Colorado Department of Corrections receives \$2,410,172 for fiscal year 2011 SCAAP Payment

The Colorado Department of Corrections recently received notification that the Department was awarded \$2.4 million for the FY 2011 SCAAP payment. The State Criminal Alien Assistance Program (SCAAP) is a payment program designed to provide federal assistance to states and localities for the costs of incarcerating certain criminal aliens who are being held as a result of state and/or local charges or convictions. The SCAAP grant is paid out one year after the period of incarceration. The FY 2011 SCAAP grant is for incarceration expenses incurred from July 1, 2009 to June 30, 2010. The Bureau of Justice Assistance (BJA) distributes payments to many jurisdictions including city and county jails and state prisons. A total of 929 applications were submitted and approved for FY2011 with a total of \$272,238,251 distributed to eligible states and local jurisdictions.

General Research and Statistics

In order to participate in the SCAAP Program, the Office of Planning and Analysis has established databases and criteria needed to submit all required information to the BJA for payment. The General Statistics and Reporting Unit provides resources to track and extensively monitor offender data with special emphasis on key identity tracking fields. The tracking ensures the highest level of matching with federal and homeland security databases used in the SCAAP data verification process. Aggregate correctional officer salary and employment numbers obtained from the Business Office are also key elements submitted by the Department of Corrections each year. The Colorado Department of Corrections has participated and benefited from the SCAAP since 1995, receiving a total of \$57,328,586 in funds over the past 17 year period though the true cost of incarcerating these offenders is drastically higher than the reimbursements received.

- The Colorado 2011 award showed a 17.4% decrease in the SCAAP Payment.
- Overall, total jurisdictional applications increased from 865 in fiscal year 2009 to 929 for fiscal year 2011.
- The number of inmates included in the Colorado submission rose 3.7% in 2011.

State DOC Payment Comparison

BJA is continually enhancing and updating their review and verification process. Some highlights in the comparison of the state jurisdictional funding, excluding counties and cities, are listed below with a chart breakdown for the top 12 states who received funding.

- The State of Colorado ranked 11th in fiscal year 2010 compared to 12th in fiscal year 2011.
- Of the top 12 states, Oregon (45.95%) and California (25.27%) had the largest decreases for fiscal year 2010. Most of the states had significant decreases in their payments. New York (3.54%), Illinois (19.16%), and Nevada (91.21%) saw increases in their payments.

Percentage of Distribution

The following table shows a yearly breakdown of the SCAAP distribution since fiscal year 2001. The number of jurisdictions increased to 929 from 865 in fiscal year 2010. The CDOC SCAAP payment has decreased 27% since fiscal year 2009. In the same period the total SCAAP distribution has decreased by 31%. In addition, the number of jurisdictions receiving payments has gradually risen since 2001 and is currently at the highest point of the period. The average percent of the federal distribution for Colorado is 0.86% with the highest percentage occurring in fiscal year 2004.

- The 2011 total distribution was the lowest it's been in over ten years.
- The number of jurisdictions receiving payments increased 7% in fiscal year 2011.
- Since 2001, the total SCAAP distribution has decreased 50% while the number of jurisdictions receiving payments has decreased 80%.
