CCAP Program Overview '


The Colorado Correctional Alternative Program (CCAP), established through legislation passed in 1990, is a regimented inmate training program for nonviolent offenders thirty years of age or younger. This 90-day program includes:

- A military-styled intensive physical training and discipline program
- An educational and vocational assessment and training program emphasizing job seeking skills
- A health education program
- A drug and alcohol education and treatment program structured as an integral part of the entire regimented program

Upon completion of the program offenders are referred to the sentencing court for a possible reduction of sentence pursuant to rule 35b of the Colorado rules of criminal procedure. Offenders successfully completing the regimented inmate training program within 28 months of parole eligibility are immediately eligible for placement in a community corrections program.

A total of 7,875 offenders have been placed in CCAP through March 31, 2008; 7,463 males and 412 females.

CCAP Graduations and Terminations ^

- > 5,172 offenders have graduated from CCAP as of March 31, 2008; 4,964 males and 208 females.
- > 2,570 offenders have been terminated from the program for medical, mental health, physical or attitude problems; 2,377 males and 193 females.
- > 957 offenders completed G.E.D. while in CCAP.




Population Highlights


- The population consists of 105 offenders: 101 males and 4 females.
- ♦ 47.6% of offenders are in CCAP for a Class IV felony.
- Among the current population, El Paso County has sentenced 16 of the 105 offenders, representing the highest number of commitments by county.
- ♦ The mean age is 24.8 years.
- Anglo offenders constitute 51.4% of the current population; the largest ethnic group in CCAP.
- ♦ The most serious crime of drug abuse comprised 26.6%



CCAP Return to Prison / Recidivism

A comparison population of first time incarcerated nonviolent offenders less than 31 years of age not participating in CCAP was selected to represent the CCAP "Eligible" offenders.

- ➤ Total CCAP graduates released to probation or court order discharged constituted 38.9% of the graduates released in 2004, compared to only 6.6% of non-CCAP nonviolent releases and 3.1% of CCAP terminations released.
- > 50.7% of CCAP graduates released in 2004 returned to prison within 3 years compared to 57.3% of other nonviolent offenders and 60.9% of CCAP terminations.
