Practical Parent Policies

NCLB requires all districts receiving Title I dollars to adopt a parent involvement policy that meets the fourteen requirements of the law. These requirements include: a description of how parents' capacity for greater involvement will be supported; a description of how parents will be given opportunity for understanding state standards and testing; and involvement with parents in the development and evaluation of the policy.

The Colorado Association of School Boards (CASB) has developed a sample Parent Involvement policy and a template for districts to use in development of their policy, which can be found at www.cde.state.co.us/cdeunified/pi.htm. Neither of these documents can be adopted without significant personalization by districts, which is very different from how sample policies have been used traditionally.

At Arriba-Flagler School District on the eastern plains, Mark Ricken and his staff have put considerable time into developing a district parent involvement policy that meets NCLB requirements. This summertime work has paid off, and not just in having a solid policy to take to the local school board. Parents involved in the process report that they have a broadened view of parent involvement and fresh ideas for more active engagement. One of these activities involves focused outreach to parents, especially to those who have not traditionally been involved.

Adoption of a quality parent involvement policy can provide just the needed push that expands our perspective on how parents and the community can take constructive roles in supporting greater academic success for all of our students.

Highly Qualified Teachers

There has been much discussion across the nation and in Colorado regarding the definition of a Highly Qualified Teacher (HQT). We believe that it is important to dissolve some of the mystery around what we consider to be a highly qualified teacher as defined by No Child Left Behind (NCLB Sec.1119 (a)).

The definition of highly qualified teachers only applies to teachers teaching in the core academic subjects. The core academic subjects, as identified by NCLB, are: language arts/reading, math, science, arts (art, drama, vocal and instrumental music), civics/government, economics, history, and foreign language.

The following are the definitions of Highly Qualified Teachers in the State of Colorado.

Elementary Educator

A qualified elementary educator shall mean an educator who holds a Colorado Initial or Professional Educator's License. In order to be "highly qualified" the teacher must have:

- An Elementary License, or
- A Secondary License, and passing score on the state's elementary education content area test. The test includes content in language arts/literacy, science, mathematics, social studies, humanities, wellness, and physical education.

Middle School Educator

Note: Colorado does not offer a Middle School License.

A qualified middle school educator shall mean an educator who holds a Colorado Initial or Professional Educator License. In order to be "highly qualified" the teacher must have:

- An Elementary License, if the teacher is teaching in a self-contained classroom (teaching all subject areas), or
- An Elementary License, with (a) 24 semester hours in the subject(s) they are teaching, or (b) passing score on the content area test(s) in the subject(s) they are teaching, or
- A Secondary License, with an endorsement(s) in the subject(s) they are teaching, or

 A Secondary License, with (a) 24 semester hours in the subject(s) they are teaching, or (b) passing score on the content area test(s) in the subject(s) they are teaching.

Secondary Educator


A qualified secondary educator shall mean an educator who holds a Colorado Initial or Professional Educator's License. In order to be "highly qualified" the teacher must have:

- A Secondary License, with an endorsement in the subject(s) they are teaching, or
- A Secondary License, with (a) 24 semester hours in the subject(s) they are teaching, or (b) passing score on the content area test(s) in the subject(s) they are teaching, or
- An Elementary License, with (a) 24 semester hours in the subject(s) they are teaching, or (b) passing score on the content area test(s) in the subject(s) they are teaching.

The 24 semester hours of coursework must be in the content area(s) in which the educator is teaching and may be earned through a combination of professional development activities, college credit and relevant travel (maximum of 6 hours in travel). Certification of this requirement is the responsibility of the educator's employing school district.

Application for Funding Opportunity related to the Educational Success of Homeless Children and Youth

At the invitation of the Daniels Fund, CDE is submitting a grant application for a statewide educational initiative to support students who have been identified as homeless. After surveying local funded McKinney programs, a pilot project has been developed related to student assessments, instructional interventions, and supportive on-going communications and relationships with both students and classroom teachers. The goal of the program is to provide Academic Advocate Interns to school districts. They, in turn, provide needed services so that homeless students can perform at grade level.

Partners with CDE in the grant are the Teacher Education Programs in the School for Professional Studies at Regis University, the Center for Research Strategies and 6-15 local school districts (still to be determined). The grant application requires local matching funds. For this Academic Advocate Pilot Project each participating school district will need to commit \$3,200 towards the stipend for the Academic Advocate Intern. Each advocate would work a total of twenty hours a week for 32 weeks. They will be supervised by Regis University and work closely with the district homeless liaison. Title I staff, and the district assessment staff, as well as teachers, to coordinate academic services for homeless students.

Students pursuing their master's degree at Regis University in the School for Professional Studies will be recruited for the paid internships as Academic Advocates to work in school districts. School districts receiving McKinney Vento support have priority, but the advocate positions are open to all school districts in the state. The interns will support the academic success of students who have been identified as homeless through: academic case management; assessing current academic skill level; developing a remedial intervention plan, and accessing the resources to implement and manage the plan. The intern, under the guidance of the school district's assessment personnel and homeless liaison will assess homeless students' current academic skill level against district grade level standards and track the success of any remedial

services implemented to assist the student in moving towards proficiency in selected core subjects. In all cases the development of a supportive, individual relationship through meetings between the Academic Advocate and the students is critical. In some situations, the advocate may be providing some of the remedial services. In other situations the intern will access other more appropriate services, yet be in regular contact with students, their parents, and teachers so the on-going remedial support builds upon the skill development of the day-to-day classroom instruction and is supported by parental involvement.

The Center for Research Strategies will work closely with academic advocate interns, and both their university and school district sponsors to capture the success of the program. Interns will complete action research projects at each site. In addition student records for homeless students, including academic success, test results and attendance will be tracked and correlated with qualitative data recorded through home visits and case management notes. Formative evaluation research will be used to make program improvements. A final report will outline the project and what factors contributed to success at each site.

Notification of grant awards is scheduled for December 2003. If funded, the Academic Advocate Pilot Project will start during the second school semester.


After completing an initial AYP evaluation, we have several schools that will move into 2nd year school improvement and will have to offer supplemental services. Where is CDE in having an approved list of supplemental service providers?

We are in the process of finalizing the list of state approved providers. We will be adding approximately 20 providers to our present list of 13. The list is available on our website at www.cde.state.co.us/index_funding.htm. We anticipate having a final, published list by the beginning of September. We will also have a sample parent notification letter translated into Spanish available on our website by the end of September.

As noted in the timeline for AYP, districts who determine that a school in 1st year school improvement did not make AYP will be required to provide supplemental services will not need to do so until January 2004. Please note, if a school is in its 1st year of improvement and

made AYP for the 2002-2003 school year, they will not need to offer supplemental services.

CDE will be hosting a networking day for providers and district personnel to provide information about





CDE will be calculating the District AYP determinations and reporting them to Superintendents by September 30th. Districts will then have until October 14th to appeal the determination. Final determinations will be made by November 14th. However, districts are responsible for making individual school AYP determinations for all district schools by October 31st and reporting final determinations to CDE by December 31st. UPDATES

The Colorado Department of Education has recently launched a new **Adequate Yearly Progress (AYP)** website. At

www.cde.state.co.us/ayp, you will find the most current information regarding calculating AYP. We have created an Excel Spreadsheet to do the calculations for you, when the appropriate data is entered. CDE will make District AYP determinations by September 30th. Districts must make school AYP determinations by **October** 31st. Schools currently on improvement that do not make AYP will need to begin providing supplemental services in January 2004.
