Supplemental Educational Services Request for Proposals Now Available

The Request for Proposals (RFP) for the 2004-2005 List of Approved Supplemental Service Providers is now available online. There will be a training on the completion of the RFP January 23rd from 2-4 p.m. at the Colorado Association of School Boards (CASB), 1200 Grant Street in Denver.

Schools on 2nd year improvement, corrective action or restructuring are required to offer supplemental services. Supplemental services are free tutoring opportunities for low-income children attending schools on 2nd year improvement, corrective action or restructuring. The cost of services is paid for by the district with the required Title I set aside for supplemental services.

Presently, we have a list of 34 state approved providers. A tutoring provider is any organization with a demonstrated record of effectiveness in increasing the academic achievement of students in reading and/or math and successfully completes the RFP. This is not a competitive grant in that all providers that meet the criteria specified in the rubric will be approved.

Although our list contains many competent providers we are hoping to add more options for the rural areas of Colorado. If you know of an organization that you believe would be a strong provider of supplemental services please encourage them to apply. Or, you may want to consider applying on behalf of your district-run program if there is a possibility that your schools will have to offer supplemental services next year.

School Support Teams

According to NCLB, each state must establish a system of support for schools on improvement and corrective action. Part of Colorado's school support system involves the use of school support teams who provide a diagnostic review of all facets of a school's program. CDE will continue to pilot the implementation of school support teams in the spring in preparation for a more comprehensive implementation in fall of 2004.

School Support Resource Website

The Professional Development and School Support website is being developed as a way to continually communicate information, activities, and events to those involved in the continuous school improvement processes. The website will include information about:

- Professional development opportunities
- Colorado's school support process
- · Online articles to support school improvement
- Links to other sites that have resources to support improvement
- Parent involvement resources
- Innovative approaches to raising school achievement

Math Workshops

CDE has two initiatives to assist teachers in raising student achievement in mathematics. One is a short term initiative to train teachers in standards based content for K-5 mathematics. The other is a long term initiative to develop trainers who can offer K-5 mathematics training in districts and regions across the state. An additional focus for the coming year will be leadership institutes to assist principals in developing skills to work with teachers on appropriate instructional practices for the implementation of standards based mathematics.

Schoolwide Training

With the creation of new schoolwide programs and the additional requirements laid out in NCLB, we will be developing a simplified template for the development or revision of schoolwide plans. The handbook for guiding schoolwides will also be revised. A series of workshops will be held in late spring to assist those interested in schoolwide planning.

Charter School Grant Program

The Colorado Charter School Grant Program provides startup and implementation funds for new charter schools. Eligible charter schools may include conversions or grassroots startup schools. Up to \$450,000 is available over a three year period; the grants are competitive. There are two tiers for the startup grant competition. Tier One is in October and is for schools that have already received their charter or have submitted a charter application to a school district. Tier Two is for the schools that have just been approved by their school district and will be opening the following autumn.

There will be mandatory grant training for Tier 2 Charter School Startup Grant applicants on Wednesday, January 14, 2004. Only those charter schools that have just recently been approved, or have submitted a charter application to a local school district and are still waiting approval, may apply for Tier 2 Charter School Startup Grant funds. Tier 2 grant applications are due Feb. 23, 2004.

The grant writers training will be 8:30 a.m. to 4 p.m. Wednesday, January 14th at the Talking Book Library. Registration (required) and directions are on the CDE website at:

reg.pdf. The deadline for registering is Jan. 9, 2004. The training is free for writers associated with a charter school that will be applying in Tier 2. Others are welcome to attend the training on a space available basis, but must pay \$15 in order to cover refreshments and lunch. For charter schools that had a representative at the August 8, 2003 grant training, attending the Jan 14th training is strongly suggested, but optional. If you do not wish to attend the Jan. 14th training, please email Denise Mund the rationale for that decision.

Every startup grant application in Tier 2 will be assigned a consultant. Consultants are available to read drafts of the application and provide detailed feedback. The consultants will be at the Jan. 14th training and will be providing assistance to writers as they begin their drafts. Using a grant consultant does not in any way imply guaranteed funding.

During the morning portion of the grant writers training, CDE staff and consultants will be providing information on the grant program, financial issues, library plan development, professional development plans and technology plan development. After lunch the grant consultants will be working with writers to begin their grant applications. Grant writers attending the training are encouraged to bring laptops and primary documents for reference such as the charter school application.

Consolidated Federal Programs Handbook

We are in the process of creating a handbook that would provide basic information on the administration of the Title I, II and V grants. The handbook would, among other things, include sample parent involvement policies, school choice and supplemental service letters.

Website Organization

We have heard comments from numerous sources that it is difficult to locate information on the CDE website. In an effort to make information more accessible we plan to reorganize the State and Federal Grants page. This will be an ongoing process that will begin immediately.

Policy Development Goals

Adequate Yearly Progress

Early in 2004, CDE will reconvene the AYP Subcommittee to refine the AYP definition and associated policies and procedures.

District Improvement Plans/Restructuring

Some districts may enter into improvement status in the fall of 2004. We have begun formulating the actions that must be taken by districts on improvement and districts with schools entering the restructuring phase of school improvement. This information will be provided to districts in the spring.

Monitoring

This spring CDE will be launching a pilot of the Consolidated Federal Programs On-Site Monitoring. The on-site visit will be conducted by representatives of each Title program. The goal is to ensure that federal funds are being used appropriately. A copy of the on-site tool will be available for districts.

Neglected or Delinquent

An action plan will be developed to ensure that all eligible students and facilities within each district are being served. A web-page will also be developed to provide districts and facilities with accurate and relevant information regarding this program and guidance concerning emerging issues.

We realize that needs develop over the year and we plan to adjust our goals as appropriate. We appreciate your patience and look forward to working with each of you this year to successfully meet the academic needs of Colorado's students.

RELEASE OF THE PARENT INVOLVEMENT TOOLKIT

Over the last few months, most Colorado districts adopted a district Title I parent involvement policy, in compliance with the requirements of NCLB. In a 'just-in-time' response, CDE is sponsoring a series of regional workshops with the Colorado Parent Information and Resource Center to support the implementation of this policy and help build districts' capacity for meaningful parent involvement. These workshops also provide the opportunity to roll out the Parent Involvement Toolkit, a year-long project that was the joint work of many organizations.

The Parent Involvement Toolkit is a one-stop product that provides a variety of information, tools, and guidance. The Toolkit has a review of the research, web-based resources, contact organizations, and a wealth of other helpful items. The Toolkit is available on CDE's website under What's New on the State and Federal Grants page. A hard copy will be provided to workshop participants.

Toolkit Workshops have been scheduled across the state. This series is targeted to district administrators, parent liaisons, DAAC members, board members, and principals. The focus will be on how the Toolkit can assist with the implementation of the district Title I policy, but also cover issues related to school-level work. Can a teacher who has a secondary license become highly qualified to teach at the elementary level by taking 24 semester hours?

No. A teacher with a secondary license must take the elementary PLACE/Praxis test or take coursework to obtain an elementary teaching degree to be considered highly qualified at the elementary level.

Is an LEA required to have a policy to ensure comparability?

Yes. A district must have a policy in place to ensure equivalence among 1) schools for teachers, administrators and other staff and 2) schools in the provision of curriculum and instructional materials. Please note the policy does not need to be board approved.

What needs to be submitted to CDE in regards to comparability?

All districts should have submitted the signed assurance document to CDE by December 31, 2003. This includes districts that only have one building per grade span. The assurance document is an acknowledgement that the district is complying with the comparability requirement. All other documents related to comparability should be retained at the district. This information will be requested during an onsite monitoring visit.

CDE has now received all school AYP determinations from districts. January will be spent compiling the determinations and analyzing where the strengths and weaknesses are for the schools in the state.

Initial district analysis is showing that, after the appeals process, 59% of districts made AYP. 74% made 90% or more of their AYP targets and 16% made between 80% and 90% of their AYP targets. More district level analysis will be completed in January.

More information and a complete list of district determinations will be available on the State and Federal Grants page in the "Colorado No Child Left Behind State Report Card" in mid-January.

The Colorado Department of Education is announcing the release of a publication that will provide clarity and hopefully alleviate the anxiety around the implementation of the "Highly Qualified" teacher provision of No Child Left Behind.

The publication is organized into three major components. First is general information about the "Highly Qualified" teacher requirements and the reporting requirements for schools and districts. The second section of the document contains definitions that describe the terms mentioned in the "Highly Qualified" teacher provision. The last section addresses frequently asked questions. As helpful as we hope the publication will be we do anticipate it to change and enhance as we learn more about this provision. CDE is presently accepting nominations for the Title I Distinguished Student Award. Two Title I students for whom the program has made a significant impact will be awarded a \$1,000 gift to the school where Title I services were received. All current or former students who have participated in the Title I program are eligible. The nominee must be nominated by a teacher, school official, community leader minister or employer. The Mathematics and Science Partnership program is intended to increase the academic achievement of students in mathematics and science by enhancing the content knowledge and teaching skills of classroom teachers. Partnerships between high-need school districts and the science, technology, engineering, and mathematics (STEM) faculty in institutions of higher education are at the core of these improvement efforts.

The MSP program is a formula grant program to the states, with the size of individual state awards based on student population and poverty rates.

Thanks to all who submitted a Mathematics and Science Partnership proposals. We commend you on your proposed efforts for improving the educational opportunities for middle school children and mathematics and science teachers.
