No Child Left Behind Report Card Annual Reporting Requirements

After conducting a desk review of all districts' Annual Reports to the Public, during the 2005-2006 school year, it became apparent that districts needed additional guidance and support in the development of their Annual Report. Along with the combined accreditation and NCLB reporting requirements that are posted on our web site, a template report has been created that contains all the minimum requirements for NCLB and accreditation. Clearly, the report can contain much more than the minimum requirements; however, if districts fill in the tables with their data, they will be in compliance. A majority of the data required for the Annual Reports are available on the CDE website. The AYP and Highly Qualified teacher data are included in the NCLB school and district profiles. The 2005-2006 profiles should be posted by November 6th at

Sunnyside and Shanner Elementary Schools Win Top Title I Award

CDE is honored to recognize the two National Title I Distinguished Schools for the 2005-2006 school year. Each school will receive a \$10,000 award.

Sunnyside Elementary School in Durango has been awarded the National Title I Distinguished School status for highest achieving school. The school has already reached the 2013-2014 AYP goal of 100% proficiency in reading and math. Additionally, 87.27% of all students were proficient or advanced in reading and 78.18% were proficient or advanced in math. The school has a 39.66% poverty rate.

Shanner Elementary School in Holly, with a poverty rate of 71.62%, has been identified as the top school in closing the achievement gap between students eligible for free or reduced lunch and those that are not eligible. The table below shows the achievement and improvement of all of Shanner Elementary students.

CHANGES TO PROGRAM IMPROVEMENT IDENTIFICATION

The U.S. Department of Education granted CDE permission to change how districts are placed on, or move forward in the improvement cycle. In the past, districts were placed on improvement if any AYP target in a content area was missed for two consecutive years. However, now a district is only placed on improvement if it misses AYP in the same content area and same level (elementary, middle or high) for two consecutive years (for example, middle school math in 2005 and 2006). To move forward on improvement, the district must miss the same content area and level for a subsequent year. In calculating the improvement status for 2006, the Consolidated Federal Programs unit returned to 2003 data and recalculated district AYP using the new criteria. As a result, some districts are not as far along in the improvement cycle. The chart below identifies the number of districts at the different levels of improvement.

HIGHLY QUALIFIED TEACHER PLANS

Many of you are in the process of, or already have, submitted plans for teachers in your district that are not yet Highly Qualified. **All plans are due into the online system by November 30th.** Districts that need a username and password need to complete a respondent form (e-mail Tina Tamayo at tamayo_t@cde.state.co.us for a copy) and fax it to Tina at (303) 866-6637. CDE will then contact the identified HQT contact with the online system password. Districts will not be able to access the online system without this username and password.

Sometimes the plans consist of explaining the steps the district will be taking to assist the teacher in becoming Highly Qualified, Other times, the plans are simply providing additional information (e.g., the teacher took an approved elementary content test in another state). Please note, if additional information is provided about a teacher's credentials, this same information will also need to be reflected in CDE's Human Resources data collection and documentation kept at the district. The only information CDE will be updating is if an elementary teacher qualifies for HOUSSE. Otherwise, your district is responsible for communicating the information in the HR collection. If the most current information is not reflected in the HR data collected this winter, the district will receive notice from CDE next year that the teacher is not highly qualified.

Final Message from Bush White Title IIA, Senior Consultant
