Supplemental Educational Services Request for Proposals Available January 10, 2007

The Request for Proposals (RFP) for State Approved Supplemental Educational Service Providers for the 2007-2009 school year will be available at

www.cde.state.co.us/FedPrograms/improvement /SuppServices.asp. The proposals are due to the Colorado Department of Education (CDE) on or before March 12, 2007. There will be a training for the completion of the RFP at CDE in the State Board Room on January 18th from 2-4 p.m.

Supplemental Services are free tutoring opportunities for low-income children attending schools on their second year of school improvement, corrective action or restructuring. The cost of tutoring is paid for by the school district using Title I funds. A list of schools in Colorado that are presently offering Supplemental Services as well as schools that may have to offer services next year is also available at the above link.

This is not a competitive grant in that as many providers can be included on the list of approved providers as meet the criteria of the RFP. Furthermore, approval means being placed on a list of approved providers which districts will send to eligible parents. There is no guarantee that if selected to be on the list the organization will serve students. Eligible parents are provided the list at the start of school and choose the provider that best suits their child's needs.

Currently, there are 44 state approved providers. Eligible applicants are organizations with a demonstrated record of effectiveness in increasing the academic achievement of students in reading and/or math. Districts and schools on improvement may not be Supplemental Service providers. However, a school that is making adequate yearly progress within a district identified for improvement may apply to be a provider.

2007 Math and Science Partnership Request for Proposals Now Available

CDE is now accepting proposals for the 2006-2007 Mathematics and Science Partnership Awards. The Request for Proposals is available at. Applications are due on or before February 19, 2007.

Math and Science Partnership is intended to increase the academic achievement of students in mathematics and/or science by enhancing the content knowledge and teaching skills of classroom teachers. Partnerships must include faculty from the science, technology, engineering, and/or mathematics (STEM) faculty in institutions of higher education and at least one "high need" local school district. Other partners may include public charter schools or other public schools, businesses, and nonprofit or for-profit organizations concerned with mathematics and science education. School districts and university faculty are jointly responsible for improving mathematics and science instruction.


December's Question:

The annual Amgen Award for Science Teaching Excellence (AASTE) program is looking for extraordinary science teachers from across the United States and Puerto Rico.

This year, 30 science teachers will be awarded an unrestricted cash grant of \$5,000, and their schools will receive a restricted grant of \$5,000 to be used to expand or enhance the school's science program, purchase new science resources, or further the professional development of their science teachers. To be eligible, nominees must:

- Be full-time, K-12 classroom teachers whose major responsibilities include teaching science
- Have at least three years of experience teaching science in grades K-12
- Work in communities where Amgen has key operating sites: California, Colorado, Kentucky, Massachusetts, Rhode Island, Washington, or Puerto Rico

Clarification on the "4-Week Rule" Letter

Title I schools must provide all parents timely notice when their child has been assigned, or has been taught for 4 or more consecutive weeks by, a teacher who is not highly qualified [Section 1111(h)(6)]. This "4-Week Rule" information must be in the form of a letter that is sent to the parents of each student in the affected classroom. As part of the C-FIRS desk review, a sample of the letter schools will use to inform parents must be submitted to Trish Boland by January 31, 2007. A copy of this letter may be submitted electronically boland_t@cde.state.co.us, by fax (303) 866-6637 or sent to 1560 Broadway, Suite 1450, Denver, 80202.

In addition, the district will need to submit a list of teachers for which this letter was sent. At this time, CDE does not need to review each letter sent. However, if the state conducts an on-site review of the district, individual letters will be requested.

Online System for Highly Qualified Teacher Plans

Thank you to all districts that submitted their Highly Qualified Teacher plans. Please note that CDE staff has reviewed all plans at this point. Each Title I and Title II contact should have received an email updating them on whether their district is finished with the process. To date,

- 71 districts have 100% of their teachers highly qualified or have all of their plans approved
- 112 districts have submitted plans that have been reviewed however all plans have yet to be approved
- 7 districts have yet to submit plans

In Colorado's most recently approved state plan, CDE stated that 2007-2008 Title II funds will not be released until every teacher is HQ or has an approved plan to become HQ. "Through ebony eyes: What teachers need to know but are afraid to ask about African American students" G. Thompson. Reviewed by

Julie Landsman, Ph.D., Dec. 2004, Vol. 2, Issue 1. "...a high percentage of teachers are under prepared to work effectively with students of color. Hence, there is often a cultural mismatch between teachers and African American students that has many negative consequences." The author has divided her book into two major parts: the first deals with basics in educational reform such as tracking, theories to explain the achievement gap, common myths about African American Students, effective instructional practices, and effective classroom management. The second half of the book addresses other controversial questions and topics such as Standard English versus Ebonics, reaching students from challenging backgrounds, the N word, accusations of racism, culturally relevant education, and other issues that come up for teachers who are often too hesitant to talk about them. She concludes with a chapter that responds to the questions, "Can beliefs be changed?" For the full review visit

CONSOLIDATED PERFORMANCE REPORT

Due to the reporting requirements from the U.S. Department of Education in Part II of the Consolidated Performance Report, CDE needs to collect additional data from all school districts receiving Title I and Title V funds. The Title I data is the same information that was requested for the last two years. However, the Title V data request has been updated. The district's Consolidated Performance Report is collected online and consists of a few brief questions about the students who participated in Title I, Part A, Title I, Part D and Title V programs and the services they received during the 2005-2006 school year.

Please note it is essential that all data be submitted and finalized by Friday, January 26, 2007. Districts will receive reminders of the due date on a regular basis.

To avoid some of the confusion from past years, the Consolidated Performance Report has been updated to allow the district to register a unique contact person for each LEA.

In the case of BOCES completing the Performance Report for their districts, BOCES representatives can register as the contact for numerous districts. However, BOCES representatives will receive multiple emails with passwords, one for each district to be represented. BOCES representatives must log in separately for each district and enter only that district's information. If the BOCES does not submit data for its districts, please forward any information received to the appropriate district representative so that they may respond.
