#### AYP TO MEASURE LONGITUDINAL PROGRESS

In February, the Consolidated Federal Programs (CFP) submitted an amendment to the USDE to create an additional safe harbor measure. Last week, CFP was given approval to use a longitudinal safe harbor measure in the 2006-2007 AYP determinations.

The longitudinal safe harbor target will be an additional option for districts/schools/ disaggregated groups that do not make performance or regular safe harbor targets, in order to make AYP overall. The target is still a 10% reduction in the percent non-proficient (same as regular safe harbor). But instead of comparing 2006 students in the school to 2007 students in the school, the comparison will be of students in the school for both years. For example, in a K-5 elementary school, the 3<sup>rd</sup> and 4<sup>th</sup> graders in 2006 will be compared to those exact student's scores in 4<sup>th</sup> and 5<sup>th</sup> grade in 2007. Thus, the measure will be more reflective of the school's actual impact on individual students, as opposed to being influenced by specific cohorts.

This is an exciting new option as it adds more validity and robustness to AYP determinations. However, when last year's AYP data was run with this option, only 7 additional schools would have made AYP. So, a tremendous impact on AYP determinations is not expected. But for those schools it does impact, it will recognize the significant work done with struggling students.

Training dates to discuss the new calculations will be announced later this summer. The AYP Calculator and all supporting materials will be revised to include this new option. ## OPPORTUNITY FOR EDUCATORS TEACHING 4<sup>TH</sup> AND 5<sup>TH</sup> GRADES

The Mid-continent Research for Education and Learning (McCREL) is seeking Colorado schools and teachers to participate in a U.S. Department of Education funded study of *Classroom Assessment for Student Learning (CASL)*. The purpose of the study is to evaluate the effectiveness of the CASL professional development program for enhancing teacher assessment literacy, improving classroom assessment practices, and raising student achievement.

This program is designed to help teachers:

- Use a variety of strategies to not only measure, but also promote, student learning;
- Accurately assess what students know and don't know;
- Set learning targets and make them clear to students; and
- Involve students in classroom assessment, record-keeping and communication.

The study encompasses two school years (2007-2008 and 2008-2009). In order to participate in the study, teachers must sign up as a team. The teams must meet these criteria:

- All team members must teach students in grades 4 or 5;
- Each team must contain 3-6 members; and
- All team members must teach at the same school.

Participants in the study will receive the following benefits:

- All participating teachers will be entered in a drawing for a chance to win an expense-paid trip to the Assessment Training Institute 2009 summer conference on classroom assessment.
- Teachers will receive a monetary incentive for their participation.
- All teachers training with CASL are eligible to receive up to four hours of graduate-level credit from the University of Colorado at Denver for a \$50 per credit hour fee.
- Schools will receive the CASL materials free of charge or the equivalent retail value of the CASL materials.

#### RURAL SECONDARY LITERACY PROJECT

The Colorado Department of Education, through a collaboration of units within CDE, are implementing a Rural Secondary Literacy Project. The project was established to assist rural districts in developing a comprehensive multi-tiered system of literacy supports in middle and high schools that results in increased student achievement. The goal is to develop model examples of successful rural secondary literacy school and/or district sites through the implementation of a technical assistance model with data collection to determine effectiveness. Sites were selected using specific criteria including demonstration of being a rural school district serving less than 2,000 students in grades 6 through 12 or a consortium in which each district or school serves less than 2,000 students in grades 6 through 12 and an established literacy need at the secondary level, including students with disabilities. Twelve sites representing 7 regions in Colorado were selected:

- Wiggins RE-50(J) and Prairie RE11 Consortium
- Eaton RE-2
- Woodlin R-104
- South Conejos RE-1
- Alamosa RE-11J
- Sierra Grande R-30
- Park County Re-2
- Spanish Peaks-Fishers Peak Consortium (Aguilar RE- 6, Primero RE-2, La Veta RE-2, Hoehne RE-3, Trinidad 1)
- Fremont RE-2
- Pikes Peak Consortium (Big Sandy 100J, Calhan RJ-1, Cripple Creek Victor RE-1, Edison 54JT, Elbert 200, Ellicott 22, Hanover 28, Miami Yoder 60JT, Peyton 23JT)
- Lamar School District RE-2
- De Beque 49 JT

These sites will receive assistance to develop and implement key critical components of a secondary literacy model including 1) the development of instructional leadership teams, 2) professional development on literacy for general and special education staff, 3) implementation of scientific research-based interventions, and 4) systematic progress monitoring of student literacy achievement over the next three years.

## Access to Online Databases in Schools Can Increase CSAP Scores

Did you know? Students with the most school-wide access to licensed databases achieve 18-25% higher CSAP reading scores than students with the least access to such databases. Scores may be even higher if the school librarian collaborates with teachers and technology specialists on using these library-based resources with students.

Schools can help students and save money by taking advantage of the reduced statewide price agreements negotiated by the Colorado State Library's AIRS Committee. The cost ranges from \$218 to \$567 per year, per building, based on grade level and population served. Without this statewide cost-saving agreement, schools would pay as much as \$3,000 per year. Subscribing to the print versions of these online resources would cost a library more than \$58,000 per year! And even better, the Colorado State Library is making a special offer to schools that were not subscribers this year. They can subscribe to these databases next year at ½ the list price!

This eight-database package includes resources for students, teachers, and parents, including:

- Over 500 full-text magazines for students
- More than 84,700 biographies, 100,000 primary source documents, and 235,000 photos and maps
- Selected articles from 25 national and 260 regional newspapers
- More than 139,800 articles on current events topics
- Consumer health reference books and articles from health magazines
- A professional collection of articles and reports for teachers and educators
- A direct link on every screen to the <u>AskColorado</u> online help service, for 24/7 live assistance from librarians on using the databases

### 2006-07 Highly Qualified Teacher Data Collection Update

Everyday, Colorado inches closer to the 2006-2007 target of 100% highly qualified (HQ) teachers. The online collection of HQ Teacher plans is just about wrapped up. The HQ data will then be finalized during the 2006-2007 HR Collection which reopens during the summer. If districts submit all data as negotiated with the Consolidated Federal Programs (CFP) unit, then our state will reflect 98% of core content teachers as HQ.

CDE has reviewed each HQ teacher plan and assigned an approval code. The following explains the codes and necessary district action:

#### 2 -- Approved HOUSSE rubric

Pertains to elementary, rural and special education HOUSSE provisions and means that CDE has approved the teacher for HOUSSE. This data will be submitted to ADE for the HR Collection. Districts must reaccept this data in the HR Collection to take advantage of the changes.

#### 3 -- Approved Data Change and District Must Resubmit New Data to the HR Collection

The district submitted a change in the teacher's records (e.g., reassignment, elementary, took an approved test in another state) and CDE has approved this change. The district must change this data in their HR submission by

## Do all paraprofessionals have to meet the definition of highly qualified?

All paraprofessionals in a **Title I schoolwide program**, without regard to whether the position is funded with Federal, State, or local funds must meet the definition of highly qualified. In a **Title I targeted assistance program**, only paraprofessionals funded with Title I, Part A funds must be highly qualified.

### The following are Consolidated Application Updates and Reminders:

- Section 15 has a new functionality on the bottom of the page which enables applicants to download a Microsoft Excel version of Core Content Teachers to copy and paste into the Electronic Budget.
- All core content teachers funded with NCLB funds must be considered Highly Qualified.
   Therefore, applications that contain TBD (to be determined) either in Section 15 or in the Electronic Budget will not be eligible for Final Approval. Additionally, the application will not be eligible for Final Approval if Section 15 and the Electronic Budget do not match for Core Content Teachers.
- Double-check that programs are reflected accurately in Section 1 (i.e., "Accept", "Decline," or "Signover"). Call the Helpline (303) 866-4814 or Tina Tamayo (303) 866-6705, if there are any errors.
- District and Private schools listed in the drop-down boxes of Title I Data Table 6 (Add New) are now sorted by name.
- When logging in, use the mouse to click on the "Submit Button". The enter key does not always work for logging in.
- LEA's can now access last year's application in a printable format. The 2006-2007 printable application can be accessed at www.cde.state.co.us/fedprograms/consapp. Click on "Online Consolidated Federal Programs Application - 0607 Application Review" link. LEA's can use either the 06-07 or 07-08 entry code.

resetting the 2006-07 submission and resubmitting the district with the approved change(s).

4 -- Approved Teacher Plan, but Not yet Considered Highly Qualified

The district has submitted a plan for the teacher to become HQ. CDE has approved this plan. The district must continue to work with the teacher to ensure that the plan is followed.

#### 5 -- CDE Data Change

CDE's data has changed to make the teacher HQ (e.g., license was approved, teacher passed the PLACE test). This data will be submitted to ADE for the HR Collection by CDE Districts must reaccept this data in the HR Collection to take advantage of the changes.

8 -- Record No Longer Relevant
Teachers have left the district or have been
reassigned to a non-core area. The district must
change this data in their HR submission by

9 -- Teacher Plan Not Accepted by CDE
The plan needs additional information before CDE
can accept it. The district should resubmit a plan to
the online HQ Teacher Plan system.
