SPACES AVAILABLE FOR SCHOOL SUPPORT TEAM VISIT

Consolidated Federal Programs has completed a total of 74 School Support Team (SST) reviews since its conception in 2003.

The Title I School Improvement Grant will again be offered for the 2007-2008 school year. All schools on Improvement are eligible for the grant; however, due to limited funding, awards will be made on a first come, first served basis.

Funding for the grant is disseminated in two parts. A Year One grant is awarded in the amount of \$50,000 to fund a SST review of the school program. The remaining funds (approximately \$30,000) will be awarded to the school to support a debriefing of the report with school staff, planning and initial implementation of short-term recommendations.

Schools will then receive a Year Two grant ranging from \$50,000 to \$100,000 in June 2008 to address the major areas of need as identified by the external review.

Title I Schools Show Gains Based on 2006-2007 Adequate Yearly Progress

Twelve Title I schools showed significant academic improvement and were removed from the Title I School Improvement list, based on 2006 and 2007 Adequate Yearly Progress (AYP) determinations.

- Fulton Elementary and Sixth Avenue Elementary, Aurora (Adams-Arapahoe School District 28)
- Schmitt Elementary, Denver Public Schools
- Wilson Elementary, Colorado Springs Dist. 11
- Gunnison Elementary, Gunnison School Dist.
- Aguilar Elementary, Aguilar School District
- Pomona Elementary, Montrose School District
- Youth and Family Academy Charter, Middle School, Pueblo School District 60
- Haskin Elementary, Center School District
- Billie Martinez Elementary, Greeley-Evans School District 6
- Colorado School for the Deaf and the Blind, elementary and high schools

Five of those schools—Gunnison, Aguilar, Pomona, Haskin and Billie Martinez elementary schools—received a Title I School Improvement Grant, which includes a School Support Team visit and \$150,000 over two years. The School Support Team visit is a part of the state's system of school support and provides an in-depth analysis of the school based on nine "best practice" standards.

"We have seen a tremendous amount of focus, hard work and collaboration from teachers, principals and staff to turn around these schools on our improvement list," said Patrick Chapman, Director of Consolidated Federal Programs. "We can see the direct correlation between improved processes and improved results. We celebrate their accomplishments with enthusiasm."

Each year the Colorado Department of Education recognizes teachers from Title I schools who demonstrate outstanding commitment and excellence in teaching. In addition to recognition as distinguished teachers, each of the two award recipients will receive \$5,000 in honor of their achievement. Nominations are due to CDE by Monday, November 5th. Title I, which is part of *No Child Left Behind (NCLB)*, supports school and district programs to improve the learning of children. The U.S. Department of Education provides Title I funds to states to give to school districts based on the number of children from low-income families in each district.

Title I provides approximately 150,000 students in 608 schools with \$121 million in additional funding to assist Colorado's struggling students. To determine if a school receives Title I funding, visit the NCLB Federal Programs page on the CDE Web site at

Colorado standards for identifying Title I Distinguished Teachers incorporate what research reveals about excellent teachers. This research recognizes the importance of documenting a high level of academic growth for all students, as well as leadership in the school and community. Therefore the award criteria focus on evidence of the individual teacher's ability to work:

- With students, such as eliciting a high level of academic growth, and determining students' needs and differentiating instruction based on those needs.
- Within her/his subject area, such as staying abreast of new information and research within their subject area.
- With parents and community, such as effectively communicating with parents and contributing to the school community beyond the classroom.

Comparability Update

In an effort to improve the state's Title I comparability determinations, Consolidated Federal Programs is developing a new system which will ensure the accuracy and ease of determining comparability. Comparability is only a requirement for districts with more than 1,000 students or one school per grade span.

This new process will be completed online for the 07-08 school year but in future years comparability will be included in the ADE Human Resource collection. Additional information and trainings will provided as soon as possible. In the meantime, be sure to identify teachers funded with Title I with the grant/project funding source code of 4010 in the upcoming 2007-2008 ADE HR collection.

E-rate

E-Rate is administered by the Universal Service Administrative Company (USAC) under the direction of the Federal Communications Commission (FCC), and provides discounts to assist most schools and libraries in the United States in obtaining affordable telecommunications and Internet access.

The Schools and Libraries Program supports connectivity - the conduit or pipeline for communications using telecommunications services and/or the Internet. Funding is requested under four categories of service: telecommunications services, Internet access, internal connections, and basic maintenance of internal connections. Discounts for support depend on the level of poverty and the urban/rural status of the population served and range from 20% to 90% of the costs of eligible services. Eligible schools, school districts and libraries may apply individually or as part of a consortium.

Applicants must provide additional resources including end-user equipment (e.g., computers, telephones, etc.), software, professional development, and the other elements that are necessary to utilize the connectivity funded by the Schools and Libraries Program.

Training for the 11th Year of E-rate will begin at the end of October. Locations, times, and exact dates are still pending and will be emailed and posted to the Ed Tech website soon.

In all, 75 percent of Colorado schools made their AYP targets in 2007. That overall percentage was unchanged from 2006.

The federal *No Child Left Behind Act* (NCLB) requires school districts to make determinations of Adequate Yearly Progress in reading and math for all schools in the district. The Colorado Department of Education (CDE) sets the guidelines and targets for determining AYP within the parameters set by the law. CDE uses the Colorado Student Assessment Program (CSAP), Lectura (a Spanishlanguage test given to qualifying students), CSAPA (for students with a significant cognitive disability) and graduation rate data to provide districts with AYP calculations for all schools.

Additionally, CDE calculates AYP for all districts in the state. Fifty-seven percent of districts in Colorado made AYP compared to 60 percent in 2005-2006. Ninety percent of districts made at least 90 percent of their targets.

With approval from the USDE last spring, CDE obtained permission to allow districts and schools to make AYP with an additional methodology. An additional safe harbor measure, called Matched Safe Harbor, was added. The measure looks at how the exact same students in a school do from one year to the next (as opposed to regular safe harbor which compares the students in the school in 2006 to the students in the school in 2007. If the school or district doesn't make the performance target or regular safe harbor, they can make AYP by showing a 10% reduction in the percent non-proficient of the same students from 2006 to 2007. Seventeen schools and two district levels were able to make AYP by using the Matched Safe Harbor calculations.

NCLB School Improvement

Only if a school receives Title I funds (federal funds for supplemental education in reading and/or math) are consequences attached to AYP determinations.

A Title I school that does not make AYP for two consecutive years in the same content area (reading or math) is placed on first year School Improvement, requiring the school to create a school improvement plan. The district must also provide transportation for children whose parents wish to transfer them to a higher performing school in the district.

For each additional year of remaining on the School Improvement list, additional steps are added

that bring resources to the school or provide parents with more alternatives. These steps are only in place at Title I schools (those that receive federal funding based on their demographics).

In addition to the 12 Title I schools removed from the School Improvement list this year, 17 Title I schools on the School Improvement list made AYP this year. If those schools make AYP next year, the schools will be removed from School Improvement status.

Following is the current number of schools on the School Improvement list:

- 31 schools have missed AYP targets for two years, meaning they are on Year 1 of School Improvement Status. They are required to have a school improvement plan and offer public school choice with transportation provided.
- 26 schools have missed AYP targets for three years, meaning they are on Year 2 of School Improvement Status. These schools must also provide supplemental tutoring services.
- 25 schools have missed AYP targets for four years, meaning they are on Corrective Action. These schools must revise their school improvement plan, provide transportation to other public school choices, offer supplemental tutoring, and the district must take one of seven corrective steps.
- 13 schools have missed their AYP targets for five years in a row, meaning that they are listed as "Restructuring, Planning." The district must also develop a plan to restructure the school.
- 27 schools have missed their AYP targets for six years or more and are listed as "Restructuring, Implementation." These schools must implement the restructuring plan.
