# ANNUAL NCLB REPORTING REQUIREMENTS

Congratulations to those districts that were 100% compliant with the NCLB Reporting Requirements in 2006-2007. Compliant districts do not need to send your Annual Report to CDE for review this year! Please note that all districts need to send the report to your public!

However, if your district was not 100% compliant in the reporting requirements then you must send in your Annual Report to the public for review by **December 1, 2007**. Districts can check their status by logging into the C-FIRS system at: www.cde.state.co.us/scriptscfpu/cfirs06/index.asp. The reporting requirements for the Annual Reports are posted at:

## DON'T MISS THIS GREAT OPPORTUNITY

Consolidated Federal Programs has completed a total of 74 School Support Team (SST) reviews since its inception in 2003.

The Title I School Improvement Grant will again be offered for the 2007-2008 school year. All schools on improvement are eligible for the grant; however, due to limited funding, awards will be made on a first come, first served basis.

Funding for the grant is disseminated in two parts. A Year One grant is awarded in the amount of \$50,000 to fund a SST review of the school program. The remaining funds (approximately \$30,000) will be awarded to the school to support a debriefing of the report with school staff, planning and initial implementation of short-term recommendations.

Schools will then receive a Year Two grant ranging from \$50,000 to \$100,000 in June 2008 to address the major areas of need as identified by the external review.

## WISE: The Web-based Inquiry Science Environment

WISE is a simple yet powerful learning environment where students examine real world evidence and analyze current scientific controversies. Curriculum projects are designed for grades 5-12 and include exciting inquiry projects on topics such as global climate change, population genetics, hybrid cars, and recycling. Students do most WISE activities on a computer, using a web browser. WISE (in this free online software environment) provides tools for data visualization, causal modeling, simulations, and assessment. #### FOUNDATIONS IN FAMILY LITERACY TRAINING

Foundations in Family Literacy provides a framework for understanding the comprehensive, four-component family literacy model. Foundations is designed to provide a basic overview of the principles and practices of family literacy and the research that supports those practices. This training has been created by the National Center for Family Literacy and will be delivered by NCFL trainers.

#### Foundations in Family Literacy training goals:

- ✓ To develop a basic understanding of the skills and strategies needed to implement the four-component family literacy model
- ✓ To explore and utilize relevant research in the development of family literacy services
- ✓ To understand the research that supports and validates procedures and strategies used in teaching reading and writing skills to children and adults
- ✓ To understand the research-based principles and strategies for teaching parents how to support the development of their children's language and literacy
- ✓ To understand the principles and strategies important in the development of meaningful parent and child interactions
- ✓ To demonstrate the principles and strategies which make component integration powerful and productive
- ✓ To summarize, in action statements, ideas generated and lessons learned for program development and improvement

This 3-day training will be aimed toward beginning family literacy practitioners and will be held in January or February, 2008. Exact dates to be determined based on interest. The cost for each participant is \$125 and includes lunch. Participants who bring a *Foundations* manual to the training pay only \$25.

## Accessing Needs Assessment and Identifying Gaps

At the NCLB Directors Meeting in September, Dan Jesse and Clare Heidema from RMC Research conducted a session on needs assessments, examining how to choose instruments, collect data, avoid common mistakes, and describe results to identify priority needs and satisfy NCLB requirements.
