As we approach the summer months, we begin to look forward to July 4 – our Independence Day. It is a time to celebrate our country's freedom complete with fireworks, picnics, and deep

gratitude for our independence as a nation. To be independent is to be selfsufficient and self-reliant. It means to have freedom to make choices, to fulfill our potential, and to make our own mark on the world.

Our goal is to raise and support our children to become fully self-sufficient and selfreliant. This creed is so powerful that the field of educating children who are blind/ visually impaired long ago developed a companion curriculum to the core general education curriculum. Educators define "core curriculum" as the knowledge and skills expected to be learned by high school graduation. The core curriculum consists generally of knowledge and skills related to academic subjects (English Language Arts, math, science, etc.). The Expanded Core Curriculum for Children and Youth with Visual Impairment (ECC) is the body of knowledge and skills that are needed by all students who have blind/visually impaired due to their unique disability-specific needs. The underpinning focus of the ECC is to build concepts and skills to increase personal independence and success. What we all need to implement the ECC is time—and what better time than summer time!

There are many activities (see the Calendar of Events) that children and youth can become involved in over the summer months to increase their concepts about and skills of independence. Summer is also a great time for families focus on building self-sufficiency on the home front. Parents are key to encouraging / expecting a child's self-responsibility of getting dressed in the morning, helping with or fully completing house-hold chores, making snacks or a meal for the family, getting around the neighborhood and community, etc. No matter the age, blindness/visual impairment should never be an excuse for a child not to be working on ageappropriate independence. Without high expectations and real opportunities, our children and students do not move steadily down the path of independence.

As summer approaches, think about how to maximize personal independence skills of our shared children. Everyday should and can be Independence Day!

#### A Great Student Tool: The Braille Caliper

Chris Tabb shared information about the braille caliper at our recent CDE O&M Seminar. The Tactile Caliper is a simple to use, accurate low-cost measuring ruler for people who are blind and visually impaired. It provides a braille output to 1/16th of an inch.

Developed by SQUIRREL DEVICES (past winner of the Louis Braille Touch of Genius Award), the Caliper allows its user to measure with accuracy and speed. It displays readings directly in braille. It is a simple mechanical instrument that can be used anywhere by people of all ages. ## **CDE Happenings**

#### **Gifted Identification and Twice Exceptional**

The Exceptional Children's Educational Act (ECEA) requires all administrative units (AUs) in Colorado to identify and serve students between the ages of five and twenty-one, and age four in administrative units with Early Access, whose aptitude or competence in abilities, talents, and potential for accomplishment in one or more domains are so exceptional or developmentally advanced that they require special provisions to meet their educational programming needs.

Administrative units include: school districts, Charter School Institute (CSI), multi-district administrative units and Boards of Cooperative Educational Services (BOCES). There are a variety of important resources about Gifted Education at:

Twice-exceptional students are those who are identified as gifted according to state criteria in one or more of the categories of giftedness (cognitive, academic, creative, leadership, or arts) *AND* Identified with a disability according to federal/state criteria – and the disability qualifies them for either an IEP or a 504 plan. The goal of identification of a child as a twiceexceptional learner is to bring personnel together; both those trained in gifted education and those trained in special education. For the child with visual impairment, including blindness, this means that the teacher of students with visual impairments plays an important role to work closely with the gifted education personnel to determine accessibility to the identification tools and process. It may be that the team works to build a body-of-evidence to determine the child's qualifications for Gifted Education.

#### Licensure Requirements for TVI and COMS Colorado Initial Licensure in the Endorsement Area of Visual Impairment

All candidates for initial educator licenses in Colorado have historically been required to take and pass one or more of the PLACE Content Assessments. Candidates for the special education endorsement in Special Education Specialist: Visual Impairment were mandated previously to pass the *PLACE Educator Content Assessment for Special Education Specialist: Severe Needs – Visually Impaired.* This test had a short section to assess braille competency in English Braille American Edition. This particular content assessment is suspended currently as a licensure requirement. Whether this specific test will be revised to include a section specific to Unified English Braille or is fully replaced with another test as a licensure requirement is yet to be determined.

At this time, it is important to note there is not a Professional Services and Educator Licensing Unit content test that requires a candidate for the Special Education Specialist: Visual Impairment to demonstrate braille competency as a requirement of licensure.

It is further important to note that if such a content test is reinstated, it does not replace the Colorado Braille Competency Test administered through the Exceptional Student Services Unit. This latter test is not tied to CDE licensure.

#### **CDE Licensure Requirement for O&M Specialists**

If you are working in a Colorado administrative unit as a School Orientation and Mobility Specialists, please know that you MUST have a current CDE license as a special services provider: School O&M Specialist.

If you do not have this license, your scope of O and M services should be severely restricted to those skills that could already be taught by a TVI. Without this license, you are placing yourself and your AU at risk for O&M-related liability. There is no temporary or emergency licenses for School O&M Specialists.

The NIMAC is excited to announce the successful launch of their new online system, NIMAC v3. The launch on March 21, 2017 represents the culmination of a year-long development project which involved a comprehensive analysis of their users' needs and a complete system redesign. As technology advanced over the past several years, new options became available to the NIMAC.

Since its beginnings in December of 2006, the NIMAC has now grown to house over 46,000 file sets from 130 educational publishers. The NIMAC's more than 400 users—including all 50 states and seven Outlying Areas—have downloaded over 26,000 NIMAS files for use in the production of accessible materials on behalf of students with print disabilities. this work going forward with the launch of the new system.


#### **APH Annual Report Celebrates the Year of Braille**

#### First Place winner of the previous contest

**Entries Due August 10, 2017!** Once again APH is the U.S. national contact for The International Tactile-Illustrated Book Prize, a biennial competition created to encourage improvement of the quality and quantity of tactile books for young children with visual impairments. Don't miss your chance to submit your tactile book, designed for children with visual impairments from 3 to 12 years of age.

The competition is conducted by Typhlo & Tactus (T&T), an organization comprised of western and eastern European nations that exists to improve the quality and quantity of tactile books available to young children with visual impairments in member countries. As a part of T&T's efforts, the organization has conducted a biennial tactile book competition each year, beginning in 2000. At first, the competition was open only to European T&T members, but in 2011, it was opened to a worldwide audience.

A panel of U.S. judges will review entries sent to APH and select the top 5 tactile books for final adjudication by an international panel of children and adults with visual impairments, as well as professionals in the field of vision. A single winning entry will be chosen, along with ten shortlisted books. Selected books may be featured on the T&T website, on posters, or in promotional materials used by T&T.



#### The Importance of Pre-K Work with Our Youngest Students

A task force comprised of esteemed social scientists from Brookings and Duke University has just issued six consensus statements on what is known about the effects of Pre-K. Not surprisingly, but of great importance, the scholars agree that what happens before, during, and after Pre-K all matter:

"Children's early learning trajectories depend on the quality of their learning experiences not only before and during their pre-k year, but also following the pre-k year. Classroom experiences early in elementary school can serve as charging stations for sustaining and amplifying pre-k learning gains. One good bet for powering up later learning is elementary school classrooms that provide individualization and differentiation in instructional content and strategies."

Available electronically are a Brief Article from Brookings, a 16-page Consensus Statement, and 106-page Full Report.

For those of you interested in short- and long-term evaluation studies of state- and district-funded Pre-K, there is an excellent bibliography at the end of the <u>Full Report</u>.

-Learn as much as you can about your child's *specific* visual impairment. The more you know, the more you can help yourself and your child.

—Understand that your child is **receiving small bits of information at a time**, not all at once through vision. Help your child explore new things with his or her senses and build up a concept of the "whole." For example, your child might need to be shown a banana, help you peel it, feel the banana without its skin, have a bite of it, and then help you mash it in her bowl to understand the qualities of bananas and that bananas can be eaten in different ways.

-Encourage curiosity and explore new things and places often with your child. Give lots of opportunity to touch and investigate objects, ask questions, and hear explanations of what something is, where it comes from, and so on.

-Learn how to **adapt your home**, given the range and degree of your child's visual impairment. Help your son or daughter explore the house and learn to navigate it safely.

-Encourage your child's **independence** by letting him or her do things, rather than you doing him or her. Teach how to do a chore by using hands-on guidance, give lots of practice opportunities with feedback.

-Work with the early interventionists or school staff (depending on your child's age) to build a solid individualized plan of services and supports that address your child's unique developmental and educational needs.

-Talk to other parents of children who have visual impairments similar to your child's. They can be a great source of support and insight in the challenges and joys of raising a child with vision problems. Many of the organizations we've listed in the Resources section have state or local chapters you can contact. You can also visit **Parent to Parent**, which specializes in teaming new parents up with veteran parents of children with similar disabilities. -Keep in touch with the professionals working with your child. Offer support. Demonstrate any assistive technology your child uses and provide any information teachers will need. Find out how you can augment your child's learning at home.

#### Assignment Updates from Last Meeting

- Information about identification of students who are gifted and talented / twice exceptional was posted in the January February 2017 edition per questions about this process.
- We are still in need of a DVR listing of providers for the state.
- A goal for the fall will be to prepare a video tape of a child being screened in a braille-format DiBELS.

#### PARTNERSHIPS WITH OUR EYE CARE COMMUNITY

Working with our Ophthalmological and Optometric Communities: Discussion with Dr. Kara Hanson and Dr. Robert King. Dr. King is a pediatric ophthalmologist who works closely with Anchor Center for Blind Children. Dr. Kara Hanson is a low vision optometrist. She noted that she really appreciates it when a TVI / COMS come into the eye examination. Linda Corssmit is the Eye Clinic Coordinator at the Anchor Center for Blind Children.

There was a wealth of discussion about the unique roles of eye doctors and TVIs. Dr. King shared that eye doctors very seldom gets feedback. There is not enough communication. It is important to understand that many eye examination appointments may be only be 15 minutes in duration. Any information that can be provided ahead of the examination can be very helpful. For learners on the TVI's caseload, there is a great opportunity to help provide information to the doctor.

We discussed something very simple – a paragraph or simple comments specific to:

- Some history of what is working with the child / what is not working.
- What do you want out of the evaluation what are key goals of the appointment. The TVI can "lead" the exam in certain areas.
  - ✓ Estimation of Acuity
  - ✓ Positioning of Child / Positioning of Objects
  - ✓ Glasses: Full-Time Near / Distance
  - ✓ Lighting Needs
  - ✓ Low Vision Device Need
  - ✓ Considerations: print enlargement or enhancement, braille

What can we do to have a feedback loop to the doctor about his or her recommendations? What worked and what did not? It was recommended to have a template for 0-3 and 3-21. It was also recommended that we have a standardized form.

What are recommendations for reaching out to establish a communication relationship with an eye doctor? Dr. King noted that it would be helpful to know more about the child and what is needed from the eye exam.

It would be good to reach out to liaisons from certain eye care offices to bring that person into the communication loop. Dr. Hanson thought she could find someone from her faculty. She has also invited a TVI to come meet with the residents.

We also discussed the value of lab notes / report summaries that could be attached to the form to avoid duplication of effort.

<u>Assignment</u>: Meet to draft the standard eye examination report form that could be used for school-age student (Tanni, Nancy, Julia, and Jim).

#### **PROGRAM UPDATES**

#### Metro Region (Nancy Cozart)

Our last meeting was on March 9<sup>th</sup>, hosted by Denver Public Schools. We covered a lot of information! Key Content included:

Trina Boyd Pratt is no longer operating as a coordinator for Foresight.

DPS staff did a wonderful job of formulating a document with a variety of options for field trips to do with students who are visually impaired. Others in attendance added to the list as well.

We had the opportunity to hear from staff members from DVR who are getting the transition services off the ground. We were able to ask questions and give input. This special division will be evolving by getting input from a variety of TVIs, COMS, agencies, and families. It is great to begin forging the possibilities for our teens across Colorado.

Steve Lindauer, Director of A Shared Vision, introduced himself and was present for the whole meeting to learn more about services for the school age population of students with visual impairment.

Items discussed at the March meeting:

There was a brief discussion about eye report forms in general, as well as how to communicate with doctors, including educational recommendations, attending appointments, etc.

A request was made for input again on the Resource Allocation Guidelines for a caseload management. We are trying to get scoring of three types of students – braille, low vision, and additional disabilities through 2 TVIs that know the same three kids for inter-rater reliability. (Thanks for the couple of you who have already shared!) A few TVIs are working on a major revision of this document, so your input is very important. Then, others representing various agencies will review the final draft. Changes that are being discussed include: (a) updating language to 2017; (b) separating O&M to a self-standing RA document ; (c) looking at this document through the lens of the 9 ECC areas; and (d) threading our students with additional disabilities more effectively

The final metro regional meeting will be held May 11<sup>th</sup> at 3:30 p.m. TVIs in Aurora Public Schools will host. Janet Anderson has arranged for Paul Sandoval to be there. Paul used to work at Beyond Sight as the technology expert and now owns his own consulting and training business. He really knows his stuff and can teach it. He will be talking about iPAD apps and the accessibility features on OS. We also plan to set dates for next year. The plan we currently have in place of certain districts hosting is working well. The TVIs now organize the topic(s) and set up guest speakers in addition to the physical space and snacks. The collaboration has been terrific!

Nancy shared a metro-created document that had links of different places that might be good field trip opportunities for students with visual impairments. This list can be expanded across the regions. This information could be posted on the CAER website.

#### Southern Region (Deb Andrews)

Southern Region has been busy. Diane Fitzkee is working on planning a trip to Skate City for kids in our region. The tentative date is May 1. Contact her for more information. <u>Dfitzkee@d49.org</u> We've had some training at our regional meeting on making Word Documents accessible and are set for round two on April 12. Several TVIs attended a training at CSDB on audio description.

Regional Meeting dates: May 10, 2017

**Discussion**: Would it be possible to ask eye doctors to put "consult with district TVIs" regarding school accommodations instead of putting specific accommodations in the eye reports?

A recent discussion at the southern region was on making word documents accessible. The goal is to teach teachers to understand accessibility needs, but it is really helpful for TVIs to also have this information. Paula shared that Closing the Gap is a great AT resources. One of the featured presentations was on recent apps. There may be some great resources on their website.

There have been concerns that a CVI diagnosis may lead families to believe that the child is automatically eligible as a child with visual impairment, including blindness. As with ocular visual impairment, it is important to determine whether there are true visual impact concerns that require specially designed instruction. It is important to reassure families that services may be reconsidered based on new needs for the child.



There was a good discussion on student data privacy concerning the CIMC registration of students (etc.). There will be a meeting in June to discuss CIMC policy needs and privacy factors will be one of the key discussion areas.

#### Western Region (Angela Sims)

Mesa School District wants to give a big shout out to their amazing braillist Lesli Tigert. Lesli just completed her braille modules! Congratulations on that major accomplishment! More excitement worth mentioning ... Hayden Roswell competed in the Braille Challenge and once again took first place in her division! She is so excited and just waiting to see if she'll be invited back to nationals. We're all so proud of her and keeping our fingers crossed.

Angela Sims is passing off the baton; Julie King will be taking over as the Western Slope representative for next year. Thank you Julie!

#### Northern Region (Julie Hutchinson)

*Staff Updates in the North:* Liz Wieder (Saint Vrain Valley Schools) has completed her Master's Degree and O&M Practicum – yay, Liz! Greeley Schools (District 6) is looking for a full-time TVI for the 2017-2018 school year and a TVI to provide ESY services this summer. Thompson School District is also looking to hire a half-time TVI.

At our last meeting (1/27/17), Trina Boyd provided our group with a brailler cleaning workshop. Each TVI came to the meeting with one especially dirty brailler in need of some TLC and Trina showed us disassemble, clean, oil and reassemble each brailler; the workshop was incredibly informative and equally fun. Sally Burch filmed the workshop on behalf of CAER and the video should be available on its website soon. The Northern Region TVIs also reviewed and discussed notes from the recent Vision Coalition meeting. The Northern Region agreed that it would be beneficial for all Colorado TVIs to use the same eye medical report templates – one for babies/toddlers and one for K-12 students. TVIs shared that they are beginning to make connections between DVR and their students/families but that the process is still somewhat slow-moving with regard to setting up meetings between counselors and families. The Northern Region is hopeful, however, that the summer programs provided by DVR will help their students to become more familiar with DVR and their purpose in working with students at the transition-age level. At our next meeting, we will be exploring and discussing the Building on Patterns Prekindergarten program and other programs being used with early learners in order to develop a better sense of how our region's TVIs are utilizing time and instruction with younger children with visual impairment, including blindness.

The next Northern Region Meeting will be on April 21, 2017

#### Discussion:

- Are any other TVIs receiving eye medical reports in which the eye care professionals are writing/documenting that students should qualify for vision services on the eye medical report itself? Not a recommendation but more like a professional assertion. If so, how do you address this with the families/IEP team when determining eligibility, with the issue being that this is somewhat of a pre-determination of eligibility from an eye doctor? <u>Response</u>: This is will be a focus on the VC to help to develop a sample eye doctor form.
- Some TVIs from the Northern Region are experiencing an increase in amount of students with Cortical Visual Impairment (CVI) on their caseloads and are feeling somewhat overwhelmed in determining the amount and types of services they should be providing to these students. They are hoping for some discussion on what the rest of the state is doing in reference to the amount and types of services TVIs are providing to students with CVI (i.e. are you providing direct instruction in literacy to address the unique instructional needs that students with CVI require or are you providing indirect instruction to their Sped teachers to address these needs? Do you feel that the teachers are listening to and utilizing TVI recommendations or do you get the sense that you are expected to provide academic instruction to these students? Are you using a CVI severity rating scale? Generally, what do your services look like for this demographic?). <u>Response:</u> This may well be a topic for the fall conference. It sounds like there is a continued need for strategies to work with children with CVI.

#### Colorado AER (Trina Boyd Pratt)

CAER has been active with trainings and fundraisers since the last Vision Coalition meeting.

February 4<sup>th</sup> was our first JAWS training. We had 22 people come. February 11<sup>th</sup>, we had a fundraiser at the Spero Winery. We made \$1,000 with donations included (Barb Galgano brought in many donations from her friends). March 14<sup>th</sup>, the McDonald's at Parker and Quincy held a McTeacher's fundraising night from 4-7pm in which CAER received a percentage of the money made. Jeannie Lei was the coordinator for this activity. We made \$250. On April 8<sup>th</sup>, we held the second JAWS training that dealt with Google documents. Showe Yang has been the instructor for the JAWS trainings and graciously has given her time on the Saturday trainings. Found out that NVDA works well with Google documents instead of JAWS.

#### Colorado Division of Vocational Rehabilitation Services (Dana McMullen)

DVR is now providing Pre-ETS (Pre-Employment Transition Services) to students with visual impairments. A survey was sent out to all TVIs, thank you for your feedback.

- Eligible for Pre-ETS Transition age (15-21) who are enrolled in school.
- YP Case Student who have a visual impairment, are enrolled in school, but has not established an employment goal.

Denver Metro DVR teachers are currently working on a series of Pre-ETS 2-3 day workshops that will take place over the summer including career exploration/counseling, college preparation, and work readiness skills which include all the areas of Personal Adjustment Training (PAT) including Daily Living Skills, Orientation and Mobility, Adaptive Communications and Adaptive Technology (see brochure).

BLVS teachers now have two supervisors. Karen Klein supervises the center program and Sue Williams supervises the field teachers. Laverne Dell supervises counselors. DVR hired a new trainer for the Business Enterprise Program, Ellen Karre.

Discussion: What is the main barrier that keeps your students from attending summer programs? How can DVR/PAT staff be more involved in the transition process?

Dana brought packets of information about the Workforce Innovation and Opportunity Act (WIOA)

#### A Shared Vision (Paula Landry)

Our first few months as A Shared Vision have been a whirlwind of meetings, trainings and travel, but best of all: lots of quality time spent with children and families! This past month we provided over 120 consults and home visits in both local and rural communities. As our numbers continue to grow, we have hired our 4<sup>th</sup> TSVI! Caitlin Bleything, our former intern, has officially joined the ASV team and we couldn't be more thrilled! Caitlin joins TVI staff members Paula Landry, Stefanie Kirkwood, and Sarah Bickford Vallese. We have recently completed the Telehealth Training through CDHS and will begin providing Early Intervention vision services throughout the state via telepractice. Through the use of audio/video conferencing, our teachers will be able to participate in home visits with families and other service providers in "real-time." We are very excited about telepractice and the increased access to services it provides to families.

Our team is gearing up for our 2<sup>nd</sup> outreach trip which will be in early May. We will be making stops throughout the north and south western areas of the state (including Montrose, Durango, Cortez, Grand Junction, Glenwood Springs, Vail) in addition to the north east (Sterling). We would welcome the opportunity to connect with TSVIs in these areas to discuss how we can best partner in supporting our youngest children with visual impairment.

Discussion: Tanni shared an update of EIVI meetings. One need will be to help work with transitions from Part C to Part B. There is a lot of information being addressed on how best to serve the state specific to home visits to families of infants and toddlers with visual impairment, including deaf-blindness.

#### Anchor Center for Blind Children (Callie Spotted Elk)

*Program:* We are looking forward to celebrating with the graduating preschool class of 2017 on June 8th. The majority of these graduates have been with Anchor for 3-5 years and we feel honored to be part of this monumental accomplishment with them. Our Infant and Toddler programs will also celebrate the end of their year on June 7<sup>th</sup>.

Dr. Bow, an international fellow from CHC serving as a rehabilitation physician from Thailand, has been spending time in different parts of our program learning from our staff about the needs and services for families of children with visual impairments. When she returns to her hospital in Thailand she is going to initiate a program that serves children with visual impairments.

Karen Jamison, one of our TSVIs, is currently enrolled in the CVI endorsement training through Perkins and anticipates successful completion by the end of the school year. *Student News:* Two high school students were selected to attend the Close Up Trip in Washington DC, April 23<sup>rd</sup>-28<sup>th</sup>. These students were selected based off a submitted essay and also for demonstrating leadership skills in our school on a regular basis. School Events: PSAT and SAT prep workshops are helping prepare 10<sup>th</sup> and 11<sup>th</sup> graders for their upcoming examinations during Friday workshop time. Upper elementary and supported secondary students participated in a special performance by the Philharmonic Orchestra at the Pikes Peak Center called, "The Orchestra Rocks." Students brought their recorders and clarinets along to the performance so when called upon, they played along with the orchestra to songs they had practiced in music class ahead of time. WE Fit Wellness visited Brown 1 South to speak with our students about the 2017 National Fitness Challenge. Three of our dorm students are signed up to participate in this challenge which includes tracking steps on a Fitbit, tracking water intake, and logging sleep patterns. The students are ready to go and excited the application is accessible through their iPads and cell phones. We hosted our second audio description training on Saturday, February 25<sup>th</sup>. March 6<sup>th</sup>-10<sup>th</sup> = READ across America activities were planned in both schools for our elementary students. Students listened to daily stories and participated in daily theme events. Friday students from both schools attended a shared story with Jamie Lugo voicing and Tera Wilkins signing. Freshman Job Shadow day occurred on Monday May 20<sup>th</sup>. Students from the School for the Blind prepared for their trip to iHeartRadio (106.3 FM) by writing commercials for CSDB. While visiting the radio station, they recorded the commercials, which were scheduled to air the morning of March 21<sup>st</sup>. March 3<sup>rd</sup> – At the invitation of Julie Novak, the Youth Orchestra performed in the CSDB gym. The performance was attended by students from both schools. Running Club began the first week of April for elementary students in the School for the Blind. The Bulldog Band was invited to Denver on March 22<sup>nd</sup> to play for the Legislature. The School for the Blind welcomed 3 new students in March, bringing total enrollment to 57 students.



#### CSDB Outreach Services (Sara Noel)

The Visual Impairment Including Blindness 101 workshop, held at CSDB on March 23, addressed interventions for instruction of children who have visual impairment including blindness. Thirty-five attendees, from fifteen school districts/BOCES, listened to three presenters as well as networked through a lunchtime job-alike Q&A session. Attendees included general education teachers, para-professionals, school counselors and psychologists, special education teachers, occupational and physical therapists, orientation and mobility teachers, and a braillist. The activities included discussion on instructional strategies and accommodations, hands-on simulations, while blindfolded, and new resources available.

At the Sensory Safari, held on April 8 and led by staff from the Colorado School for the Deaf and the Blind, fifteen families spent a Saturday morning being introduced to the smells, sounds and "slop" of some of the most distinctive animals. This CSDB Outreach event provided a special day for children, who are blind and visually impaired or deafblind. The families visited the Cheyenne Mountain Zoo learning stations and talked with zoo and wildlife staff. Zoo docents brought lizards, turtles, and an armadillo for a hands-on experience. The families also fed the giraffes and then touched animal pelts/bones. Many families talked with each other about transitioning to preschool, and available resources. After the guided tour, families spent the rest of the day exploring the zoo grounds.

The Colorado School for the Deaf and the Blind is hosting the 26<sup>th</sup> Annual Council of Schools for the Blind Outreach Forum. This forum is an opportunity to learn from each other and share our widely varying models for helping provide short term programs, in-service training, personnel prep support, family support, ECC information and resources, and more. *PLEASE NOTE:* This conference is only open to Outreach staff. #### Colorado Department of Education (Tanni Anthony)

**Colorado Services for Children and Youth with Combined Vision and Hearing Loss Project**: We are in the fourth year of our five-year cycle. The grant is funded from October 1, 2013 through September 30, 2018. The project's mission is free technical assistance to parents and services providers of children and youth, ages birth through 21 and who are deafblind or who have both a vision and a hearing loss. The project has a lending library and a website with a multitude of electronic resources that are available to families and educational personnel.

*Project Staff:* Tanni Anthony and Gina Herrera coordinate the grant project. We are thrilled to share that we now have three Technical Assistance Specialists. Callie Spotted Elk has been hired to do specific work on the topic of interveners. She will be building networking opportunities for our existing interveners and information materials on the role of the interveners. Callie joins Technical Assistance (TA) Specialists Kathryn Daniels and Wendy Stoltman with the project. Kathryn and Wendy provide onsite child-specific consultation and customized training to the educational teams of the children with deaf-blindness. Shannon Cannizzaro is our Family Specialist. Annual Deaf-Blind Census: Thanks to all the people who completed the census forms. We have identified 140 infants, toddlers, children, and youth with combined hearing and vision loss in Colorado. This is a slight increase from our last December 1 Count. A child can be registered at any time in the school year. If you work with a learner with both vision and hearing loss, please be sure to work with Tanni to register the child. All learners identified as having combined vision and hearing loss are eligible for free technical assistance.

Annual Report: Tanni and Gina are currently preparing our annual report for the reporting period of March 1, 2016 through February 28, 2016. It has been fun to go through the data to show the number of technical assistance events and the quality and efficacy of the trainings. (Editor's note: the report was submitted three weeks early and contained a wealth of data on the TA work from this past reporting period).

*Summer Institute:* The 2017 Summer Institute on Deaf-Blindness has been planned! The dates are June 20-12, 2017. The featured speakers with be Dr. Julie Durando and Ira Padhye. Their topic will be making It Routine. Key objectives will be learning to: (a) complete a Literacy Skills Checklist for students with sensory loss and multiple disabilities; )(b) identify three building blocks of literacy; (c) describe two strategies for developing joint attention and meaningful interaction; (d) list three reasons to connect literacy related experiences into the daily routines; (e) identify two strategies for adding literacy skills to established routines, and (f) identify two strategies to select objects to represent. Registration will close shortly as we a full-up!

*Low Vision Evaluation Clinics*: The Low Vision Evaluation Clinics have occurred for the Western, Southern, Northern, and Metro regions. Thank you to all who have participated! We are grateful for our returning LVE Clinic returning team of Dr. Tom Theune, Jim Olson, Wendy Stoltman, and Debbie Haberkorn. Tanni recently send out a request for this year's TVI participants in this school year's clinics to send a response to four evaluation questions. So far over 15 have responded with some great results data.

*Recruitment and Retention:* We have a significant number of openings. There is a full time opening in Denver, along with a fall maternity substitute position. Greeley Schools has a full time position. Poudre has 2 full time positions. Thompson School District has a half time position. Pikes Peak has a full time position. CSDB Outreach has a full time position. Anchor Center for Blind Children also has TVI openings. If people are aware of any upcoming vacancies in their administrative units, they are strongly encouraged to be in touch with Tanni for proactive advertising and recruitment efforts. *(Editors' Note: Since this time, Cherry Creek now has a full time opening).* 

*Listservs:* The CDE ESSU maintains three separate listservs specific to personnel working in BVI programs in Colorado school districts. One is specific to Colorado TVIs and COMs. The second one is specific to Colorado braillists. The third is specific to Colorado TVIs and braillists. It is important to remind all users of these listservs that personally identifiable information (PII) on students and parents should never be posted in any listserv messages. If anyone has questions about the listservs, please be in touch with Tanni.



*Parent Database:* We currently have about 215 parents registered on the CDE Parent Database. This is out of over 1,100 families across the state. The database is used only to mail out the *Keeping in Touch* newsletter and, on rare occasion, other mailings. It is important to keep it maintained with accurate addresses AND families of

children with visual impairment, including blindness that are currently enrolled in our Colorado early intervention or public school programs. As children graduate or families move out of state, we need to ensure that we remove those families from the database. You can do this by leaving a message on Tanni's voice mail at 303 866-6681. As new families come into the system, please help Tanni to be proactive with getting families registered on the database. This is a voluntary process – so families need to complete and sign their registration forms.

#### Proposed CDE-Funded Projects for School Year 2017-18

#### CDE ESSU

#### **Braille Competency in UEB**

All CDE braille testing materials have been converted to the Unified English Braille (UEB) Code. There are no longer any braille competency materials in English Braille American Edition (EBAE). The materials used in the 2016 CDE Braille Refresher Course will be converted to practice test materials for test candidates of the CO Braille Competency Test. It is anticipated that these items will be posted on the CDE webpage specific to braille testing by May 31, 2017. As such, these materials will be fully retired for their use with Colorado TVIs who had demonstrated braille competency with the English Braille American Edition Code.

For those individuals who are in process of completing their 15 braille renewal modules, all remaining modules must be completed in UEB format. For all TVIs who will demonstrate their initial braille competency with the CDE Braille Competency Test in UEB format will be required to take all 15 renewal modules in UEB. As noted, there are no braille competency materials remaining in EBAE format.

Assignment: Tanni and Paula Conroy will talk more about how best to support UEB for math instruction.

#### **Dian Megarry's Retirement**

#### This history was provided by Jan Megarry.

**Dian Megarry** will retire this June from the Colorado School for the Deaf and the Blind. Dian received an Honorary Mention for the Teacher of the Year given by POSB in 1999. Dian P. Megarry grew and performed duties and responsibilities as a Teacher of the Visually Impaired since 1991 as a graduate student in one of the best VI training programs developed in the state of Utah. Dian finished the program with a high recommendation from Helen Brymer, head of the program and one of the gurus in the vision field. Dian was hired at CSDB in August 1993 to teach elementary students in the School for the Blind. Dian recognized the need for students who are blind and visually impaired to learn and perform as close to their sighted peers as possible. During his first year, he found that the academic curriculum was limited and began the process of creating an academic program that would help elementary students learn to read and write braille, learn and use math, connect with the world around them, and learn to become independent, along with many other necessary skills. Dian didn't just teach in the



classroom but he helped plan and involve students in activities and field trips that would help them connect and understand the world around them.

Dian has never done anything half-way. His motto has always been 'If anything is worth doing, it is worth doing well' and gives it everything he has to give, including, and not limited to, time, energy, and self. During his years at CSDB, Dian has served on numerous committees such as: curriculum development (reading, mathematics, writing, social studies, extended core curriculum, daily living skills, social skills, science, transition), School Wide Plan, has created ideas to help with students be successful with graphic organizers and VENN diagrams, evaluated tactile graphics for use in testing and learning materials, and willingly served on interview panels, as well as other committees he felt would help benefit blind and visually impaired students. Dian also assisted in the development and teaching of self-defense for the blind and visually impaired during summer camps, ACB, Independent Center, and others. He promoted physical activity and physical exploration to aid the intellectual development of blind and visually impaired students. Summers were often spent helping students from around the state with summer experiences at CSDB. These included camping, visiting mining camps, rock climbing, exposure to various sports, and teaching transition skills, daily living skills, job skills, braille literacy, and Nemeth mathematics. He also courageously faced the cold to take students snowshoeing during the winter months. Dian loved the idea of being active and enjoying the energy of youth and collaboration with other Teachers of the Visually Impaired.

Dian has always been active in the field of vision, not only working with children but working with adults. He was an active mentor for students who are blind and visually impaired, served on the role model team as a Community Mentor, and was a member of NFB, AFB, and AER, as well as assisting where he was able. Dian attended the Getting In Touch with Literacy Conference in Vancouver, Canada in 2003 then assisted with planning, implementing and presenting at the Getting in Touch with Literacy Conference in Denver in 2005. Dian was eager to help new and upcoming teachers in the field. He shared his knowledge and skills serving as a mentor to three student teachers and four new teachers. Dian even encouraged two of his best paraprofessionals to go to school and become teachers of the visually impaired and have their own classroom of blind and visually impaired children. Dian took training to help at risk students become successful in school by becoming trained and certified in each of the Lindamood-Bell Programs (Sensory-Cognitive Instruction: A Reformation in Teaching Reading, Intensive Reading Demonstration, Implementation-Staff Perspective, Implementation of Lindamood-Bell, Lindamood-Bell Phoneme Sequencing (LIPS), Lindamood-Bell On Cloud Nine for mathematics).

Dian participated in the 1999 National Federation of the Blind Braille Readers are Leaders program with his students. He became an instructor for the Intel Teach to the Future Program at CSDB, became a certified tester for the Woodcock -Johnson III Intelligence Test, and maintained his braille proficiency for the state of Colorado. We must agree that Dian believes in being active and keeping up with information, as well as participating in trainings that would benefit students who are blind and visually impaired.

Dian took a little time off but was unable to stay away for long and returned to CSDB to, once again, put students first by teaching braille, and elementary literacy and science focusing on academic success. Albeit a short time since his return, it is now time for Dian to spend time with me, his wife, while we are still able to camp, travel, explore, and learn together. Dian has been a huge asset in the field of vision during all the time and energy he has invested and will be missed. I assure you that Dian may not physically be in the classroom but his mind and his heart will always be with students and those in the profession.

As a young girl growing up on the East Coast, Rebecca read a book about guide dogs and instantly became interested in them and in blindness. Her passion ignited, she completed a research project about people who are blind when she was in the 6<sup>th</sup> grade. She also visited a school for the blind and started to teach herself the braille code. All this at the tender age of 12! This curiosity brought her to Penn State where she graduated with an elementary degree in Elementary Education. She fell in love with the Nittany Lions and was a member of the Penn State Equestrian Team. From there, she moved to CO so that she could attend UNC and learn about visual impairment (and ski J).

After graduating from UNC, Rebecca took a long term substitute position in the Aurora Public Schools as a TVI for Brenda Shepard. Then she went on to teach in the Vision Resource rooms at Johnson Elementary and then at Kunsmiller Middle School in Denver Public Schools. As the circle continued, she went back East and was an Orientation and Mobility instructor at the Westchester Lighthouse for the Blind. She missed Colorado so much that she decided to come back and then she worked as a TVI in Aurora again. She opted to try her hand at other teaching positions and taught 5<sup>th</sup> grade for a while at Sixth Avenue Elementary and then 8<sup>th</sup> grade social studies for 15 years at Columbia Middle School. She loved making history come alive for her students! She also decided to go back to school and get her administrative license and was a Dean of Students at Quest for 2 years.

As the circle closes, Rebecca returned to being a Teacher Certified in Visual Impairment in APS. She is a determined, knowledgeable, "tell it like it is" teacher who works hard to offer students with blindness/ visual impairment quality education. We will all miss her dearly as she advances onto retirement. Maybe her next adventure will involve guide dogs :)
