

# **Colorado Deaf-Blind Project News**

**Project Purpose and Staff:** The Colorado Services for Children and Youth with Combined Vision and Hearing Loss Project (aka the Colorado Deaf-Blind Grant) is in the final year of its federally-funded five-year grant cycle. The purpose of the project, awarded to every state and US territories is to identify children and youth with deafblindness and provide free technical assistance (TA) to the identified children, their families, and service providers.

Key project activities are to maintain an annual Child Count process, host professional learning events, and provide tiered and customized technical assistance. The current project has three broad goals: (1) timely identification, (2) family networking, training, and TA support, and (3) professional training and TA support, and 4) intervener recruitment and training / support.

# 2024 Summer Institute on Deaf-Blindness and Significant Support Needs

Save the dates of June 24-25, 2024 for our in-person training on the important topic of *From Interaction to Formal Language - Becoming the Excellent Observer and Thoughtful Communicator with Children who are Congenitally Deafblind* presented by Christopher Montgomery, M.Ed., TVI. During this 2-day, interactive conference we will explore ideas and questions for the adult interaction partner of congenitally deafblind learners with emerging language.

Topics covered will include:

- The Five steps of Interaction;
- An introduction to the Tactile Working Memory Scale (TWMS)

Our plan is to disseminate the flyer and register by mid-February. First priority will be public school teams working with a school-age student with deaf-blindness.

# Fact Sheet in Spanish

Like the English version, it covers what deafblindness is, how many children are affected, and how children who are deafblind learn and communicate. **IEP Team Discussion Guide on Intervener Services – Redesigned:** <u>Are Intervener Services Appropriate for</u> <u>Your Student Who Is Deafblind?: An IEP Team Discussion Guide</u> has been refreshed and updated to make it easier to read and use. The content remains the same except for minor wording changes. The purpose of the guide is to help teams make informed decisions by understanding how a student's deafblindness affects their access to information, communication, social relationships, and conceptual learning.

Intervener Definition – Now Available in Spanish: Intervener Services and Interveners in Educational Settings: Definition is available in Spanish. This document discusses the intervener's primary roles, how they participate as a member of a student's educational team, and essential components of intervener training.

**OHOA-CEC Competencies Alignment Document - Updated**: The Council for Exceptional Children's intervener competencies were updated in 2022, with the title "Initial Specialty Set: Deafblind Intervener." A new NCDB document, <u>Alignment of OHOA Modules with Council for Exceptional Children 2022 Intervener</u> <u>Competencies</u>, lists which competencies are addressed in each of the 27 OHOA modules. Thanks to the state deafblind project personnel and university faculty who helped develop the document.

# 4to24 App: For Parents of Deaf-Blind Youth

The 4to24 app is a free mobile app created for parents of youth who are deaf-blind or have combined hearing and vision loss and additional disabilities. It covers ages 4 to 24, from preschool age into young adulthood. It focuses on reaching the youth's highest potential for independence, community engagement, and employment.

There are two versions of the 4to24 app for two distinct populations: (1) deaf-blind children and youth who have additional disabilities and (2) children and youth who are blind or have low vision. They previously have presented information about the blind/low vision version, which can be found on their <u>website</u>.

The app provides information, activities, and links to resources to inform parents about skills and experiences that would be helpful for their child as he or she grows. For youth who are deaf-blind, app information focuses on building skills and as much independence as possible, with attention to topics like developing a communication system, planning for the future, and creating a profile of the youth's abilities and preferences to share with a support network. It offers suggestions for activities that are flexible for a broad range of ability levels.

Modules of information are delivered about once a month and are self-paced, so the information can be utilized when convenient. To sign up, download the app and create an account by registering as a new user. The app will ask for some basic information on your child's age and grade so that it can start you at the right level.

# NEW DEC Recommended Practices Monograph—Leadership: Leading from Where You Are

The DEC Recommended Practices provide guidance to families and professionals about the most effective ways to improve learning outcomes and promote development of young children, birth through age 5, who have, or at-risk, for developmental delays or disabilities. # New OSEP Guidance on Assistive Technology

The Office of Special Education Programs (OSEP) published updated guidance for the provision of Assistive Technology (AT) devices and services on January 22, 2024. This guidance includes a *Dear Colleague Letter (DCL)* and *Myths and Facts* document. Highlights from the DCL include "beyond ensuring equitable access to technology and educational materials, children with an individualized family service plan (IFSP) or an individualized education program (IEP) may also need AT devices and services for meaningful access and engagement in education. In fact, when developing an IEP, teams are required to consider whether the child needs AT devices and services. [...] These devices and services must be available, accessible, and appropriate for children with disabilities and their families" (OSEP, pg. 2). # **Funding for IEP Translation Costs**

The new Colorado HB 23 1263 for IEP Translation should serve as a reaffirmation of Colorado's commitment to providing this essential service to families with LEP free of charge to facilitate meaningful and ongoing participation in the IEP process. Individuals with Disabilities Education Act (IDEA) and Exceptional Children's Education Act (ECEA) funds can be used in conjunction with other state and local funding sources to cover the costs of language interpretation services as well as for written and oral translations of finalized Individualized Education Program documents (IEPs) and other IEP related documents including but not limited to the Prior Written Notice (PWN), Consent to Evaluation, and the Procedural Safeguards. Administrative Units receive an additional annual allocation from the fiscal note attached to the HB. The AU's allocation is determined by the prior year's Multilingual Learners with Individualized Education Programs (Dually Identified Students) count as reported in the December count collection. You should have already received your fiscal year 2023 allocation.

# Educator Recruitment & Retention (ERR) Financial Assistance Program

ERR financial assistance program funds available for fiscal year 2024 (July 1, 2023 - June 30, 2024) have been fully allocated. Applications that could not be funded will be kept active in the COOL system until an update on ongoing award balances is available, which we anticipate will be in March. Educators who submitted applications during the October/November window will be first to receive any funds that may become available this spring on a first-come-first-served basis. It is unlikely that CDE will be able to accept additional applications in the spring. An <u>online interest form</u> will be utilized again to capture information from educators who would like to apply for the financial assistance. In addition to providing contact information should funds become available, these form submissions help CDE quantify the unmet need for this program across the state.

Financial assistance has been awarded to 662 educators so far this year. And 208 of them filled positions in rural or small rural school districts. The average award amount was \$7,502. The retention rate of educators awarded financial assistance in the first year of the program (2021-22) is 99%.

# Important Reminder: Principal/Administrator READ Act Requirement

For the 2024-25 budget year and each budget year thereafter, districts are required to submit evidence that each K-3 principal and each K-3 administrator, as defined in state <u>rules</u>, successfully complete evidencebased training designed for K-3 principals and administrators in the science of reading. CDE's Early Literacy and School Readiness team will be offering the next Principal/Administrator Read Act office hours on Thursday, January 8 from 3-4 p.m. These office hours will focus on answering questions and sharing key information and resources designed to support districts in ensuring all applicable principals/administrators meet the Aug. 1, 2024 evidence-based training deadline.



# **Teaching Learning Conditions**

The Colorado Department of Education and the Colorado Education Association are encouraging all school leaders, and school support professionals to participate in the statewide Teaching Learning Conditions Colorado survey. This confidential and anonymous survey will be available at <u>www.TLCCsurvey.org</u> until 5 p.m. on Friday, February 23.

Individuals who work in schools can get their site survey codes from their CEA representative or school leaders. The biennial survey provides an important opportunity for educators, building leaders, and school support professionals to provide feedback and insights on the teaching and learning conditions of their schools and districts.

The Colorado Department of Education uses survey responses to understand the areas where educators need resources and support. Schools and districts that reach 50% staff participation and at least five responses can also access survey results to help them understand the needs and concerns of the educators in their communities. Educators and support professionals will receive unique codes that allow them to complete the survey anonymously. This confidential survey can be completed in 15 minutes and includes questions on topics such as facilities and resources, professional development, instructional practices, student and staff wellbeing, and resources for new teachers.

# **Initial CDE Braille Competency Testing Requirements**

**Initial CDE Braille Competency Certificate**: All licensed teachers endorsed in the area of visual impairment, including those individuals employed on a temporary status (Temporary Educator Eligibility-TEE), who are completing their university program in visual impairment, must have a valid CDE Certificate of Braille Competency or a CDE Renewal Certificate of Braille Competency on file with their current administrative unit of employment. This certificate expires five years from its initial issue from CDE.




The CDE Certificate of Braille Competency must be earned <u>no later</u> than May 31st of the first instructional year as a teacher of students with visual impairments, with a Colorado administrative unit. If a TVI moves from one Colorado administrative unit to another, the expectation of first-year braille competency demonstration does not "reactivate" from year-to-year. The testing clock begins with the first day of Colorado employment as a TVI.

The initial CDE Braille Competency Certificate expires fives years from its date of issue.

# **Renewal CDE Braille Competency Certificate**

There is a one time expectation to renew the initial CDE certificate five years after its initial issue. This is accomplished by completing 15 renewal modules across the five year renewal period. These modules must be taken with one of the CDE Braille Proctors. Candidates who are in the renewal process should plan on completed three braille renewal modules during each of the five year renewal requirement.

# **UEB Technical Versus Nemeth Braille Codes**



# **Department Announces Multilingual Education Campaign**

As part of its <u>Raise the Bar: Create Pathways for Global Engagement</u> initiative, the US Department of Education launched "<u>Being Bilingual is a Superpower</u>" to promote multilingual education and bolster highquality language programs and a diverse multilingual educator workforce nationwide. This initiative, led by the Department's Office of English Language Acquisition (OELA), seeks to advance research-based bilingual education and language instruction in early learning settings and beyond. It also strives to further the understanding of bilingualism and biliteracy as an educational and economic imperative for student success, global competitiveness, and engagement.

OELA hosted a <u>convening</u> with education leaders and stakeholders on Nov. 16 in Washington, D.C., to hear <u>Secretary Cardona's vision</u> and the Department's efforts to provide every student a pathway to multilingualism. Additionally, the Secretary released a <u>letter to families</u>, <u>educators</u>, <u>and school leaders</u> to share resources for English learners, including Raise the Bar <u>metrics and data visualizations</u>, the completed <u>English Language Family Toolkit</u> (also available in Spanish, Chinese, and Arabic), and a <u>Seal of Biliteracy</u> <u>infographic</u>. # Visual Impairment, including Blindness

Thank you to all of people who took time to discuss, craft, and comment on the updated eligibility criteria of Visual Impairment, Including Blindness. Thank you also to the Colorado State Board of Education for their careful view and constructive feedback on the draft version and the ultimate final version, which is effective as of June 2023.

The updated eligibility criteria can be found in the <u>Rules for Administration of the</u> <u>Exceptional Children Education Act.</u>

2.08(11) A child with a Visual Impairment, Including Blindness has an impairment in vision that, even with correction, adversely affects the child's educational performance and that requires specialized instruction. The term includes low vision, blindness and/or progressive vision loss.

2.08(11)(a) A determination that a child is an eligible child with a Visual Impairment, Including Blindness may include but not be limited to:

2.08(11)(a)(i) Visual acuity of no better than 20/70 in the better eye after correction;

2.08(11)(a)(ii) Visual field restriction to 20 degrees or less; and/or

2.08(11)(a)(iii) A physical condition of visual system which cannot be medically corrected and, as such, affects visual functioning to the extent that specially designed instruction is needed.

These criteria are reserved for special situations such as, but not restricted to cortical visual impairment and/or a progressive visual loss where field and/or acuity deficits alone may not meet the aforementioned criteria.


# Press Release: DVR Awarded \$14 Million from the Disability Innovation Fund

### **Parents Encouraging Parents**

- Parents Encouraging Parents are conferences, abbreviated as PEP, for families and parents who have children with disabilities, ages birth to 21.
- Parents include parents as couples, single parents, legal guardians, adoptive, and foster parents.
- A support person may attend and accompany a single parent. A support person is one who is helping a parent to
  raise a child(ren) with a disability or who is a caretaker of the child(ren) with a disability in the family (can include
  grandparent(s) or other relatives).
- PEP conferences are arranged in a conference setting, and parents can obtain information relating to parents, parenting, educating, and supporting a child with a disability.
- Professionals are also invited to attend to obtain information relating to educating and supporting a child with a
  disability and their family. Professionals must work with children and youth with disabilities (ages birth to 21) and
  their families.

PEP is a non-specific disability conference that focuses on commonalities, not diagnoses.

In 2023, A Shared Vision supported 175 families, providing 1,865 educational service visits. These numbers represent 69.8% of all vision services statewide. Since our beginning in 2016, we have supported 742 families with 11,000 visits! They have used a Quick Response model to do a first visit with new families to help triage the next steps with families.

One area of new practice is that toddlers whose third birthdays happen in late spring/ over the summer can now continue with Part C services throughout the summer when school services are not available.

*Discussion:* A question came up about how to discern the numbers of infants and toddlers. The proposal to Part C resulted in a collaborative count of the three BVI EI entities. One challenge is that not every infant and toddler with visual impairment has been registered with the CIMC. Jim will follow up on registration needs with the involved agencies.

We are continuing to coordinate our new referrals in the Denver/Boulder metro area with Anchor Center. However, our most significant collaboration beginning in 2023 is a proposal submitted to El Colorado from A Shared Vision, Anchor Center, and the Colorado School for the Deaf and the Blind to address the shortage of El-TVIs in the state, the inadequate compensation, the challenges of providing services within rural communities, and the sustainability of the current service provisioning model. The proposal was presented on October 31, and we are waiting to learn the next steps.

# Anchor Center for Blind Children (Tammy Miller)

Program Updates: We are having a fantastic school year! We have expanded our preschool program from 2 to 3 days/week this year, which has been an exciting change for us and our students. We are at capacity with twenty-eight students enrolled in Preschool but have no current wait list. There are forty-three students in our Infant and Toddler Program, and thirty-two students in our Home Visit Program, with many new referrals for each program rolling in each week.

Preschoolers can enroll at Anchor Center, enroll in their district's preschool, or do both! The new UPK funds go to the district if the child is dually enrolled, but tuition assistance is available to all families based on need. In order to access the UPK funding, all students need to have a Child Find evaluation, and if the family decides to enroll only in Anchor Center's preschool, the family forgoes the IEP established by the school district for that year. Additionally, most CCBs are now funding the tuition for the Toddler program for those children receiving El services.

Our Research Team, led by Dr. Cathy Smyth, continues to grow, and we have many research projects underway! Our NAVEG research project (newborn screenings for brain-based visual impairments), now in its second phase and showing promising results for the future of newborn vision screenings, is underway at Children's Hospital of Colorado. The NAVEG team (Cathy Smyth, Tammy Miller, and Elise Darrow) continues to have requests for trainings on the screening from TSVIs and early interventionists across the country. They have trained El professionals in nine states and have 3-4 more in progress/scheduled over the next few months. The response has been exciting!

The CVI Initiative, headed by Elise Darrow, is working on exciting projects with students who have brain-based visual impairments, including case studies and other research projects in our center-based programs. She, along with Cathy Smyth, continue to represent Anchor Center as presenters and attendees of both education and medical conferences nationwide and are collaborating with vision specialists from around the world on CVI-related research.

Staffing: We are currently hiring Teachers for Students with Visual Impairments, either full- or part-time (flexible schedule). Contact Tammy Miller <u>tmiller@anchorcenter.org</u> to apply or for more info.

Events: We have Community Days planned for each month of the school year for all our students and their families, including swimming, playground visits, adaptive horseback riding, etc. Our Family Services team holds Night Watch respite events, and we will continue to have one per month starting in October. Our 14<sup>th</sup> Annual Visions of Love: Wine Tasting Event will take place on Feb. 2. Given that the Anchor Center is funded in nearly in full by charitable gifts, we are extremely grateful for the support of our sponsors and guests.

Playground Update: We have a new, beautifully designed, inclusive playground, thanks to the Toni Stephenson Memorial Fund! It features ramps for wheelchairs, adapted swings, equipment for movement and musical exploration for kids of all abilities, and it has been an incredible addition to our already-amazing building and campus. We welcome any visitors who want to come check it out!

Headquartered in Denver for 40 years, Anchor Center for Blind Children specializes in serving children with visual impairments or combined vision and hearing loss during their most formative years of development, ages birth to five years. Staffed by a transdisciplinary team of highly trained teachers of students with visual impairments, early childhood special educators, therapists, and a pediatric ophthalmologist, Anchor Center's vision services are customized to meet each child's unique needs and strengths. Families also receive support, guidance, practical knowledge, and connections to other important resources. Anchor Center's primary programming includes: vision assessments and pediatric ophthalmology exams; early intervention home-based services (for children, ages birth to 3 years); center-based programming for infants (newborn -18 months), toddlers (18 months -3 years), and preschoolers (3 - 5 years); occupational, physical, and speech/language therapies; recreational, music, and horticultural therapies; summer camps and family respite care; and family support, including programs for caregivers and siblings. The Anchor Center charges a nominal tuition fee for toddler and preschool programs but does not charge for infant services. No child is ever denied access to services based on the family's inability to pay.

*Discussion:* Praise to ASV, Anchor Center, and CSDB for their shared work with identification and service support to Colorado families with infants and toddlers who are blind/visually impaired or deaf-blind. The work is impressive across their referral coordinators to move through the list of newly referred children.

### Colorado AER Chapter (Chloann Woolley)

The chapter needs personnel who are interested in meeting, holding office, and offering CAER events. If this is an interest area, please reach out to President Chloann Wooley. This is a new role for Chloann, which is exciting! Heather Solbert is serving as Treasurer. There is the current question of whether CAER should merge with another entity, which would mean that funding would be shared. The Northern Rockies AER Chapter is strong and includes several states. This is one model that has worked. There is more opportunity with numbers and the virtual aspects of meetings have really opened the door for participation. There will be a CAER Banquet on May 2. They have had four meetings this year. CAER needs people who are engaged – both to be on the board and to be responsive to the CAER support activities such as mini grants.

### Colorado Center for The Blind Youth Programs (Chaz Davis)

Recently, our year-round youth program has been focusing on STEM and outdoor oriented activities as there have been several requests for such programming. During the fall, we hosted a nature / conservation activity at the Carson Nature Center in Littleton. Students had the opportunity to interact with animals local to the environment, examine owl pelts, and identify different animal claws, wings, and skulls which allowed for a greater understanding of the Colorado ecosystem.

In October, as part of the NFB of CO State Convention, students from nearby school districts attended a STEM Day at the Marriott at Lone Tree. Led by blind female professionals in various science disciplines, Students were able to take part in chemistry and physics experiments in a completely accessible way.

Our young students were able to participate in a rock-climbing experience with Denver Rock Climbing Company, an outdoor climbing outfit that meets students where they are so that they can build confidence through challenge recreation. One student exclaimed that he rarely gets to do outdoor activities like everyone else but felt free when he was climbing.

In November, logistical issues prevented us from being able to host a collaborative event with the Boy Scouts of America for an outdoor skill building activity. We hope to partner with the troop during the upcoming year for a funfilled event building fires, knot tying, and assembling shelter.

This past month, our Blind Parents division of the NFB of CO in collaboration with our blind youth attended an interactive tour with South Metro Fire Rescue Station 12. Participants blind and sighted enjoyed learning about the different tools that the fire department uses, getting an up-close understanding of the various fire apparatus, and even talking to a firefighter in full bunker gear. Participants said that they felt more comfortable around firefighters and seeing them as being more approachable.

Next month, CCB will be partnering with Ignite Adaptive Sports, a program based at Eldora Mountain. Our students will be able to enjoy skiing, snowboarding, snow shoeing, cross country skiing, and more! Our organization has been working with Ignite for over 30 years and even though our students may not become life-long skiers, the exposure to a new experience can prove to be invaluable.

Through the Colorado Parks and Wildlife, CCB has been awarded an outdoor equity grant that will support outdoor recreation, conservation outdoor education, and STEM activities through 2025. This grant will allow our organization to expand our reach and offer more outdoor based programming for Blind CO youth.

Looking ahead to the summer, we will be hosting several camps and summer programs for blind youth in Colorado and beyond. Through a partnership with the National Science Foundation and several agencies that serve blind youth in CO, high school aged students will be able to attend a one-week residential camp starting June 17 at the Colorado Center for the Blind. The focus of the camp is to understand astronomy using 3D printed renderings. Participants will assemble the printers and become familiar with their function as well.

CCB will be hosting our Confidence Camp for blind youth ages 5-11. This day camp will run for 10 days and will expose students to increased Braille literacy, empowerment through cane travel activities, and challenging themselves through recreation too. The dates will be finalized for Confidence Camp in the next two weeks.

This summer the Colorado Center for the Blind will again offer its No Limits to Learning program for blind teens. In addition to the 4-week program we offered in 2023, we will also offer a 7-week program that will include attending the National Federation of the Blind convention in Orlando.

No Limits to Learning 7-week program: Dates: June 21 through August 9. This longer program will provide each student with additional instruction to cement their skills and confidence. Students enrolled in this seven-week program will have the opportunity to attend the National Convention of the NFB that will be held in Orlando Florida. They will learn about techniques of airport travel, how to navigate a large hotel, a wide array of technology, meet blind people, attend meetings to learn more about the NFB and much more. To participate in this program applicants must be 16 years of age or older. They are required to submit an essay discussing why they want to attend the national convention. There is a focus on college-readiness.

No Limits to Learning: 4-week program and the dates are July 12 through August 9. Except for attending the National Convention, this shorter program will cover all elements listed above, including challenge recreation activities. Applicants for the 4-week program must be fifteen or older.

*Discussion:* Age range of children for family activities: four through 21. For students who need to return to school in early August, they may need to depart a few days early from the No Limits program. They do accept students with additional disabilities to their blindness. There are requirements for basic self-care abilities – getting up in the morning, self-grooming, and taking medications independently. For more details, talk to Chaz at <u>cdavis@cocenter.org</u>.

### Colorado Instructional Materials Center (Jim Olson)

A big welcome to our new Administrative Assistant, Danielle Steel, to the CIMC. Danielle Steele started in mid-December and is primarily responsible for processing order for braillers, technology, software, and APH orders.

With input from some of our wonderful early education TVIs, the CIMC has recently revised the "CIMC registration of an Infant with Visual Impairment, Including Blindness" and the "CIMC Exit Form of an Infant with Visual Impairment, Including Blindness." Both forms have been disseminated to our agencies providing early intervention services for birth through two year-olds. If there is feedback on the forms, please reach out to Jim. They will also update the school-age registration form.

Important updates for both our statewide count and our federal quota census database census. The deadline for school districts to submit both of their two count reports to the CIMC has been extended by two months, from the end of January 2024 to the end of March 2024. The 'effective date' for both counts remains Monday, January 1, 2024.

Important update to the federal quota census for January 1, 2024. Beginning in 2024, APH will institute a modified definition of blindness for the purpose of carrying out the Act to Promote the Education of the Blind. In the 2024 Census for students to be eligible for registration in the Federal Quota program, they MUST meet the following criteria: (1) Meet the Definition of Blindness (MDB); (2) Function at the Definition of Blindness (FDB); and a NEW criteria: "IF NEITHER are met, students may also be eligible because they qualify under the Individuals with Disabilities Education Act (IDEA) definition of blindness: <u>an impairment in vision, that, even with correction, adversely affects a child's educational performance (</u>34 CFR §300.8(c)(13)).\*

Stay tuned for whether there will be changes in when APH materials can be ordered for a newly registered child based on the time of year when they are first registered. Braille books can be ordered at any time and a braille writer will be provided as soon as the student is registered, and these needs are established. With that said, braille devices tied to APH funds may not be immediately available.

The CIMC First Friday meetings are going strong! Glad to see this attendance to equalize information across the state.

# Colorado School for the Deaf and the Blind (CSDB) School for The Blind (Jamie Lugo)

CSDB is celebrating our 150<sup>th</sup> Anniversary in April. Students are learning about the history of CSDB through lessons prepared by teachers each month. Students watch videos of alumni giving them advice as well. These videos can all be found on the CSDB YouTube channel. Others can also watch the videos at: <u>https://csdb.colorado.gov/about-</u>

<u>csdb/celebrating-150-years-of-csdb/explore-our-past</u> There will also be a campus program in April. There will be a summer weekend for alumni festivities.

*Campus Activities*: Secondary students with additional disabilities are learning about opinion writing in literacy. They shared their opinions about different musical instruments and will be exploring tactile graphics displaying their opinions. White Cane Day was celebrated at Acacia Park on October 13<sup>th</sup>. City council woman Yolanda Avila presented an official proclamation. Both bands, the Bulldog Band and PRIDE band performed songs, students danced, and poems were read. Our guest speaker this year was Quaiyim Gray, a paraprofessional in the blind school. Tactile art was displayed and described in large print and braille. Elementary students were asked the question: "Where can your cane take you?" This opened a variety of ideas of current, future, and make-believe places that students would love to one day independently travel to. Students have learned some important beginning concepts of how to create landscape using perspective foreground, middle ground, and background. Finally, our CSDB staff band made their big debut singing "Celebration" The entire student population attended, blind/vi and deaf hard of hearing students. It was truly the best White Cane Day yet!

During the self-determination unit of our expanded core curriculum class, students learned about the IEP and their role in their own IEP meeting. They also explored the anatomy of the eye and are currently working on making a 3D representation of an eye using a variety of art materials. Two individuals from the Colorado Springs office of Accessibility, American Disability Act Title II spoke to class. Students learned about the importance of self-advocacy when something is not accessible in their community and the process for alerting the city to the issues. Elementary Career Education classes are learning about different community helpers. Students made police hats, visited the Children's Village (fire station), and we have some guest speakers coming in to talk about their jobs. The Post Secondary Preparation class visited and volunteered their time to Concrete Couch. They learned how to use various tools, identify wood by smell, and made tactile tiles out of clay for their tactile Kiosk. Unity Day was Oct 18<sup>th</sup>. Staff and students were encouraged to wear orange. Students created a chain of links with their pledge to stand united against bullying at CSDB.

The School for the Blind hosted its first ever Spelling Bee on Friday, November 10<sup>th</sup>, with activities available for interested students of all ages and abilities. Assistive Technology: CSDB was a testing site for the new Monarch refreshable braille display. Seven students were involved in testing this device as well as numerous staff. A CSDB Day of the Dead Ofrenda was displayed at the Fine Arts Center in collaboration with neighboring public schools.

Young scientists are conducting experiments to test their hypotheses about multiple things. One group is studying if a plant can grow by disco light, another is testing the effects of classical music on the growth of a plant. Some other students are tracking the growth of either pumpkin seed or sunflower seeds to see germination firsthand. Finally, students are completing poems, songs, or raps about renewable resources and how humans need them for survival.

Does anyone else have a need for uncontracted braille format CMAS tests? This is not a need based on the TVIs represented on the Vision Coalition. Students taking general CMAS tests are typically using contracted braille by third grade. Students who are eligible for the alternate assessment have the option for uncontracted or contracted braille. To gain more information, this could be a good topic for the listserv to further canvas the state.

### Colorado School for the Deaf and the Blind (CSDB) Outreach Services (Donna Keale)

Ashley Renslow has taken over as the Interim Outreach Director (<u>arenslow@csdb.org</u>) as CSDB searches for our next director. The TVI's/COMs have been busy with their caseloads in both school districts and with early intervention. Ashley and Donna are both collaborating with teams to support the 2025 Western Region Early Intervention Conference, WREIC.

# University of Northern Colorado (UNC) VI Program (Paula Conroy)

The VI Program is going strong! Paula is currently working on accreditation, which is a lot of work. Silvia Corres Torres is working with doctoral students. Corey Pierce is stepping down as Director of Special Education and Tracy Gershwin will assume this role. UNC currently has a hiring freeze. Currently they are using past doctoral students as adjuncts. The cohort currently has a few Colorado candidates. Enrollment is down across the country for university programs.

# Division of Vocational Rehabilitation (DVR) (Michelle Reed)

Staff Updates: Our current vacancies include a Field Instructor O&M/VRT for the Denver Metro area, Field Instructor O&M/VRT for the western slope and a Vocational Rehabilitation Counselor in Colorado Springs.

The Personal Adjustment Training Unit continues to provide training in the community. We continue to discuss and examine ways to provide comprehensive services to the people we serve that include remote training, in-person training, and Zoom virtual group sessions (Reflections, Enrichment Hour, Women's Group, and two Braille Groups) and a Men's Group. We are also going to begin discussions on how to offer in person training opportunities at the Denver Metro Regional Office. However, the Personal Adjustment Training Center based program at the Denver Metro Regional Office will not be reopened. At present, DVR personal adjustment training will continue to be provided in the community and the field.

BLVS and DVR are looking at pre-employment transition services including training/job development support, collaborating with other youth with disabilities, collaborating with other states, and increasing vendors to provide more options and opportunities. We have a new vendor who is providing statewide Pre-ETS services. Statewide referrals would be virtual, and Colorado Springs local services can be hybrid. She is meeting with people 1:1 for now and will be offering six group workshops the week of March 25<sup>th</sup>. She is finalizing the curriculum. Her name is Josie Shea and she was a former rehabilitation counselor in the Colorado Springs office.

# Colorado Department of Education (Tanni Anthony)

Colorado Services for Children and Youth with Combined Vision and Hearing Loss Project: We are closing the final year of our current project. A new grant award was made that will be effective from October 1, 2023 through September 30, 2028. The project's mission is to provide free technical assistance to parents and service providers of children and youth, ages birth through 21, who are deaf-blind or who have both a vision and a hearing loss. The project has a lending library and a website with a multitude of electronic resources that are available to families and educational personnel.

- Project Staff: Tanni Anthony and Gina Herrera are Co-Directors on the grant project. Jessica Meisel is our Technical Assistance (TA) Specialists. Jessica provides onsite consultation and customized training to the educational teams of the children with deaf-blindness. She is also leading our training and support to schoolbased interveners. Cindy Colwell is the Family Specialist.

- Annual Deaf-Blind Count: The December 1, 2023 Colorado Deaf-Blind Child Count forms were disseminated to the field in early October and should be returned to CDE through a secure online portal. The forms for each Colorado administrative unit, Anchor Center for Blind Children, and A Shared Vision are sent to a designated contact who is a TVI. Please note that a child can be registered at any time in the calendar year. If you work with a learner with both vision and hearing loss, please be sure to work with Tanni to register the child. All learners identified as having combined vision and hearing loss are eligible for free technical assistance. This can be childspecific consultation and customized staff training.

- Project Trainings: Three webinars have been scheduled for this school year. The first one occurred on January 22 with Dr. Susan Bruce and focused on self-determination. Over sixty people attended. The February and March seminars will feature Linda Alsop and focus on building a conceptual framework for students with deaf-blindness. The Summer Institute has been planned and Tanni will be sending out the flyer and registration information shortly.

<u>BVI State Funded Activities</u>: The CDE has a strong commitment to services and supports to our students and the staff who serve them. We are pleased to offer professional learning and technical assistance to the special education field serving children who are blind/visually impaired.

- Sound Bites: Sound Bites are monthly virtual training / dialogue sessions based on identified topics of needs. The topics for the 2023-24 school year are almost finalized. Tanni has sent out Calendar Invites and information with the registration link. There has been consistently excellent attendance at these virtual training opportunities. We have the January, February, March, and April trainings left for this school year.
- CDE/CSDB Regional Low Vision Evaluation Clinics: Drs. David Simpson and Kara Hanson are filling the optometrist roles and Karin Hensel is the Low Vision Therapist who will serve the northern and metro regional clinics. Jim Olson is the Low Vision Therapist for the southern clinic. Roberta Curtis will be our statewide clinic coordinator. There was no Western Region Low Vision Evaluation Clinic this school year due to a low number of students. The Northern Clinic occurred in November and the Metro Clinic will be held in February.
- CDE O&M Seminar: The registration flyer for the May 2023 seminar has just been disseminated. We will focus on strategies specific to learners with deaf blindness with featured speakers Caroline Gonzales and Heather Withrow.
- Recruitment and Retention: We have openings in several parts of the state. Please share any expected vacancies with Tanni so we can be as proactive as possible with new recruits. Contract TVI and O&M staff are needed in several AUs. A Shared Vision and Anchor Center need more TVI / O&M Specialist support. Please keep Tanni in the loop on anticipated and real vacancies. If you want to be on the CDE list of contractors, please reach out to Tanni.
- Listservs: The CDE ESSU maintains two separate listservs specific to personnel working in BVI programs in Colorado school districts. One is specific to Colorado TVIs and COMSs. The second one is specific to Colorado braillists. is important to remind all users of these listservs that personally identifiable information (PII) on students and parents should never be posted in any listserv messages. If anyone has questions about the listservs, please be in touch with Tanni.
- Parent Database: We currently have about 250 parents registered on the CDE Parent Database. This is out of over 1,200 families across the state. The database is used to email out the Keeping in Touch newsletter link and, on rare occasion, mailing to families. It is important to keep it maintained with accurate names and addresses of families of children with visual impairment, including blindness who are currently enrolled in our Colorado early intervention or public-school programs. As children graduate or families move out of state, we need to those families. As new families come into the system, please help Tanni to be proactive with getting families registered on the database. This is a voluntary process so families need to complete and sign their registration forms.
- Braille Competency: All TVIs who are new to the field are expected to demonstrate braille competency in their first year of employment in this role. If a TVI extends this date, the administrative unit of employment is at risk for a citation of noncompliance. A Practice Test is posted on the Visual Impairment, Including Blindness website. It

includes practice multiple choice items and braille samples. Please be aware that all TVIs in Colorado public schools must renew their braille certificate one time after the first five years of initial certification.

# **DISCUSSION ITEMS**

**VIB Eligibility:** Tanni reviewed the eligibility tenets of the VIB criteria. She will send out the CDE approved PPT to TVIs to have in hand for their local district training.

**Recruitment Needs:** We must be creative and vigilant about bringing new people into the field. Ideas included (a) identifying parents and paraeducators as candidates for personnel preparation programs; (b) providing these individuals information about existing programs with federal funding supports or other funding supports; (c) identifying a cadre to support; and (d) checking to see if CSDB might be a site for housing practicum students to incentivize Colorado as an employment site.

Virtual TVIs: We are seeing more people working as a CO employed TVI who are offering services virtually. This is a trend we are seeing. What is helping is a collaborative model of school-based providers. One area of discussion will be the ability to confirm braille competency. There are areas of teaching that may be more conducive to virtual training. It also helps if there is a hybrid model with in-person connection opportunities. This might also be an opportunity to consider short term placements at CSDB. This may be a possibility given adequate space / FTE within CSDB. Another area might be how to use a hybrid model within CSDB. Possible challenges to address: (a) ability to be licensed in CO (have these people finished accredited programs), (b) braille competency, (c) AT needs of student for training on equipment and problem solving broken equipment, (d) cost of possibly providing double equipment to the person out of state and for the student, (e) quality braille and O&M instruction, (f) do contracts support the TVI "bringing" a kid to the LVE clinic or other activities or other activities that may be beneficial for the student, (g) do these providers have specific training on virtual teaching / coaching practices, (h) how is the technology working for all things that a virtual TVI may need to observe and interact with the student and the IEP team, and (i) how does this work with paraeducators and others to support the practices when the TVI is not available (which is a fair comparison to an in person itinerant model)

We have more to learn about how this can work effectively. This might be a presentation on this topic that we can use for hiring school districts so we can learn more about how this can work well.


