Reflections from the Co – Chairs By Nancy Carlson and Laura Merrill

In reflecting upon the activities of the Colorado Special Education Advisory Committee during the 2003-2004 year, the committee has taken a leadership role on issues facing special education in Colorado. There are many challenges today that the special education "system" must face and overcome. The advisory committee continues to be a guiding voice on the direction that Colorado and the nation will take to meet these challenges.

Standing Committees

The **Public Policy and Legislation** committee, chaired by Michelle Padilla, pursued two goals: 1) monitor and disseminate information about the reauthorization of the Individuals with Disabilities Education Act (IDEA) 2) raise membership awareness of legislation that impacts special education and promote legislative action. These goals were met through the dissemination of information on the CSEAC listserv and the presentation of reports at each meeting. Other issues that emerged in the discussions following these presentations were election results and their impact on education in Colorado, and education bills proposed during the legislative session. Members of the committee attended a Legislative Breakfast sponsored by the Colorado Developmental Disabilities Council where they met and discussed issues with legislators.

A continuing goal of the CSEAC is to facilitate communication throughout the state of Colorado among local Special Education Advisory Committees (SEACs), parents, agencies and other interested parties.

The **Communications** committee chair, Karen Rutledge, and her committee members were invaluable in directing the task of developing more efficient means of communication within our state.

The **Communications** committee members accomplished the following:

- Established a CSEAC listsery, which has provided a vital link among members, especially for the sharing of legislative information on the reauthorization of IDEA, and issues arising from the No Child Left Behind Act.
- Updated and distributed the CSEAC brochure.
- Researched other states' websites and met with web developers to improve Colorado's website.
- Researched school district websites within Colorado and evaluated them on "user friendliness" for parents. Outstanding sites were Cherry Creek, Boulder Valley, Windsor and Eagle School Districts.
- Surveyed special education directors and coordinators to determine how special education information is shared within their districts.
- Began development of a public awareness presentation capturing the theme "When CSEAC Talks, People Listen".
- Began development of an informational bookmark advertising CSEAC.

- Dispute Resolution Charlie Masner, CDE Senior Consultant: Law and Dispute Resolution, reviewed data on dispute resolution in Colorado.

Informational Updates

The following are just a few of the informational updates the committee received throughout the year:

- Western Slope Technical Assistance Center (WesTAC)
 A new Assistive Technology Center is now open in Grand Junction.
- Eligible Facilities A task force is studying the issues of overall quality, teacher quality and cost implications in facilities.
- Adequate Yearly Progress (AYP) The progress of school districts toward meeting AYP was discussed.
- Schools of Choice Due to lack of physical access some students are unable to attend a school of choice.
- Deaf Education Regionalization A task force is studying the feasibility of a regional delivery approach.
- No Child Left Behind Act The impact of this legislation, particularly in the area of teacher qualifications, will continue to be followed by CSEAC.

The **Membership** committee chair, Dede Landry, and her committee members went through a year long process of recruiting new members for CSEAC. Criteria developed by the committee, which included the required mandates of federal and state law, were used to identify prospective members.

From a pool of 13 applicants, four recommendations were presented to the Colorado State Board of Education. All four applicants were appointed to the committee by the State Board.

The newly appointed CSEAC members are as follows:

- Nella B. Anderson representing institutions of higher education, Congressional District 3
- Cindy Ucker representing parents of children with disabilities, Congressional District 5
- Mike Wales representing Division of Youth Corrections in the Department of Human Services, Congressional District 6
- Ian Watlington representing a vocational, community or business organization concerned with the provision of transition services, Congressional District 6

The **Bylaws and Procedures** committee, chaired by Diane Bassett, reviewed the bylaws and procedures with the committee members and found that changes were not warranted during the 2003-2004 year.

The **State Improvement Plan** (SIP) committee, chaired by Stephanie Lynch, chose to focus on transitions and post secondary school outcomes.

Of particular interest to the committee were the transition from Part C (infants and toddlers) to Part B (school age students), and tracking the effectiveness of transition from high school to post secondary services. The SIP committee educated the other CSEAC members on the topic of transition. Romie Tobin, CDE Consultant, presented a summary report of the 2003-2004 data collected from the Colorado Transition Outcomes Project (TOPs). TOPs is a self-assessment data collection project districts can choose to engage in to assess the quality of Individualized Education Programs (IEPs) for students in transition (ages 14-21). This presentation has provided guidance to CSEAC.

Committee Highlights

In addition to the many accomplishments listed under the subcommittees, CSEAC also completed the following:

 The Ad Hoc Position Paper committee, chaired by Diane Bassett, completed the paper, <u>Secondary</u> <u>Education for Youth with Disabilities: How Post-School Data Collection Can Improve Services and Supports.</u>
