Colorado is implementing significant education improvements aimed at ensuring all students graduate college- and career-ready. Educator Effectiveness

Overview:

Classroom teaching and school leadership are the strongest school-based factors impacting student achievement. CDE supports the state's 178 school districts to attract, prepare and support great educators as a part of meeting the requirements of S.B.10-191, the Great Teachers and Leaders Act.

What's Happening Now:

Update: Colorado State Model Performance Management System

The Colorado State Model Performance Management System

(http://www.cde.state.co.us/educatoreffectiveness/copms) is an optional tool to support the implementation of the state model evaluation system. Several districts/BOCES have committed to using the system for the 2014-15 school year and are now receiving training. Weekly town halls began in July to support districts on setup and implementation of the system. In addition, full day trainings in August (http://www.cde.state.co.us/educatoreffectiveness/copmstrainings) cover district/BOCES staff responsible for training users in the system and providing technical support to users during implementation.

If your district/BOCES hasn't committed to using the Colorado State Model Performance Management System but would like to, you can still sign up. Standards

Overview:

The 2013-14 school year marked the first year of full implementation of the Colorado Academic Standards, the implementation of the READ Act, and the first of a three-year school readiness initiative. The Teaching and Learning Unit offers schools and districts resources and supports to enhance student learning and achievement.

The READ Act Per Pupil Fund Distribution

READ Act Per Pupil Fund Distribution: The Colorado General Assembly allocated approximately \$33 million to the Early Literacy Fund for the 2014-15 school year to be distributed to districts according to the number of students identified with a significant reading deficiency across the state. The department is validating data and anticipates the distribution process to be initiated in early September. Preliminary numbers will be posted to the READ webpage and sent to district READ respondents on **Aug. 18** for confirmation. Districts will have an opportunity to correct their significant reading deficiency numbers prior to finalization of the count for the state.

The allowable uses for the per-pupil intervention money for students with significant reading deficiencies include: (1) providing full-day kindergarten; (2)purchasing tutoring services in reading; (3) providing other targeted, scientifically- or evidence-based intervention services (including but not limited to those identified in the READ program advisory list); or (4) operating a summer school literacy program. As part of the allowable use around scientifically-or evidence-based intervention services, funds may be used to purchase diagnostic assessments on the approved assessment list and to provide the professional development needed for teachers to use READ assessments or provide scientifically- or evidence-based intervention services. Further flexibility in the use of per-pupil intervention funds was provided in <u>H.B. 14-1204</u>, the Rural Flexibility bill. This bill allows small rural districts to purchase the services of a literacy specialist from a BOCES to provide professional development in literacy or other supports for implementation of the READ Act.

Use the Superintendent and Principal Integrated Timelines

Assessments

Overview:

Assessments administered by the unit include summative content assessments, English language proficiency assessments, college/career ready assessments and alternate content assessments for students with significant cognitive disabilities.

What's Happening Now:

Assessment Results Timeline

- Now: TCAP and CoAlt reading, writing and mathematics score files available to districts (DACs gained access on July 14) on CTB navigator
- Aug. 8: TCAP and CoAlt reading, writing and mathematics hard copy reports arrive in districts from CTB
- Between Aug. 11 and 15: CO ACT reports arrive in districts
- Aug. 11: TCAP and CoAlt reading, writing and mathematics individual student reports may be shared with parents
- Aug. 14: Public release of state, district, and school level results for the TCAP and CoAlt reading, writing, and mathematics assessments at the state board of education meeting. Results may not be released, shared with the media, or presented in any public meeting until noon on Aug. 14. However, they may be shared with principals and teachers for improvement planning.
- Sept. 3: Score files for science and social studies available on PearsonAccess
- Sept 24: Hard copies of science and social studies individual student reports sent to districts from Pearson

CMAS Policy Level Performance Level Descriptors

Under the Colorado Academic Standards, expectation for student performance has transitioned from a focus on "proficiency" to a trajectory toward being "college and career ready" by the time of graduation. The new performance levels, beginning with this fall's CMAS are: Distinguished Command, Strong Command, Moderate Command and Limited Command. Below are the policy performance level descriptors for these levels. The state board will review content area and grade specific policy performance level descriptors at the August board meeting.

Moderate Command	Students performing at this level demonstrate a moderate command of the concepts, skills, and practices embodied by the Colorado Academic Standards for Science or Social Studies assessed at their grade level. They will likely need academic support to engage successfully in further studies in this content area.			
Limited Command	Students performing at this level demonstrate a limited command of the concepts, skills, and practices embodied by the Colorado Academic Standards for Science or Social Studies assessed at their grade level. They will likely need extensive academic support to engage successfully in further studies in this content area.			

CMAS Science and Social Studies Standard Setting Recommendations

Educators from across Colorado participated in standard setting for the science and social studies elementary and middle school assessments in July. Educators made recommendations for cut scores based on review of performance level descriptors, assessment items, student responses and data. Panel cut score recommendations will be presented to the state board on **Aug. 13**.

August State Board Meeting Assessment Items

Several assessment topics will be covered at the August state board meeting, including Spring 2014 TCAP results, cut scores for CMAS and CoAlt science and social studies and an assessment study session (WestEd Assessment study results).

CMAS Science and Social Studies Sample Items and Practice Testing Environment

Updated ePATs (practice testing environments) and practice guides for the science and social studies assessments are scheduled to be available by **Sept. 1**. The ePATs will help students navigate through the online testing environment and use the embedded supports on the day of testing. An ePAT for each grade level and content area is available at <u>www.pearsonaccess.com/co</u>. Districts are strongly encouraged to give students time to practice in the testing environment before actual testing.

What's on the Horizon:

H.B. 1202 Task Force to Study the Implications of the Statewide Assessment System

The first task force meeting to study the implications of the statewide assessment system was held July 15. The H.B. 1202 task force was established through legislation by the Colorado General Assembly to study the implications of the statewide assessment system for school districts, public schools, educators and students. A final report from the task force must be submitted to the legislature no later than **Jan. 31, 2015**.

The next meeting is scheduled for **Aug. 18** at Cherry Creek School District's Instruction Support Facility, 5416 S. Riviera Way, Centennial. All meetings are open to the public and will be held from 8:30 a.m. till 3:30 p.m. in the Denver metro area, location TBD. Upcoming meeting dates are: **Aug. 18, Sept. 15, Oct. 20, Nov. 17, Dec. 15** and **Jan. 12, 2015**. Accountability, Performance & Support

Overview:

CDE supports schools and districts in the continuous improvement process through its focus on implementing quality school and district support systems, accountability measures, improvement plans, federal programs and data analysis.

What's Happening Now:

ACCESS for ELLs Growth Data Available

ACCESS for ELLs Growth data are available for districts to download in CEDAR.

TCAP Growth and ACCESS Growth Data Release

Growth data for TCAP reading, writing, math and English Language Proficiency growth data from CEDAR is available to districts. The data in CEDAR are provided as flat files. TCAP growth data will be provided in the same file format as last year

(<u>http://www.schoolview.org/documents/Flat_File_layout_2012.docx</u>). By **Aug. 8**, districts will be able to access the School and District Summary Growth Reports (also known as the "Green and White" reports) in CEDAR.

Growth data is under embargo until the **Aug. 14** state board meeting. The embargo means that data may not be released, shared with the media or presented in any public meeting. However, data may be shared with school principals and teachers for school improvement planning. CDE will present the combined achievement and growth results from 2014. On that date, it is expected that the Colorado Growth Model visualization tool will be populated with 2014 data and available publicly. Additionally, the 2014 School and District Summary Growth reports are anticipated to be live in SchoolView.

By **Aug. 30**, CDE will send bundled Individual Student TCAP Growth Reports through the secure FTP site and notify DACs and superintendents of how to download their packages of reports. Achievement and growth results will be updated in Data Lab and Data Center in **September**. Questions related to the Colorado Growth Model data and reports should be referred to Dan Jorgensen at:

District and School Performance Frameworks

The department will release the preliminary 2014 District and School Performance Framework (DPF/SPF) reports to districts by **Aug. 18**. Reports are draft versions for district review; they are not public and are considered unofficial until adopted by the state board in December. Districts can access the reports in CEDAR using the instructions that will be e-mailed to districts on **Aug. 18**.

The 2014 DPFs and SPFs include three adjustments: (1) adequate growth percentiles will be used for English language proficiency growth, (2) CMAS science and social studies results will be used for participation calculations, but not achievement and (3) foreign exchange students are not included in the composite ACT scores. The state board reviews and approves applications for school designation as an alternative education campus (AEC) at the August meeting. The approved list will be published on the CDE website. Unified Improvement Planning Templates Posted

The 2014-15 district, school and AEC UIP templates and addenda forms are finalized and posted on the "Templates" page of the UIP website. There are minimal changes to the templates based upon feedback from the field and CDE's review of improvement plans this past year. Note that plans are designed to incorporate planning efforts for at least two school years, and be revised at least annually. The 2013-14 UIP should therefore incorporate the plans for the current 2014-15 school year, as well as future plans for the 2015-16 school year. All schools*, including new schools and alternative education campuses, are expected to complete/revise a UIP each year. * Through recently passed legislation (<u>H.B. 14-1204</u>) small, rural districts and schools (i.e., less than 1,200 students) that maintain a Performance plan type may submit their UIP biennially (every other year) to CDE for public posting.

More Time Given to Adjust to Educator Evaluation and Accountability System

In the 2014 legislative session, two pieces of legislation were passed to ensure fair implementation of the state's new educator evaluation system and allow for adjustments to the state's accountability system.

First, flexibility was passed for districts/BOCES regarding the 50 percent multiple measures of student learning (for teachers and principals) or student outcomes (for specialized service professionals) portion of the evaluation for the 2014-15 school year only. District flexibility comes in the final step of the evaluation process when determining how much weight the measures of student learning/outcomes standard counts in the educator's final evaluation rating. Districts can choose to weight that portion anywhere from 0 percent up to 50 percent for that one year. To learn more, visit: www.cde.state.co.us/educatoreffectiveness/sb14165factsheet.

Additionally, some adjustments were made to the state's accountability system to account for the transition from the reading, writing and mathematics Transitional Colorado Assessment Program (TCAP) assessments to the Colorado Measures of Academic Success (CMAS) in the spring of 2015. H.B. 14-1182 calls for 2015 school plan type assignments and district accreditation ratings to be based on:

- 2014 school plan type assignments and district accreditation ratings (2014 ratings will use elementary and middle level CMAS science and social studies results for participation only and not achievement.)
- 2015 assessment participation rates
- Accreditation assurances (for districts)
- Optional: 2014-15 student performance data (aligned with the Colorado Academic Standards) or postsecondary workforce data that districts may optionally submit through the request to reconsider process.

What's on the Horizon:

Accreditation Forms and Requests to Reconsider

Based on the preliminary DPF and SPF reports, districts must submit (1) the School Accreditation Form indicating the district and local school board's accreditation ratings for their schools, and (2) Requests to Reconsider for any district that wishes to appeal the district's accreditation rating or any of their school's plan type assignments, by **Oct. 15**. Districts are encouraged to notify CDE (<u>accountability@cde.state.co.us</u>) of their intent to submit a request to reconsider by **Sept. 15**, in order for CDE staff to provide adequate technical assistance. CDE is unable to provide any follow-up or clarification to requests received on or after **Oct. 15**.

CDE will send districts passwords for the School Accreditation form in late August. The form will be available online on the accountability webpage. **The form must be filled out online, printed, signed by the superintendent and school board president and scanned in to CDE by Oct. 15.** Visit the website for detailed policy guidance on the Accreditation and Request to Reconsider process, with samples of last year's form: <u>http://www.cde.state.co.us/Accountability/RequestToReconsider.asp</u>.

Unified Improvement Planning Pre-Populated Report

School and district pre-populated reports will be released to districts approximately two weeks after the release of the preliminary performance frameworks. The estimated date of release is **Sept. 1**. A link to access the documents (MS Word format) will be e-mailed to superintendents and accountability contacts. Once the online UIP system is ready for use, data will automatically be available in the pre-populated report for the selected school or district.

UIP Online System

The Online UIP System will be ready this fall. Schools and districts will be able to make updates to UIPs using this online platform. Training is being scheduled in early fall for districts interested in being early adopters. Users can track progress on a dashboard, submissions to CDE will be easier (no more Tracker), required addenda are automatically available, sections can be downloaded to Excel (e.g., action plan to sort by date), and language from the older plan can be populated into the current plan (after the first year of use). Update on the 2014 GED

An updated GED was introduced in January. Colorado uses the GED to issue High School Equivalency Diplomas, and with the 2014 GED aligned to more rigorous standards, earning this diploma is meant to reflect a student's readiness for postsecondary education and the workforce.

Since the beginning of the year, the number of testers and the pass rate has increased each month as testers, testing centers and preparation programs are becoming more familiar with the test. CDE's Postsecondary Readiness team continues to work with testing centers to ensure they have the information needed to support testers with the most current and accurate information to prepare students for the GED. Colorado GED Data:

- Colorado's pass rate (62%) is ten percentage points higher than the national rate (52%)
- Number of testers (individual people who have taken at least 1 test): 2,143
- Number of completers (individuals who have taken all 4 tests): **1,096**
- Number of passers (individuals who have taken AND passed all 4 tests): 683
- Individual test pass rates: Math **59%**, Reasoning through Language Arts **84%**, Science **81%** and Social Studies **77%**

Organizational Effectiveness

This month's Organizational Effectiveness update focuses on Data Pipeline.

Overview:

Rollover to the 2014-15 school year in Data Pipeline is taking place for certain interchanges and continues over the next few months. Local education agencies are also preparing for the Student October count.

What's Happening Now:

Special Education Discipline - This collection closes **Aug. 19**. Continue to submit interchange files and take related snapshots. Because districts submit the student data and administrative units create the snapshots, it is imperative for districts and administrative units to collaborate and communicate regarding this collection.

Teacher Student Data Link - This collection closes **Aug. 29**. If your district hasn't started, it's time to initiate interchange file submissions and snapshots.

Special Education End of Year - Files may be submitted and snapshots taken for this collection.

Student End of Year - Local education agencies are working toward an initial **Sept. 11** close. Continue to submit interchange files and take snapshots.

Math and Science Partnerships - This collection is open in the Automated Data Exchange system. It will move into the Pipeline next year.

RITS and EDIS - These two collections are always open. LEAs may submit for 2014-15 incoming student and staff identification numbers at any time.

Important Upcoming Deadlines:

- **Aug. 19:** Administrative units must generate a complete Special Education Discipline snapshot by passing all interchange and snapshot validations.
- Aug. 29: Teacher Student Data Link closes. All districts must have finalized TSDL snapshot data.
