# Standards

## Overview:

This year educators are taking a closer look at how high quality standards ensure students are prepared to succeed after high school graduation. The Teaching and Learning Unit offers schools and districts resources and support to enhance student learning and achievement.

## What's Happening Now:

Schools have been incorporating the Colorado Academic Standards into their lessons and instruction since 2010. In fact, the law called for the new standards to be fully implemented by the 2013-14 school year. However, given different schools' availability of resources to support that transition, CDE recognizes that not all schools are at the same level of implementation. Because the Colorado Academic Standards are the foundational element to making students fully prepared for college, a career and life after high school, and they're a key component of students being highly successful on any state test, CDE wants to support schools that want additional help incorporating the standards most effectively in your schools. #### **READ Act Rule Revisions**

English Learners and the READ Act: The department will initiate a rulemaking process at the Feb. 18-19 state board of education meeting to revise the READ Act rules. The rulemaking process is in response to a recent opinion (<a href="http://www.cde.state.co.us/coloradoliteracy/attorneygeneralsopinion">http://www.cde.state.co.us/coloradoliteracy/attorneygeneralsopinion</a>) by the Attorney General's Office to allow for use of Spanish assessments in the determination of a significant reading deficiency for students who receive literacy instruction in Spanish and English. Early Literacy Assessment Tool Project: The Office of Literacy has initiated an application process for the Early Literacy Assessment Tool project. The state's Early Literacy Assessment Tool project provides no cost reading assessment subscriptions for the DIBELS Next system and DIBELS Deep diagnostic reading assessments. These tools allow teachers to obtain real-time assessment of the reading skill levels of students in kindergarten through third-grade that garner immediate results and recommend activities based on those results. The project covers the cost of the online software license and training. Hardware is not included. Districts currently participating in the project as well as districts interested in participating for the 2015-16 school year must submit an application for the licenses. The deadline for continuing applicants is **Thursday, March 5 at 4 p.m.**, and the deadline for new applicants is **Tuesday, April 5 at 4 p.m**. Through the School Finance Act in 2012, CDE was authorized to purchase an early literacy assessment tool for the state through a competitive request for proposals process. The contract was awarded to Amplify in 2013 for its DIBELS Next System.

# **Assessments**

#### Overview:

Assessments administered by CDE include the Colorado Measures of Academic Success in English language arts, math, science and social studies; English language proficiency assessments, college/career ready assessments and alternate content assessments for students with significant cognitive disabilities.

## What's Happening Now:

## **State Board of Education Discusses Testing Waivers**

Schools are preparing to give the Colorado Measures of Academic Success (CMAS) tests this spring which were developed by PARCC in English and math. Like the state tests previous to CMAS, the CSAP and TCAP tests were singular tests in reading, writing, math and science. However, each of those tests were divided into multiple components. CMAS is constructed in the same way in that each test has two components — a performance-based component and an end-of-year component. The performance-based component is the part of the test which is given about three-quarters of the way through the year and allows students to demonstrate their knowledge of the standards. Likewise, the end-of-year test is given about 90 percent of the way through the year and shows educators and parents if students met the standards for that grade in that subject for the year.

Like CSAP and TCAP, students had to complete all components of the test to receive a valid score. The same is true of the CMAS tests. At its January meeting, the state board of education passed a motion to direct the commissioner to approve waivers for districts requesting it allowing them to waive out of administering the performance-based component of the English and math state tests. Advice from the Attorney General's Office indicates neither the state board nor the commissioner have the authority to grant such waivers. CDE received at least one waiver request as of the end of January. The state board will again discuss this matter at its February meeting (either Feb. 18 or 19). # **CMAS: PARCC English Language Arts and Math Materials**

Test materials are scheduled to arrive in districts two weeks prior to the scheduled start date.

# **Colorado Alternate Assessments (CoAlt)**

The Colorado alternate assessments (CoAlt) are administered in English language arts, math, science and social studies to students with significant cognitive disabilities who are instructed and assessed on alternate achievement standards. Similar to the move to the CMAS assessments for the general population, Colorado has transitioned to CoAlt for the new alternate assessments. Specific questions related to student eligibility qualifications for the CoAlt should be directed to the Exceptional Student Services Unit's Linda Lamirande (lamirande l@cde.state.co.us).

# Learn About Deadlines for CoAlt Math and English Language Arts, Developed by Dynamic Learning Maps (DLM)

Districts should enter users and students into the Educator Portal by **Feb. 22**. Districts that want CDE to upload preliminary student data into the portal should contact Jasmine Carey (<u>carey j@cde.state.co.us</u>) for details by **Feb. 9**. The CDE recommended window for the CoAlt test in English language arts and mathematics is from **April 13 – May 15**. However, given the number of new activities districts are undertaking this spring, districts may choose to assess outside of this window starting as early as **March 16**.

# CMAS and CoAlt: Science and Social Studies High School Standard Setting

Standard setting for high school science and social studies assessments is the week of **Feb. 16**. About 50 educators from across Colorado will participate in the standard setting process. Educators will review performance level descriptors, assessment items, student responses and data. The panels of educators will use this review to make performance standards recommendations that will be presented to the state board of education for approval in March.

# **Get Your Assessment Questions Answered, Attend CMAS Office Hours**

The Assessment Unit will host webinar-based office hours on Thursdays from 3 to 4 p.m. through May 28. Office hours provide an optional time for district assessment coordinators to ask questions related to the administration of CMAS: PARCC-developed English Language Arts and Math and CMAS: Science and Social Studies assessments to Assessment Unit staff. District assessment coordinators received detailed information via email about accessing office hours.

# Input on School and District Performance Frameworks 2.0

Last spring, 113 districts participated in the annual UIP/Accountability Needs Assessment. Last year's survey focused on the measures, metrics and design of the school and district performance frameworks to get input for the release of the next iteration of frameworks in 2016. The Center for Assessment analyzed the results and conducted additional focus group conversations for CDE. The Center released a report summarizing the results and recommending next steps. #### **Accountability Work Group**

The first convening of the Accountability Work Group occurred Jan. 13. This stakeholder group, consisting of regional superintendent representatives, school and district leadership, CASE, CASB and CEA leaders will make recommendations to CDE on how to enhance the School and District Performance Frameworks for 2016. At the first meeting, the group set norms, learned about each other's experiences, reviewed artifacts from previous accountability systems and began conversations around the purpose of school and district accountability in Colorado. # **Organizational Effectiveness**

This month's Organizational Effectiveness update focuses on **Data Pipeline**.

# **Overview:**

Data Pipeline is a streamlined approach to efficiently move required education information from school districts to the Colorado Department of Education. Data Pipeline reduces data redundancy, captures closer to real-time data, streamlines the data collection process and allows districts to exchange information on transferred students.

# What's Happening Now:

## **Data Pipeline Status**

Despite a number of enhancements made to the Data Pipeline infrastructure over the past year, the system is not operating as efficiently as necessary. The majority of the issues are related to the reporting tool that is integrated within the Data Pipeline application. To address these issues, CDE is embarking on a major database upgrade over the next several months that will provide additional processing power, more storage and faster speeds, thereby reducing the delays users are experiencing. At the same time, CDE staff continue to trouble shoot overall issues with the reporting tool and rewrite code as necessary to solve specific issues. Additionally, a user group is being convened to help prioritize issues and solicit new ideas for Data Pipeline enhancements.
