Colorado is implementing significant education improvements aimed at ensuring all students graduate college- and career-ready. While much research and discussion has gone into the policy development, we're now putting those policies into action. Here's a brief snapshot of implementation milestones, deadlines, supports available and a look of what to expect ahead.

Elliott Asp Appointed Interim Commissioner

The state board of education appointed Elliott Asp, Ph.D., formerly the special assistant to the commissioner, as interim commissioner effective July 1. Asp replaced Commissioner Robert Hammond who retired at the end of June.

Educator Effectiveness

Overview:

Classroom teaching and school leadership are the strongest school-based factors impacting student achievement. CDE supports the state's 178 school districts to attract, prepare and support great educators as a part of meeting the requirements of S.B.10-191, the Great Teachers and Leaders Act.

Grant Available to Vendors for Recruiting and Supporting Teachers

The Quality Teacher Recruitment Program grant provides funding to assist Colorado districts and BOCES recruit and retain highly qualified teachers in areas of the state that have difficulty with recruitment and retention.

A total of \$2.94 million is available for one or more applicants. Funding may be applied to program costs for the 2015-16 and 2016-17 school years. Vendors applying for the grant must have a documented history of recruiting, training and retaining highly qualified teachers and must demonstrate that teachers it has placed achieve high academic growth from their students. Additionally, applicants must secure no less than 100 percent matching funds for all grant funding awarded. Applications are due on **Sept. 16**. To make the necessary updates to the Colorado State Model Performance Management System (COPMS or RANDA) for the new academic year, a system downtime is planned from **June 26 – July 19**. COPMS users should wait until **June 26** to begin updating staff roles and assignments in Identity Management. Staff updates made after **June 26** will be reflected when the COPMS is activated for 2015/16. This includes changing buildings, positions and adding or removing users to the system for 2015-16. If you make these changes prior to June 26, it may impact the reports as well as assign unintended rubrics/evaluations. Detailed instructions have been sent to districts and BOCES through the system. As districts/BOCES/charter schools prepare for the new year, please request educator identifications (EDIDs) for new employees as soon as possible. Standards

Overview:

What's Happening Now:

Early Learning and School Readiness

Attend a School Readiness Summer Training Opportunity

CDE continues to host summer training events for each of the school readiness assessments. No-cost trainings are offered for teachers and principals across the state throughout the summer in Teaching Strategies GOLD, the most widely adopted assessment tool. Trainings for REAL and DRDP, the other two school readiness assessment tools, are being arranged with the districts that have adopted these tools. Changes to Required Kindergarten Assessments in H.B. 15-1323

H.B. 15-1323 institutes minor changes to school readiness and READ Act assessment requirements at the kindergarten level and for students who test at the proficient level in reading. The law provides a 60-day window at the beginning of the school year for districts to complete the first checkpoint of the school readiness assessment. Regarding the READ Act, at the kindergarten level, each district must administer an approved reading interim assessment to kindergarteners in the first 90 days of the school year. If a district administers the READ Act assessment in the first 60 days of the school year, it is not required to administer the literacy component of the school readiness assessment.

For students identified with a significant reading deficiency, the teacher must administer a diagnostic assessment to the student within 60 days of the previous assessment to determine the student's specific reading skill deficiencies. Furthermore, if a kindergarten student is identified as having a significant reading deficiency, the district will include the student's READ plan as a component of the student's school readiness plan, which is consistent with the READ Act and with past CDE's guidance.

Districts are not required to administer READ Act interim assessments for students demonstrating reading competency for their grade level throughout the remainder of the specific school year. CDE will work over the summer with assessment providers of the approved READ Act assessments to identify cut scores for grade level reading competency to help guide districts in making a decision about whether a student is demonstrating reading competency for his/her grade level. The department anticipates having guidance to the districts by late summer.

The READ Act

READ Collection and Fund Distribution

In July, districts will receive information about the READ Act per pupil fund distribution for the 2015-16 school year, including the amount the district will receive and details on when the distribution is anticipated to occur. The allowable uses for the per-pupil intervention money for students with significant reading deficiencies include: (1) providing full-day kindergarten; (2) purchasing tutoring services in reading; (3) providing other targeted, scientifically or evidence-based intervention services; or (4) operating a summer school literacy program. The Rural Flexibility bill (H.B. 14-1204, created an additional allowable use of READ funds for small rural districts to purchase the services of a literacy specialist from a BOCES to provide professional development in literacy or other supports for

implementation of the READ Act.

Assessments

Overview:

Assessments administered by the unit include summative content assessments, English language proficiency assessments, college/career ready assessments and alternate content assessments for students with significant cognitive disabilities.

The Colorado Measures of Academic Success are the new state tests in English language arts, math, science and social studies that were given to Colorado students in the 2014-15 academic year. The science and social studies tests were developed just for Colorado students, while the math and English language arts tests were developed in collaboration with other states through the Partnership for Assessment of Readiness for Colleges and Careers (PARCC).

What's Happening Now:

CMAS: Science and Social Studies District and Student Results

CMAS/CoAlt elementary and middle school science and social studies paper individual student performance reports are scheduled to arrive in districts in mid-July. Student level and summary data files and reports are currently available in PearsonAccess. CMAS: PARCC Scores to be Released in Fall

CDE expects PARCC to release scores for the English language arts and math tests in October for high school students and in November for middle and elementary students. As with any new test, the scores in the first year are taking longer to produce because performance level setting must take place. Performance levels will help students, parents, teachers and policymakers understand how students are performing against the content standards for college and career readiness. PARCC is convening educators and content area experts from each participating state to set performance levels in Denver in late July and August. CMAS: PARCC English Language Arts and Math PearsonAccess^{next} Activities

Final updates in PearsonAccess^{next} must be made by **July 8**. Rejected Student Test alerts appear in PearsonAccess^{next} if a student's information from the paper book does not match the student's information in PearsonAccess^{next}. Rejected Student Test alerts for EOY records must be resolved in PearsonAccess^{next} because records that have not been resolved **will not be scored**. Districts should also complete any not tested and/or void coding for the EOY by **July 8**.

CMAS: PARCC English Language Arts and Math Data Clean-Up

Districts will have the opportunity to review their EOY records and complete the Student Biographical Data Review (SBD) through Data Pipeline from **July 17 - July 29**. CDE is working with Pearson to investigate the possibility of an extension. SBD data collections are not mandatory. Changes that districts have historically made through SBD may be made in PearsonAccess^{next} through **July 8**.

A merged summative record file will be available for district review in Data Pipeline through a Cognos report from **Aug. 13 – Aug. 19**. This will be an opportunity to verify that PBA and EOY records have been merged correctly. Specific information about how districts may access and use this file will be sent to district assessment coordinators and data respondents later this summer. This step in the process will only occur this year. Given PARCC's decision to move to a single window, merging will not be required next year. What's on the Horizon:

College Preparatory/Entrance Assessments in Grades 10 and 11

House Bill 15-1323 included provisions to eliminate 11th and 12th-grade PARCC tests and replace 10th-grade PARCC tests with a college-preparatory exam. According to the legislation, students in 11th-grade will continue to take a college entrance exam. The new 10th-grade college-preparatory exam and the 11th-grade college entrance exam will be procured through a competitive request for proposal (RFP) process this summer. CDE does not know which college entrance exam and its associated 10th-grade exam will be selected for 2015-16 until that process is complete. Test date selection and ordering processes will be included as part of contract negotiations for the exam selected. CDE will communicate that information to districts when it's available. Spring 2016 Testing Windows

PARCC recently announced that the PBA and EOY windows will be combined into a single window next year. The consortium deadline for completing paper testing is **April 29, 2016**. To test as close to the end of the year as possible, Colorado's testing window for all spring 2016 CMAS assessments is **April 11-29**. The three week window allows districts to complete testing for all of CMAS, including science, social studies, English language arts and math if they are able to have single groups for each session. Colorado will move to a sampling approach for social studies, with one-third of schools participating next year. All social studies and science tests must be scheduled and completed between **April 11-29**, but districts needing more time to complete their ELA and math testing due to device numbers (i.e., the number of computers available will require multiple groups for each test unit) may begin testing those content areas earlier. The maximum test window will be six weeks. Six weeks allows schools that need three groups per unit to complete testing. Please see below for the 2016 assessment windows.

Overview:

CDE supports schools and districts in the continuous improvement process through its focus on implementing quality school and district support systems, accountability measures, improvement plans, federal programs and data analysis.

What's Happening Now:

Accountability, UIP Tracker and Family Partnership Contacts

Superintendents are asked to confirm and update (if necessary) district accountability, UIP Tracker and family partnership contact information for the upcoming school year. A survey link that allows districts to update all three contacts will be sent via email in **July**. CDE's primary means of communication around accountability work is through the accountability contacts. The tracker contact receives improvement planning-related communications and will also be responsible for submitting improvement plans to CDE. The family partnership contact receives and shares information about resources and support from CDE about family-school-community partnerships for student learning.

Accountability Work Group Discusses Future Options

The Accountability Work Group held its seventh meeting on June 15, where the focus was on the design work group's recommendations. Based on the purpose statement and work of the smaller group, the Accountability Work Group provided feedback on the initial design recommendations for the frameworks. In the afternoon, small work groups met individually to continue researching and discussing various recommendations in the areas of growth/improvement; equity/disaggregation; communication and purpose; design, post-secondary and workforce readiness; and accountability pilot.

A summary of the initial recommendations for changes to the performance frameworks will be shared at the CASE Education Leadership Convention this summer. Additionally, the Accountability Work Group will share recommendations and ask for feedback around the state at regional superintendent and other stakeholder meetings this fall. Reminder: Accountability Impacts of New Legislation

The 2015 district accreditation ratings and school plan types (based on data from the 2014-15 school year), will not be calculated or assigned. Schools and districts will continue to implement their official 2014 rating in the 2015-16 school year. Additionally, the accountability clock will not move forward on July 1, 2016. When district accreditation ratings and school plan types are again assigned in fall 2016, the accountability clock will continue to advance on July 1, 2017, as a consecutive year.

Postsecondary Readiness

Overview:

CDE supports the various ways students can enter postsecondary education by working with districts and schools in thinking through the personalization of a pathway through high school and on to college and career for every student.

What's Happening Now:

Graduation Guidelines Menu of Options (Menu of Career and College Ready Demonstrations)
Adopted by the State Board of Education in May 2013 still in effect

The state board of education did not take action at the May 2015 meeting to update the of career and college demonstrations. These guidelines are in law, which directs districts to engage employers, community leaders, students and families in conversations about local graduation requirements, and how they reflect the values and priorities of each school community. In 2016-2017, school boards should adopt local graduation requirements that align with the state graduation guidelines in order to meet the goal that these graduation expectations are updated for the class of 2021. This summer, based on the work of hundreds of business and educational leaders, CDE will publish an addendum to the engagement toolkit that further defines each item on the menu, including capstone projects and industry certificates. Concurrent Enrollment Annual Report

In collaboration with the Department of Higher Education, CDE released the Annual Report on Concurrent Enrollment in May with new data highlighting the enrollment and outcomes of Concurrent Enrollment students in the 2013-2014 school year. Highlights include:

- Concurrent Enrollment and ASCENT continue to see sustained increases in participation, up 15 percent and 43 percent, respectively.
- Nearly half of students who participated in ASCENT in 2013-2014 were Hispanic, a minority group that is historically underrepresented in postsecondary education.
- Statewide, 94 percent of districts and 80 percent of high schools offer concurrent enrollment programs.
- The majority of students 89 percent passed all of their concurrent enrollment courses (up from 84 percent in the previous year).
- Over 950 students in concurrent enrollment or ASCENT programs earned some type of postsecondary credential in 2013-2014.
- Students who participated in dual enrollment programs in high school had higher firstyear credit hour accumulation, grade point averages and retention rates in college.

Special Education Discipline

By **Aug.18**, administrative units must have generated your complete Special Education Discipline Snapshot dataset by passing all interchange and snapshot validations in preparation for report review.

Teacher Student Data Link

Both the interchange and snapshot are open until Aug. 28.

End of Year

Districts must submit 2014-2015 Student End-of-Year snapshots to CDE by Sept. 10.

Math Science Partnership

This collection will be conducted through the Automated Data Exchange one last time for the 2014-15 school year. The collection is due **Sept. 30**.

Special Education End of Year

The snapshot remains open until **Oct. 13**. Exit information changes and all other change should be identified and fixed by the interim date of **Sept. 18**. Administrative unit should also create complete error-free Special Education EOY snapshots.
