Colorado is implementing significant education improvements aimed at ensuring all students graduate college- and career-ready. While much research and discussion have gone into the policy development, we're now putting those policies into action. Here's a brief snapshot of implementation milestones, deadlines, supports available and a look of what to expect ahead.

Educator Effectiveness

Overview

Classroom teaching and school leadership are the strongest school-based factors impacting student achievement. CDE supports the state's 178 school districts to attract, prepare and support great educators as a part of meeting the requirements of S.B.10-191, the Great Teachers and Leaders Act, now codified as C.R.S. 22-9-101 et. seq.

What's Happening Now:

Educator Effectiveness Leaders Take On New Roles at CDE

Two members of the EE unit, Katy Anthes and Toby King, have recently taken on some additional roles in the department. Katy and Toby are still engaged in the Educator Effectiveness Unit's work while also helping with some additional needs at the Department. Katy Anthes is now the chief of staff while Toby King is serving as the interim executive director of the Exceptional Student Services Unit. An entire team at the Educator Effectiveness Unit is still available and excited to continue to support the improvement and implementation of educator evaluation.

Every Student Succeeds Act (ESSA) Does Not Impact Educator Evaluations

While the Every Student Succeeds Act (ESSA), provides flexibility for assessments and other areas of Colorado's accountability system, it does not include requirements for educator evaluations. State law, C.R.S. 22-9-101 et. seq., will continue to govern Colorado's educator evaluation system.

Early Learning and School Readiness

Memorandum of Understanding with Teaching Strategies: Districts using the Teaching Strategies GOLD assessment as their kindergarten readiness assessment recently received information about a memorandum of understanding (MOU) entered into between the publisher and the Colorado Department of Education. The READ Act Interim Assessment Required by July 2016

The READ Act requires use of a state board-approved interim reading assessment to determine whether a student has a significant reading deficiency in grades K through 3. Since its passage in 2013, districts have been able to use the interim assessments allowed under The Colorado Basic Literacy Act (CBLA) in addition to the READ Act approved assessments. However, because the READ Act repealed the CBLA, districts have until **July 1, 2016** to transition to using only those interim assessments approved by the state board under the READ Act. Apply for an Early Literacy Grant

Through the READ Act, CDE is able to support a \$4 million grant program to distribute funds to local education providers, including school districts, BOCES, and district charter schools or Institute Charter

Schools, to support a comprehensive, school-wide literacy model for K - 3. The new round of the Early Literacy Grant application process opened in January. All school districts are eligible to apply, and districts may apply on behalf of one or more of their elementary sites. Letters of Intent to Submit are due **Feb. 5, 2016**. Applications Available for the Early Literacy Assessment Tool Project

The Office of Literacy has initiated an application process for the Early Literacy Assessment Tool (ELAT) project. Colorado's ELAT project provides no-cost reading assessment subscriptions for the *DIBELS Next* system and *Burst* diagnostic reading assessments. The tools allow teachers to engage in real-time assessment of the reading skill levels of students in kindergarten through third-grade that provides immediate results and recommended activities based on those results. The project covers the cost of the online software license and training. Hardware is not included. Districts currently participating in the project as well as districts interested in participating for the 2016-17 school year must submit an application for the licenses. For districts wishing to continue their participation, applications are due **March 3, 2016**. For districts applying for first time, participation applications are due **April 15, 2016**. READ Act Rules to be Re-Noticed by State Board of Education

At the January State Board of Education meeting, the board voted to re-notice the rulemaking process for the Colorado READ Act. The originally proposed rules are necessary to bring the READ Act into alignment with HB 15-1323. The board indicated that further discussion of the rules beyond the proposed changes are needed and will address additional considerations at the Feb. meeting. Assessments

Overview:

Assessments administered by CDE include summative content assessments, English language proficiency assessments, college/career ready assessments and alternate content assessments for students with significant cognitive disabilities.

The Colorado Measures of Academic Success (CMAS) are the state tests in English language arts, math, science and social studies that will be given to Colorado students in the 2016-17 academic year. The science and social studies tests were developed for Colorado students, while the math and

English language arts tests were developed in collaboration with other states through the Partnership for Assessment of Readiness for Colleges and Careers (PARCC).

In 2016, Colorado will also administer the PSAT to 10th-graders and the ACT to 11th-graders.

What's Happening Now

ACCESS for ELLs 2016 Administration

The ACCESS for ELLs testing window closes on **Feb. 12, 2016**.

CDE and College Board Provide Support for Transition to PSAT

To help 10th-grade students prepare to take the PSAT 10 this April, CDE is working with the College Board to provide information and resources to support educators, students and families. Next year, these students will take the SAT as 11th-grade students. Remember, this year's 11th-grade students will take the ACT as part of the department's plan for a one-year transition to the SAT. These changes were precipitated by legislation passed last spring and the required competitive selection process for Colorado's 10th-grade and 11th-grade exams.

As required by the new law, the PSAT is aligned with the Colorado Academic Standards. The assessment focuses on what students are already learning in classrooms across the state.

During the transition to the new assessment, CDE will be working with the College Board to make available information, resources and practice materials to prepare educators and students for the PSAT 10 this spring and the SAT next year. In the coming weeks, the College Board will launch a website dedicated to the Colorado partnership that will contain key information and link to detailed information about the **PSAT 10** (<https://collegereadiness.collegeboard.org/psat-nmsqt-psat-10/inside-the-test>). Additional information on SAT will be added later this spring.

CDE and the College Board want students to benefit from the opportunities connected with these assessments, including the free, interactive test practice through Khan Academy, college application fee waivers, and expanded scholarships.

Colorado PSAT and Colorado ACT

In January, District Assessment Coordinators (DACs) received initial information about the spring 2016 administration of the Colorado PSAT for 10th-graders and the Colorado ACT for 11th-graders. As districts prepare for the transition to the Colorado SAT in spring 2017, the following information about concordance tables and higher education acceptance of scores may be helpful.

Concordance Tables to be Developed:

CDE is aware of the historical college entrance assessment data that districts have and their desire to continue using that trend data. CDE will work with the vendors to explore updating concordance tables to facilitate that process. (ACT and SAT collaboratively developed concordance tables for the old SAT and ACT. This summer, College Board will be developing similar tables for the old SAT and revised SAT.)

Higher Education Acceptance of SAT Scores:

H.B. 15-1323 requires the selected college entrance exam be "administered throughout the United States and relied upon by institutions of higher education" (C.R.S. 22-7-1006.3). The SAT meets this requirement. Colorado public colleges and universities accept both the ACT and the SAT for admission and scholarship consideration.

February/March Preparation Activities for Spring 2016 CMAS Administration

Technology Preparation:

District technology coordinators should engage in technology preparation activities with local technology coordinators and district assessment coordinators to ensure that technology environments are ready for testing.

Administration Preparation:

District and school personnel can begin to set up CMAS test sessions in PearsonAccess^{next} on **Feb. 1, 2016**. This activity should be completed before students begin testing. Districts and schools can also complete the following activities in Feb.:

- Assign computer-based special forms (e.g., accommodations and accessibility features)
 - After indicating all computer-based special form assignments, begin creating test sessions in PearsonAccess^{next}
- Register new students and remove registrations or approve transfer work requests for students who have withdrawn from the district
- Train district and school staff who will be involved in spring assessment administration. Security Agreement forms and the Verification of District Training form should be signed and collected after training

What's on the Horizon:

ACCESS for ELLs Student Biographical Data

The ACCESS for ELLs Student Biographical Data Review (SBD) window is **March 14-25, 2016**. During the SBD window, districts will have the opportunity to download, review, and update demographic information associated with the 2016 ACCESS administration. Local Access Managers (LAMS) must use the "ACC" collection identifier to assign district access for this collection. This is not a mandatory data collection.

CMAS ELA Field Test

For schools selected to participate in the ELA field test, the ELA test will include four rather than three units at participating grade levels. For selected grade levels, schools participating in the field test should schedule an additional 90 minutes (grades 3-5) or an additional 110 minutes (grades 6-9) beyond the time scheduled for non-field test schools. CDE realizes that adding any amount of testing time will be challenging for some schools; however, Colorado's participation in the field test is incredibly important. When talking with staff and parents about the importance of participating in field testing, please consider the following:

- Field testing is critical to the assessment process. It allows new items to be added to the assessment each year and contributes to the rich item bank that supports the ongoing release of publically available items each year.
- Constructed response items can be scored more quickly, efficiently, and reliably after test administration because field testing allows scorer training and the establishment of score ranges and response expectations for each item to occur in advance of testing.
- Field testing allows item performance to be examined before an item can be used operationally. Specifically, field test data is used to determine whether or not an item is suitable for future use. Colorado's participation in the field test is an important way of including Colorado student responses in item performance analyses, and that the newly developed items work well for Colorado students.

Keep in mind that schools selected to participate in the ELA field test were not selected to participate in social studies testing. Participation in either social studies testing or ELA field testing, but not both, should help to balance testing time and burden across schools.

³Districts needing more time to complete their ELA and math testing due to device numbers (i.e., the number of computers available will require multiple groups for each test unit) may begin testing ELA and math earlier. The maximum testing window will be six weeks.

UIP Winter Review Process

In February, CDE will complete its review of the over 200 Unified Improvement Plans from the districts and schools required to submit their plans. This includes any school or district with a Priority Improvement or Turnaround plan type on the 2014 School or District Performance Frameworks (SPF or DPF). CDE reviews the plans using the Unified Improvement Plan (UIP) Quality Criteria, posted here:

Feedback based on the UIP Quality Criteria (including program specific requirements) will be provided to districts and schools upon the completion of the reviews. The Quality Criteria are posted online in Word format for the convenience of planning teams that may wish to use them for their own internal reviews.

Unified Improvement Planning Submission Dates

Every district and school must submit a revised/updated UIP by **April 15, 2016** (note: small, rural districts and schools with a Performance plan type may submit plans biennially). For more information, visit the CDE website here:

Organizational Effectiveness

*This month's Organizational Effectiveness update focuses on **Data Pipeline**.*

Overview:

Data Pipeline is a streamlined approach to efficiently move required education information from school districts to the Colorado Department of Education (CDE). Data Pipeline reduces data

redundancy, captures closer to real-time data, streamlines the data collection process and allows districts to exchange information on transferred students.

What's Happening Now:

Dynamic Learning Maps (DLM)

Local education agencies may make changes up until **March 7**. Any changes after this date will need to be handled through DLM directly.

Human Resources

By **Feb. 11**, all local education agencies are required to have their snapshot error free and finalized. Human Resources will close and the final report must be signed and submitted.

December Count

Administrative Units must resolve duplicates in the Special Education December Count Snapshot submission by **Feb. 9**. The Special Education December Count will be closed and all final reports must be signed and submitted by **Feb. 11**.

Directory

The 2016-17 four-day school week collection will remain open until **May 13**.

Local education agencies (LEAs) that will have school code changes in the 2016-17 school year may submit requests. These include new and closing schools, school name changes as well as grade range changes. Schools that change LEAs should utilize the new school code request.

Statewide Standard Course Codes

Webinar trainings will be conducted **Feb. 10, 16 and 18**. Course codes must be entered by **March 24**.

Teacher Student Data Link (TSDL)

The TSDL interchange is open. The target dates are to have one TSDL interchange file submitted by **March 11, 2016** and both interchange files submitted by **March 25, 2016**. As a reminder, the Statewide Standard Course Codes must be up-to-date prior to submitting an interchange file.

End of Year

At the request of districts, 2015-16 snapshots may be taken beginning **Feb. 1, 2016**; however, all edits will not be updated and finalized until **May 5**.
