## **Centennial State Libraries Changes Format**

The Colorado State Library regretfully announces that the monthly, online newsletter, *Centennial State Libraries*, is changing its format. For many years, the print version of the newsletter spotlighted important library issues as well as the activities of CSL. In January 2000, the periodical became an online publication only. Now declining resources, along with the new approach to information created by the extensive use of the Internet, mandate another change.

To provide timely resources and announcements, *Centennial State Libraries* will begin as a weekly, online bulletin, primarily containing brief news items and links to other sites or contacts. We wish to thank the readers of *Centennial State Libraries* for their interest over the years. In addition, many kudos to the talented and dedicated editors who put their skills, and oftentimes their spirits, into writing, production, and distribution of the newsletter. We hope the change enhances our services to the library community.

## **ACLIN Dial-up Numbers Change**

Qwest is in the process of discontinuing all current ACLIN dial-up numbers, and ACLIN expects all old numbers will be shut down by March 1, 2001.

ACLIN has instituted a statewide number, **1-800-748-0888**, through another company. This dial-up is free, has an automatic, 30-minute time limit, and allows text-only access to ACLIN and the Colorado Virtual Library. These services are identical to the old dial-up numbers. The new number is statewide, and can be used from anywhere in Colorado. Individuals attempting to use the number from outside the state will be automatically denied access.

Libraries still using dial-up should alert staff and patrons to the change and encourage users to switch to the new 1-800 number immediately.

The Colorado Virtual Library and ACLIN are optimized to provide access to the wealth of library resources of Colorado, particularly digital images and Web-based resources. Because of technological advances, clients may wish to investigate graphical access to the Web and not rely on text-only access. Telecommunications companies may stop providing text-only dial-up access in this rapidly changing environment.

## From the State Library

The American Library Association held its mid-winter conference in Washington, DC, just a few days before the inauguration of George W. Bush as our president. Most of the conference was held in the Washington Convention Center where, three days later, the Texas/Wyoming Inaugural Bash was held. The whole city was gearing up for the festivities with flags and seals and even buttons ("I celebrated the Inaugural at O'Brien's Bar and Grill"). Our last day there, a swarm of high school kids and their teachers invaded our lower priced hotels to participate in an Inaugural learning experience. It was hard for either Democrats or Republicans to ignore the excitement.

But I was there for ALA and left town as the horde of celebrators arrived. ALA was exciting enough. I was involved in deliberations around five major issues:

Reauthorization of LSTA E-rate update A new E-book task force UCITA The new Children's Internet Protection Act

LSTA is up for reauthorization after five years. I am part of a coalition composed of Chief Officers of State Library Agencies (COSLA), which I represent; all the divisions of the American Library Association; the ALA Washington Office; regional bibliographic networks (like BCR); the National Commission on Libraries and Information Science (there as observers); the National Indian Library Association (represented by our own Elaine Walsteadter from Ft. Lewis College); and the Association of Research Libraries. Whew! It's a big group. The purpose is to gain consensus among the library community before we go to Congress to lobby for reauthorization of the law.

After much discussion, the group came to agreement on the following:

- No basic changes in the law, only minor rewriting for clarity.
- An increase in administrative costs to allow an annual evaluation of one theme of particular interest to Congress.
- A doubling of the base grant to states which will increase the allocation to Colorado.
- An increase in the request from \$150 million to \$500 million.

We prepared a resolution that was adopted by the group and by the ALA Council. As soon as it's available online we will put a link to it.

I continue to chair the E-rate Task Force. Each conference we meet with Kate Moore, Director of the Schools and Libraries Division, that administers the E-rate. The E-rate may be bureaucratic, complicated, and frustrating, but the staff that administer it in Washington are friendly and helpful. Linda Schatz, who handles customer service, gave an update of what we had asked be changed in Year 4 and what they were actually able to change. John Noran was there, too, of course, and it was good to see him again. We will mount the document Linda prepared as soon as we can get it; and you can see the changes for yourself. They shared some really good news with us:

- They are seriously working on electronic signatures.
- They are finally going to work on a true EZ form.

I was also appointed to a new E-book Task Force. ALA finally decided they should get ahead of the curve on E-books. Of course, most others are already far ahead, so we are really playing catch-up. The group identified its purpose to:

- Educate librarians;
- Join committees outside ALA working on E-book issues;
- Participate in conferences on E-books;
- Communicate with librarians about E-book issues and developments;
- Form business partnerships as appropriate.

ALA has joined the Open E-Book Forum and attended the first meetings here in Denver. Task Force members who attended reported that the E-book vendors were delighted with the participation of librarians in the deliberations. Librarians have the respect of vendors for their experience and knowledge in the E-book arena.

Immediate activity of the Task Force includes:

- Establishing a Web-page on E-books for librarians;
- Developing an E-book display area (much like the first Internet show-room) where librarians can
  experiment with all the E-book products, both hardware and software;
- Developing a set of "requirements," the librarians' opinion about the ideal E-book environment for librarians.

UCITA stands for the Uniform Computer Information Transaction Act. If you haven't heard about it by now, you will. This is a nationally proposed law that would standardize contracts about computer transactions – actually all the software you purchase. Many, many groups oppose this law including all library groups. To date, UCITA has not been introduced in Colorado. There were extensive discussions about the shortcomings of this law, why librarians should oppose it, and how we might accomplish this. I've now been to two training sessions and will be meeting with representatives of the Colorado Association of Law Librarians to talk more about it.

But the topic that dominated the conference was the Children's Internet Protection Act (CIPA). The ALA Washington Office's regular Saturday morning update was standing-room-only as a regulatory attorney hired by ALA attempted to explain and interpret the law. Also on the program were Kate Moore from the E-rate SLD and Jane Heiser from the Institute of Museum and Library Services that administers LSTA. Both tried to explain how their respective agencies would handle the requirement to issue rules on the implementation of CIPA. The bill is enormously complex with slightly different implementation requirements for E-rate, LSTA, and the Technology Challenge Grants from the Department of Education. The governing program is the E-rate. If your library is eligible for and applies for the E-rate, you must comply with the law or forgo your E-rate discount. If you don't apply for E-rate but do apply for LSTA for a grant that provides a modem-equipped computer or Internet access, you must also comply with CIPA. There were loads of questions about nuances in the law and few answers. The biggest questions have to do with the impact of the law on networks and consortia, particularly those who don't have computers for the public. ALA has created a Web site specifically for information about the new law, http://www.ala.org/cipa. It will

have interpretive information, timelines, definitions, and a Q & A. By the end of the conference, the ALA Executive Board had voted for ALA to take the lead in a lawsuit to challenge the law. They do not expect the challenge to be decided prior to the deadline for compliance for libraries that choose to accept federal funds covered by the law.

ALA had its usual number of meetings, exhibits, parties, and general people-networking. Our professional association represents us well.
