## **Tax Time Services at Colorado Libraries**

Libraries vary in their services for people preparing tax returns. A good initial place to look is the University of Colorado Health Sciences Center's Denison Memorial Library's tax info page: <u>http://denison.uchsc.edu/QOM/taxes.html</u>. This summarizes online resources accessible from virtually anywhere.

Years ago, many public libraries stock hundreds of forms. This no longer is the case. Assistance often is via the Internet with printed copies from that source. Continuing to offer hard-copy copies of at least the most popular forms are:

Be sure to call if referring people because not all sites or branches have all forms. More tax assistance comes from volunteers, the Internal Revenue Service (IRS) Volunteer Income Tax Assistance (VITA) program, in partnership with the American Association of Retired Persons (AARP) TAX-AIDE program. Many library patrons may be eligible to have their federal and State of Colorado tax returns completed free of charge by trained IRS and AARP volunteers at the area sites enclosed. For sites outside the State of Colorado, please contact the IRS at 1-800-829-1040.

VITA and TAX-AIDE sites prepare basic tax returns free of charge for individuals and families with limited income, those who speak English as a second language, individuals who are disabled or handicapped, and senior citizens. Many of our sites do not require appointments, offer free e-file, and provide translators for those who do not speak English. This service is for basic tax return preparation only. Please check the site listing carefully to determine what services are offered in your area.

Many low-income individuals and families qualify for the Earned Income Tax Credit (EITC) and Child Tax Credit (CTC). These credits help working individuals/families reduce any tax owed and also may be refunded if there is no tax obligation on the return. The EITC is offered on the federal return only (the State of Colorado no longer offers this credit). Qualified individuals may receive as much as \$4204 from the federal EITC. The Child Tax Credit is also offered on the federal return only (the State of Colorado no longer offers this credit). In partnership with The Piton Foundation and Channel 7News in Denver, a hotline has been established to help qualify individuals for all of these credits, determine if they are eligible for free tax services, and refer them to free tax site locations that can assist them with the completion of their return. This hotline will open after January 17, 2004. Call (303) 83-CALL7 for additional information. Individuals may also call 1-800-829-1040 for general IRS tax information.

Jamie LaRue, director of Douglas County Libraries, says, "Yes, we will be distributing tax forms again this year. A survey from about two years ago showed that for some citizens, this was the ONLY service visit they made to the library."

The Colorado Blue Spruce Young Adult Book Award recognizes the most popular books among middle and high school students in the state of Colorado. Teens nominate their favorite titles and select the winner - adults do not vote. The deadline for Blue Spruce voting this year is February 1 (or Monday February 2 if you do not work weekends). #### **Comments Due for National Ed-Tech Plan**

Time is running out to comment on national ed-tech plan. The U.S. Department of Education invites educators to visit the web site of the National Education Technology Plan and contribute your ideas. Comments are due by March 12. In the new Participate section of the site, users can provide comments on nine different themes, including technology and teacher quality, special education, and leadership; upload files such as reports, articles, and presentations; contribute to a blog; and more.
