State Library notified of budget cuts in 2001-2002

Late the week of October 19, the State Library was informed that Colorado's economic situation required all state government programs to be reduced. While the official announcement seemed to exempt education, this turned out not be true. We took cuts along with everybody else.

For the year 2001-2002, the year we are now in, we were asked to take a 1% cut on our total budget. After some discussion, we decided it would be fairest to take this across the board so that all programs will be reduced by 1%. This includes all State Library operating programs (Talking Book Library, ACLIN, State Publications, Institutions, as well as operating and travel) and all distribution programs (Systems, Denver Public Library's Colorado Resource Center, Payment for Lending, and State Funding for Libraries). We have been told that they do not expect this will not impact the base of these programs in the future. That decision is not final yet.

We have also been told that they expect to take another 3% from next year's budget, FY 2002-2003. We are still in discussion with the CDE Budget Office and the Governor's Office to determine from where these cuts will come.

We hope to have an announcement by CLA.
