Community Relations Awards Note Achievements with Prizes

Nominations are now being taken for the second annual Library Community Relations Awards. The Awards recognize library staff and volunteers who are the energy behind community relations and outreach, the foundation of all successful advocacy and marketing efforts. Libraries of all types are eligible.

It's simple. Write a letter of nomination for yourself, a coworker, a volunteer, or a group, telling about your community relations and outreach program. Send it to the Colorado State Library by February 7, 2005. The note should contain the following:

- A brief description of the program or project (can be new or continuing).*
- Time period of the project.
- What the outcome of the project has been, what positive impact it's made.
- Statistical information, numbers, evaluations, etc. IF ANY.
- Library name, type, address, phone.
- Nominator's name, affiliation, phone, and e-mail

 Projects that utilize the ALA or Colorado's @your library logo and/or materials will receive special consideration.

A minimum of SIX awards will be given. Awards for projects deserving special merit may also be made. Examples of community relations: registering for library cards at grocery store; presenting about school media center at PTA; giving promotional bookmarks to customers at used book sale; getting local computer store to stock bookmark or flyer with your library's web site; giving book talk at local senior residence. Awards include:

- Three cash awards of \$100 and three cash awards of \$50 to the person OR persons involved in the best community relations effort.
- Certificate
- Notice in CSL publication.



Task Force Report on Denver Public Library Funding Released

Denver Mayor John Hickenlooper has released the Report of the Mayor's Task Force on Future Library Funding. You can read the Report by visiting http://denver.lib.co.us/taskforce/report.pdf. Hickenlooper formed the Task Force in March 2004 to explore the Denver Public Library's (DPL) funding in light of its financial situation.

In their Report, Task Force members advocate a modest funding increase to help offset three years of severe Library budget cuts at both State and City levels. At its year-end meeting, the Denver Public Library Commission is reviewing and discussing the Report. The Library will develop its strategic next steps, which include an extensive process to seek public opinion.

Library Looks to Future Following Court's Decision

The Pikes Peak Library District (PPLD) has prevailed in the court case filed against it a year ago in El Paso County District Court. Judge Thomas Kane of the Fourth Judicial District granted the motion for summary judgment submitted by PPLD based on the merits of the case, finding in favor of the District on the three points of the complaint:

- The District's 1986 mill levy authorization constituted voter approval in advance for the District's subsequent mill levy increases.
- The District has substantially complied with TABOR's limitations on fiscal year spending and revenues for fiscal years 1999-2003.
- The District's lease and purchase agreements include non-appropriation clauses and do not, therefore, equate to multi-year fiscal obligations.

The Plaintiff in the case has filed a notice of appeal to have the Colorado Court of Appeals review the District Court's decision. The Library is confident that the appellate courts will affirm the District Court's decision.

PPLD looks on the outcome of the court case as an affirmation of its policies and practices. The process has confirmed for the District the importance of fiscal responsibility to the community.
