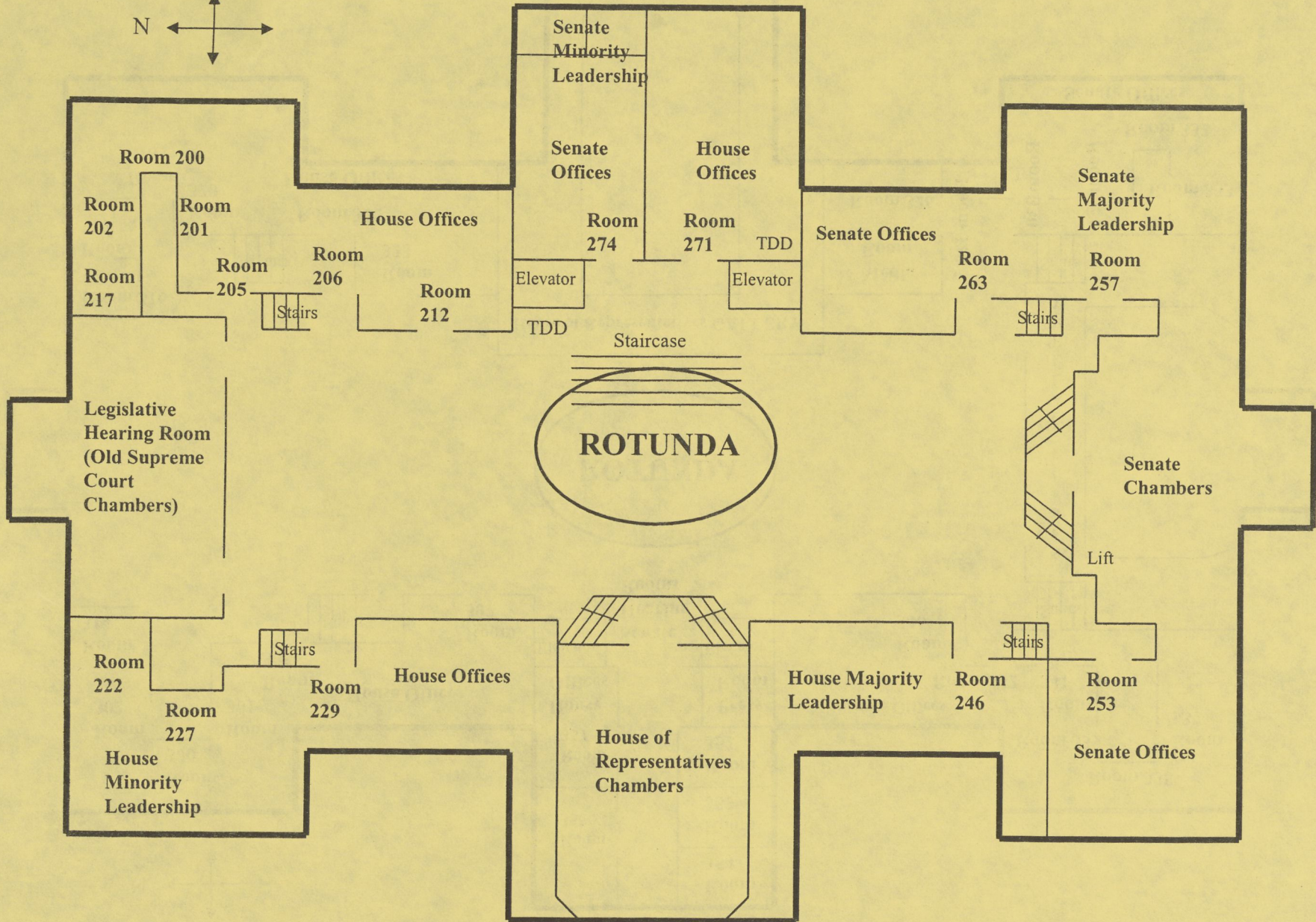
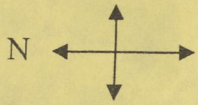
BASEMENT FLOOR PLAN



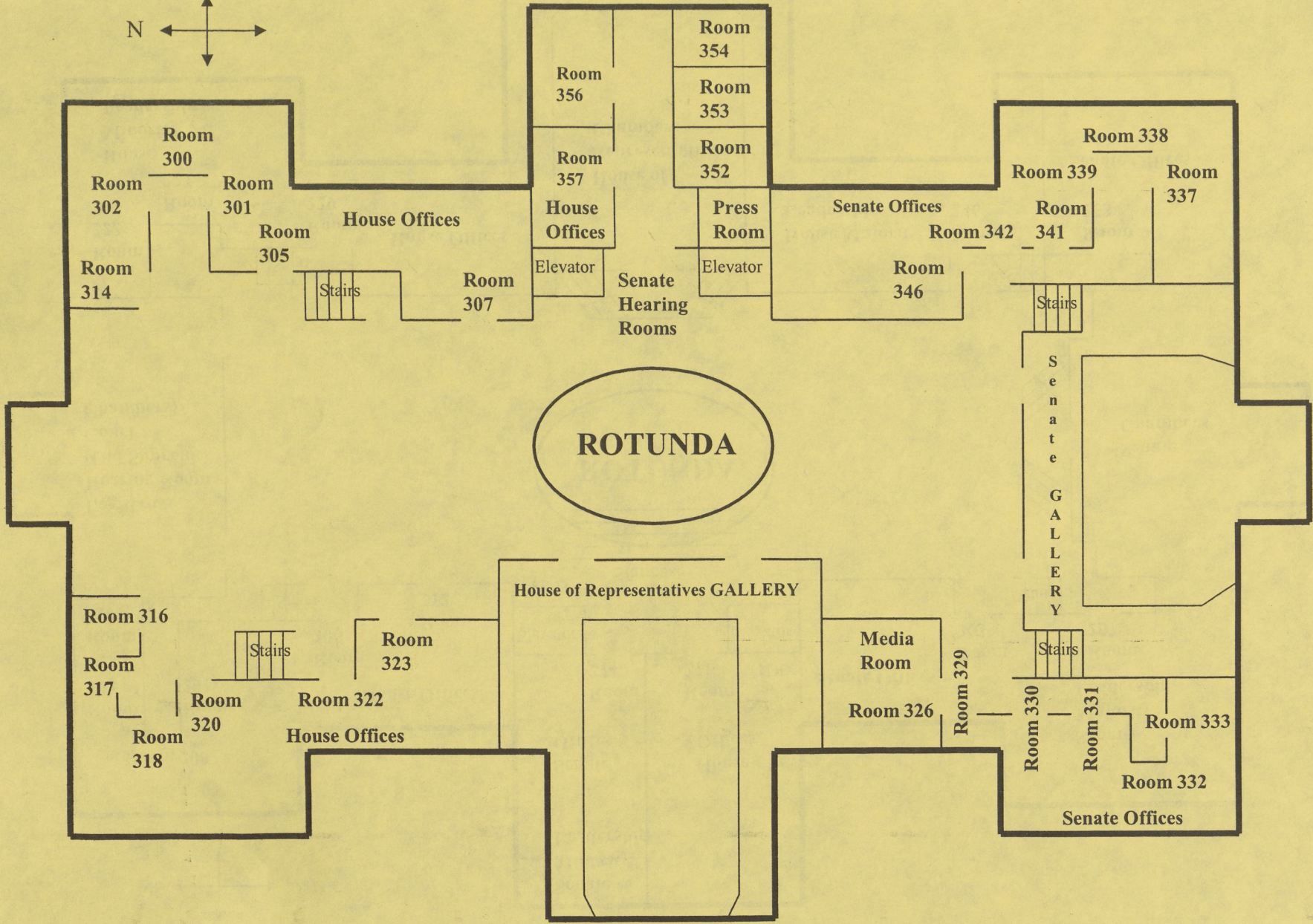
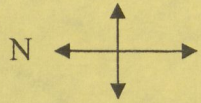
FIRST FLOOR PLAN
