## 2009 STATUTORY DUE DATE REPORT

At the request of the Legislative Council and the Department of Property Taxation, Wild Rose Appraisal – Audit Division collected information from the counties on their compliance with meeting the following statutory due dates:

Not later than January 10: § 39-5-129, C.R.S.

Assessor delivers tax warrant to treasurer.

Not later than May 1: § 39-3-204, C.R.S.

Assessor mails senior citizen and disabled veteran exemption notices to residential real property owners.

Not later than May 1: §§ 20, art. X, COLO. CONST., 39-5-121(1), and 39-7-102.5, C.R.S.

Assessor sends Real Property Notice of Valuation and Protest Form to taxpayers.

Not later than June 15: §§ 20, art. X, COLO. CONST., 39-5-121(1.5), 39-5-113.3(2), 39-6-111.5, and 39-7-102.5, C.R.S.

Assessor sends Notice of Valuation and Protest Form for personal property, drilling rig valuations, and all producing natural resources property.

On or before last working day in June: §§ 39-5-122(2) and 39-5-122.7, C.R.S.

Assessor mails two copies of Real Property Notice of Determination to taxpayers who filed a protest.

On or before July 10: § 39-5-122(2), C.R.S.

Assessor mails two copies of Personal Property Notice of Determination to taxpayers who filed a protest.

Not later than August 15: §§ 39-3-206(1) and 39-3-206(1.5)(b), C.R.S.

Assessor mails denial notice to residential real property owners returning incomplete or non-qualifying senior citizen or disabled veteran exemption applications.

Not later than August 25: §§ 39-2-115(1) and 39-5-123, C.R.S.

Assessor files two signed copies of the Abstract of Assessment with the Administrator.

Not later than August 25: §§ 39-5-121(2)(a), 39-5-121(2)(b), and 39-5-128(1), C.R.S.

Certification of Values to Taxing Entities

- Assessor notifies each taxing entity, the Division of Local

Government, and the Department of Education of the total assessed value of real and personal property within the entity, and the exceptions to the revenue and spending limitation.

- The assessor certifies the actual value of the taxable property in each school district to the secretary of each school district.
- Assessor notifies each taxing entity, except school districts, of the total actual value of all real property, the actual value of newly constructed real property, destroyed real property, and additions to minus deletions from taxable real property as prescribed by the Administrator pursuant to § 39-2-109(1)(e), C.R.S.
