Suspension of Statutory Salaries — Declares that existing statutory salaries may work an unreasonable hardship upon State employees because of present economic conditions; suspends such statutory salaries from July 1, 1949 to June 30, 1951, and provides that the chief executive officer of the department, institution or agency may fix salaries of such employees with the written approval of the Governor within the limits of appropriations therefor; applies only to those employees not under the classified civil service.

6 <u>Arkansas River Compact</u> — Approves the Arkansas River Compact between the State of Colorado and the State of Kansas.

Wage Assignments - Provides that assignments of future 52 wages or any other sum due thereafter shall not be valid as against any creditor of the assignor who has not had actual notice thereof unless the assignment has been recorded within 5 days thereof; provides that assignment of future wages or any sum due shall not be valid, unless if the assignor is a married man or woman residing with his or her spouse, the spouse joins in the assign-ment and acknowledges the same; provides that no assign-ment of wages by any employee to any person for the benefit of such employee shall be valid or enforceable and that no employer or debtor shall recognize or honor any assignment of wages unless the assignment is in writing and for a fixed and definite part of the wages earned, or to be earned within thirty days of the date of such assignment; provides that any post-dated assignment or one dated on any other date than that of its actual execution is void; provides for notification of such assignment to the employer with a copy to the employee; provides that the burden of proof as to the recording of the assignment or of actual notice to the creditor is placed upon the assignee; provides that the use of the check-off between employers and employees is not affected; provides that the assignment of wages to a credit union and certain other payroll deductions are not affected, nor those under the Small Loans Act.

Commission on Alcoholism — Creates the Colorado Commission on Alcoholism; provides for the appointment of its members; provides for the study of the problem of alcoholism; provides for the establishment of Out-Patient Pilot Clinic in Denver; provides for the dissemination of information concerning alcoholism; provides for the reporting of its findings and the making of recommendations to the Governor and the Thirty-eighth General Assembly as to the incidence of alcoholism; provides for the appointment of an executive director and prescribes his powers and duties.

Unfair Practices Act — Amends and re-enacts the Unfair Practices Act, C. 261, L. '37, as amended, and re-enacted by C. 227, L. '41; makes unlawful the sale or offering for sale of commodities with intent to destroy competition, excepting as to motion pictures and public utilities; makes directors, agents, or officers of firms, corporations and others responsible; makes it unlawful to sell below costs; provides the procedure for establishing costs and proving the same; prohibits secret rebates, refunds, discounts, etc.; declares contracts made in violation of Act illegal; provides for the maintenance of actions and recovery of damages and other related provisions and for the administration and enforcement of the Act by the Director of Revenue with the assistance of the Attorney General and district attorneys.

'41, by clarifying the provisions of subdivision 2 relating to first liens upon real estate and buildings and by adding subsection 6 permitting investments of funds of such companies in equipment trust obligations or certificates but not to exceed 10% of their assets. The subsequent subsections are renumbered. \$20 of the Act recites certain chapters of existing laws which are not to be construed to be repealed, including S. 710 enacted by the Thirty-seventh General Assembly and approved by the Governor on March 25, 1949, which provides that funds of domestic insurance companies may be invested in real estate loans guaranteed under the provisions of the Farmers' Home Administration Act of 1946 under certain conditions.

Dentistry — Amends § 4, 6 and 15, C. 52, '35 C.S.A., relating to the practice of dentistry in Colorado by increasing the examination fee from \$25.00 to \$50.00, the annual registration fee from \$2.00 to \$4.00 and the dental-hygienist license fee from \$10.00 to \$20.00.

Public Employees - Retirement — Provides for an increase in the rate of contributions of employees of school districts and municipalities from 3-1/2% to 5% commencing January 1, 1950; provides for an increase in the rate of such public employer contributions from 3-1/2% to 5% commencing January 1, 1950; provides for retirement of school and municipal employees at age 60 after 20 or more years covered service, instead of age 65, and at age 55 after 35 years covered service, instead of after 35 years covered service, any age; provides for retirement of such employees on a basis of 50% of average salary with a maximum of \$200.00 instead of \$100.00 per month; amends by implication \$6,7 and 11, C. 149, L. '43, as amended

Public Employees - Retirement — Amends by implication C. 36, 135 C.S.A., as amended, by increasing the maximum monthly retirement benefits from \$150.00 to \$200.00, effective January 1, 1950.

Public Employees - Retirement - Public Health Employees in County and District Health Departments — Amends C. 149, L. '43, by implication by extending its provisions to the employees of County or District Health Departments, as established under C. 204, L. '47, effective January 1, 1950, at the option of the governing county or district board of health.

Public Employees - Retirement — Amends § 4, C. 149, L. '47, by providing that, effective January 1, 1950, whenever a member of the retirement system has been an employee of the State for 20 years and has attained the age of 60 years, or for 30 years and has attained the age of 55 years, he may retire and receive an annuity equal to 50% of the average of the highest monthly salary during any period of 5 consecutive years within the last 10 years but not to exceed \$200.00, instead of \$150.00 as formerly; provides that, effective July 1, 1950, whenever any member of the retirement system has been an employee of the State and affiliated with the system 5 years or more and has attained the age of 65 years, and is otherwise qualified, he may retire and receive a monthly annuity equal to 1/20 pwt. of 50% of the average of the highest monthly salary received by him during any 5 consecutive years of service within the past 10 years, multiplied by the number of years service, not to exceed 20 years, or the sum of \$200.00, whichever is the smaller amount. This is a clarifying amendment.

Fraternal Benefit Societies - Distribution of Funds - Amends \$ 179, C. 87, '35 C.S.A., to clarify the procedure for the distribution of funds by fraternal benefit societies.

Fraternal Benefit Societies - Benefits — Amends § 173, C. 87, '35 C.S.A., relating to benefits by providing for the issuance to its members of term, life, endowment, and annuity certificates, and combinations thereof, in addition to death benefits; provides for permanent partial disability as well as permanent total disability, correcting an error in the existing law; provides for the payment in full at the age of 65 instead of 70 in cases of permanent disability; eliminates the proviso regarding the issuance of benefit certificates for a term less than life to conform to the specific provisions enumerated above; adds the Commissioners 1941 Standard Ordinary Mortality Table and 3-1/2% to the American Experience Table, and 4% interest provided for in the present law; and provides for loans to members.

'37, establishing further procedures in connection with such discharge or probationary discharge making it mandatory for the judge of the court to take action with respect to the matter within thirty days after receipt of the notice of such discharge or probationary discharge, with the approval of the district attorney.

Water Pollution Control — Amends the 12th subdivision of \$10, C. 163, \(^135\) C.S.A., by adding to the powers of city councils and boards of trustees, the power to provide for water pollution control in a more detailed manner and procedure; city and incorporated towns are authorized: (1) To apply for and to accept grants or loans or any other aid from the United States of America or any agency or instrumentality thereof; (2) To construct, re-construct, lease, improve, better, and extend sewerage facilities and sewage treatment works wholly within or wholly without the municipality or partially within or partially without the municipality; (3) To issue its general obligation bonds or other general obligations for the aforesaid purposes within the limitations prescribed by the 6th subdivision of \$10, C. 163, \(^135\) C.S.A., and to issue its revenue bonds or obligations for such purposes as may be provided by law; (4) To provide for the sale of such bonds or obligations; (5) To cooperate with other local public bodies and with state agencies and institutions, by contract, for the joint construction and financing of such works and their maintenance and operation, all as prescribed in the amended subdivision; provides that the foregoing powers may be exercised only after approval of the State Board of Health.

Sewerage Facilities — Authorizes municipalities to acquire, construct, re-construct, lease, improve, better, and extend sewerage facilities; to issue bonds payable solely from the revenues thereof; to accept loans, grants, and contributions to aid in financing the planning and construction thereof; to regulate the issuance of such bonds and provide for their payment and for the rights of the holders thereof; to enter into contracts with other municipalities or districts or with industrial establishments regarding such sewerage facilities; and provides for other related matters.

May 20 Inheritance and Succession Taxes - Amends § 9, C. 85, 135 C.S.A., relative to proceeds of insurance policies to provide that if an insurance trust is created by incorporating in the trust agreement a copy of the maker's last 949 will and testament, it shall not be considered as making the proceeds of the policies held in such insurance trust subject either to the claims against the decedent's estate or to distribution as a part thereof; amends the second paragraph of said § 9, C. 85, '35 C.S.A., by adding the following parenthetical clause after the words "described beneficiaries". beneficiaries", - "(whether or not such beneficiaries may have the power to effect a change in the method of distribution of such proceeds by electing to take a spouse's statutory share of the deceased's estate)."
