#### SENATE BILLS ENACTED AND APPROVED

3 Appropriation to the Colorado Advertising and Publicity Committee - \$200,000.00.

March 27

March 27

4 Salaries of Clerks of Courts of Record — Amends present statutes by eliminating the temporary provision regarding payment of salaries of clerks of courts of record, and repeals two sections of the law which are redundant.

February 3 February 3

Salaries of Justices of the Peace and Constables — Repeals the temporary provision for payment of increased salaries of all Justices of the Peace and Constables; also repeals the act which provides for payment of salaries of Justices of the Peace and Constables in counties of less than 30,000 or more then 50,000 population out of the general county fund.

6 <u>Salaries of District Attorneys</u> — Amends the present statutes by eliminating the temporary provision for payment of salaries of District Attorneys; repeals old law concerning said salaries which was redundant.

Salaries of Members of General Assembly — Provides for payment of \$50.00 per month to each member of the General Assembly during his term of office and an additional \$1200.00 per biennial period, to be paid at the rate of \$10.00 per day for each day served in regular session, and the balance, if any, at the end of the biennial period. Act affects those members elected in 1952.

Salaries and Allowances of Certain Elected State Officials — Removes temporary provision for payment of salaries of Lieutenant Governor, Attorney General, Treasurer, Secretary of State and Auditor, and allows \$3,000.00 to the Governor for salary of private secretary. Provides for payment of \$20.00 per day to the Lieutenant Governor or President pro tem of the Senate while acting as Governor.

9 <u>Salaries of Non-classified State Employees</u> — Provides that statutory salaries of non-classified state employees be suspended until June 30, 1953, and that all such salaries be fixed by the head of the department concerned with the approval of the Governor.

General Assembly - Vacancies Filled -- Provides that the vacancy committee of the political subdivision in which any vacancy occurs shall, within ten days from said vacancy, fill the same with a constitutionally qualified person of the same political party as the member whose termination created the vacancy. The Governor makes appointment if the vacancy committee fails to act. The appointee's name is certified to the Secretary of State who, in turn, certifies the same to the General Assembly. The appointee serves until the convening of the next General Assembly after his successor has been elected and qualified.

11 <u>General Assembly - Employees and Compensation — Provides that officers and employees of both Houses and their salaries be fixed by Joint Resolution without regard to Civil Service classification.</u>

19 Appropriation to the Board of Education - \$7,500.00 for the current fiscal year.

Fireworks - Prohibition of Sale and Use - Provides that it is unlawful to sell or have possession of fireworks as defined. Permits may be granted for supervised public displays upon filing of a bond, and sale of fireworks to permittee is not unlawful. Interstate sales and use of blank cartridges for ceremonial or signal purposes are exempted from operation of the act. Fireworks unlawfully in possession may be seized by police authorities. Penalty for violation is \$300.00 fine or 90 days in jail.

April 20 August 1

Labor - Workmen's Compensation -- Amends the present "Workmen's Compensation Act" by providing that all elective officials are defined as "employees"; prohibits employers from requiring employees to pay any part of the cost of insurance; raises the maximum weekly benefits from \$22.75 to \$28.00; allows the amount due the Subsequent Injury Fund to be paid in death cases; also in death cases, if there be wholly dependent persons, benefits shall be paid for a period not to exceed six years from date of death and not to exceed \$8,764.00, less any sums paid prior to death; and, if there be partially dependent persons, benefits shall be paid for such period after date of death as shall be required to be paid, at the weekly rate, to compute the total award. In cases of temporary disability of more than seven days' duration, the employee is entitled to benefits at the new rates and in cases of temporary partial disability, benefits are to be computed at the new rates, or the aggregate sum of \$3,640.00. The limitation of \$100.00 for dental treatment and repair is raised to \$500.00, and maximum award for permanent partial disability is raised from \$5,915.00 to \$7,280.00, with the maximum lump sum award changed from \$7,098.00 to \$8,764.00. A copy of transcript of any proceeding furnished on payment of thirty cents per folio, for which the old rate was ten cents per folio.

30 <u>Workmen's Compensation</u> - <u>Definition of Occupational Diseases</u> - Amends the present law which sets forth the various diseases deemed to be occupational diseases by adding thereto poisoning by radio-active materials, anthrax and dermatitis.

33 <u>Labor - Salaries of Members of Industrial Commission - Amends the present law concerning salaries of the members of the Industrial Commission by increasing said salaries to \$6,000.00 per annum.</u>

34 Stock - Inspection of Stock Before Shipment - Amends the present law relating to inspection of livestock before being shipped by a railroad or other carrier, by eliminating the alternative provisions of inspection by either the stock inspection commissioners or brand inspector. Makes provision for brand inspection of all stock shipped except in cases of transfer between pastures and and shipment to Colorado markets or sales rings where a brand inspector is maintained.

- Courts of Record Number of Judges in First Judicial District Repeals the temporary provisions of the present law increasing the number of judges in the First Judicial District to three, thereby providing permanently for three judges in said district.

42 Appropriation - Relief of Melnick Brothers - \$140.49.

Insurance - Tax on Reciprocal or Inter-insurance Contracts - Amends the present law concerning the 2% premium tax, in that such tax on reinsurance shall be paid by the assuming company. Also provides that no tax be paid in the event any reciprocal or reinsurance exchange shall have 50% of its assets in public bonds or other approved property within the state.

65 Children - Uniform Reciprocal Non-Support Act - Provides for reciprocal provisions in connection with the non-support of any dependent, thereby requiring an obligor who resides in any state having the same statute to pay for the support of a spouse, child or other dependent as defined in the act. The procedure in enforcing payment is by forwarding exemplified copies of the complaint to the state of residence of the obligor, which state can compel said obligor, by appropriate action, to make the necessary support payments.

46 <u>Motor Vehicles - Use of Mufflers - Provides that all motor vehicles be equipped</u> with a proper muffler and prohibits use a a muffler cut-out or bypass.

Amends present statute in that the limitation of 20 mills in school districts of the third class is eliminated. The levy is now made by commissioners in such amount as is necessary to maintain schools.

51 <u>Sale of Real Property</u> — Authorizes sale of parcel of real property located in Jefferson County, near the State Industrial School.

Intoxicating Liquors - Definition of Restaurants - Amends present statutes concerning definition of a restaurant by providing that such restaurant business may include the furnishing of "music by means of any mechanical device". Also allows the restaurant to furnish entertainment by way of orchestras, singers, floor shows and other forms of entertainment commonly provided by restaurants, but specifically prohibits the use of any gambling devices in any form.

56 <u>Health - Public Funds Used for Support of Private Hospitals</u> — Amends the present law in that the Board of County Commissioners may donate or lend public funds to private hospitals for care of indigent persons and those having a contagious disease. Funds may also be spent for maintenance and support of hospital buildings.

Public Health - Erection of Hospital Buildings - Amends the present law concerning erection of hospital buildings and the location thereof by providing a set of such buildings may be in different towns, and that more than one hospital may be in the same county.

Onemployment Compensation — Adds to the present law a provision that any person who has been previously employed for five consecutive years shall, if such person files a valid initial claim, receive an additional 25% of the weekly benefit; that the applicant must furnish the department with reports concerning separation from his employment. The Unemployment Compensation Fund shall also include funds received from the Federal unemployment account and all other funds received. The department is authorized to obtain an advance from the Federal unemployment account and to make repayment thereof in accordance with the Federal statute. Amends the present law so that the department may cooperate with and enter into reciprocal arrangements with both the Federal government and other states in accordance with provisions of new statutes of the Federal government and other states. Many minor procedural and administrative changes were made by the bill.

70 <u>Towns and Cities - Definition of Sewerage Facilities - Amends present statutes defining sewerage facilities by greatly broadening the definition to include any one of the various devices which might be used in connection with sewerage, industrial waste, storm, flood or surface drainage waters.</u>

73 <u>Wills and Estates - Power to Lease Real Estate - Amends the present law by removing the limitation of the period of time for which real property may be leased by a personal representative. The bill provides that lease may be for any period of time approved by the court.</u>

Roads and Highways - Department May Acquire Land and Buildings - Provides that the State Highway Department may purchase land and erect thereon office and storage buildings. The department may also enter into leasing agreements for buildings not to exceed 30 years. All rentals to be paid out of the State Highway Fund. Property so acquired is exempt from taxation as long as it is used for public purposes.

79 <u>Agriculture</u> - <u>Disposition of Fees Collected by Department of Agriculture</u> - Amends present law by deleting a reference no longer applicable.

83 <u>Appropriation</u> — Provides for relief of the widow of James B. Ryan, deceased former member of the Senate - \$980.32.

84 Appropriation — Provides for relief of the widow of Edgar W. Bray, deceased former member of the Senate - \$258.00.

- 96 Aid to the Blind Amends the present statutes concerning examination of blind persons by providing that optometrists, as well as ophthalmologists, be designated to make such examinations. Also amends present statutes concering the amount of assistance to be paid to blind persons by providing that the first \$50.00 of earned income of a blind person shall be disregarded in determining the amount of assistance.

Public Welfare - Administrative Expenses Thereof - Amends the present law by providing that 85%, in lieu of 75%, of administrative cost of the county departments be reimbured by the state. Definition of administrative expense is broadened to include the county's payment on behalf of employee's old-age insurance and retirement benefits, medical examination fees, postage and printing.

98 <u>Aid to the Blind</u> — Amends the present statutes concerning eligibility for assistance to needy blind by providing that no applicant who is a patient in any institution for tuberculosis or mental diseases or as a result of having been diagnosed as having tuberculosis or psychosis is eligible for assistance. Also makes minor change in the residence requirement by deleting the words "and continues to reside in this state".

105 <u>Appropriation</u> — Providing for the relief of heirs of Christopher Cusack, deceased former member of the Senate - \$685.00.

106 County Government - Abstract of Deeds - Amends the present law by providing that county clerks and recorders are prohibited from furnishing abstracts in counties wherein there are one or more licensed abstracters of title.

107 <u>Dentistry - Practice Thereof - Amends the present statutes by prohibiting any person from making, altering, repairing or fitting dentures for the human mouth, unless pursuant to a written prescription signed by a licensed dentist.</u>

February 15 February 15

District Attorneys - Salary of Certain Assistant District Attorneys - Amends the present law by providing that in all judicial districts having more than one and less than four judges, the salary of the assistant district attorney may be fixed not to exceed \$3,600.00 per annum. The former maximum salary was \$2700.00.

March 28 March 28

Public Welfare - Administration of the County Public Welfare - Amends the present law by defining the various allocations which shall comprise the fund. Additional allocations are aid to indigent unemployed, needy disabled, indigents afflicted with tuberculosis, poor farm, and medical aid for indigents. Provides for a new procedure in preparing budgets. Provides that county commissioners may make a county welfare levy against assessed valuation, with limitations fixed by the per capita assessed valuation in the respective counties, except that the City and County of Denver may provide welfare funds out of the general fund. Repeals several sections of the law no longer applicable.

March 16 January 1, 1952 (exceptions)

Bulk Sales - Waiver of Inventory - Amends the present law by providing that the seller and buyer may agree to waive the making of an inventory in cases of sale of the entire stock of merchandise.

113 <u>Authorizing Sale of Real Property in Jefferson County</u> — Authorizes the sale and conveyance of a tract of land in Jefferson County containing approximately 20 acres for \$6,087.00.

March 13 March 13

Public Welfare - Aid to Indigent Residents Who Are Afflicted with Tuberculosis - Amends the present law by changing residence requirements from three to one year. Also changes daily amount of assistance from \$6.00 to \$7.00. Provides that in cases of emergency the state may reimburse the county in excess of the 50% of the county cost.

121 Schools - Investment of Public School Funds - Amends the present law by providing for an additional manner in which school funds may be invested; namely, bonds of water, sanitation, water and sanitation, metropolitan and fire protection districts of the state.

March 6 March 6

123 Game and Fish - Federal State Cooperation - Provides that the State of Colorado assents to the provisions of the Dingell-Johnson Act whereby the state is entitled to receive federal funds for fish restoration and management projects.

March 16 March 16

137 <u>Automobiles - Inspection of Records of Distributors - Amends the present law</u> by providing that the Director of Revenue, rather than the state treasurer, shall be authorized to inspect the records of any distributor of motor fuel.

Also requires that every refiner and blender shall maintain complete records of all operations.

March 16 July 1

Automobiles - Refund of Motor Fuel Tax - Amends the present law concerning refunds of motor fuel tax collected by providing that a refund shall be made in connection with all motor fuel purchased and used by the state. Also provides that the Director of Revenue shall cancel any pending claim for refund and deduct from subsequent claims the amount of any altered or false claim for refund. Former penalty in case of false claim was fine or imprisonment, or both.

Automobiles - Interstate Change of Information - Amends the present law by providing that the Director of Revenue, instead of the State Treasurer, shall, upon request of other states, furnish information relative to motor fuel taxation on a reciprocal basis.

March 8 March 8

Automobiles - Collection of Motor Fuel Tax - Amends the present law concerning the collection of motor fuel tax by providing that the Director of Revenue may declare a taxable period terminated, determine the tax, and make demand therefor if he finds that the collection may be jeopardized by delay. Also provides for the procedure in collecting taxes due by authorizing the Director of Revenue to issue a warrant to seize the personal property of the tax debtor and sell the same at public auction. Warrant may be placed on judgment docket and become a lien on real property of the tax debtor, and the lien may be foreclosed in the manner provided by law.

143 <u>Automobiles - License of Distributors and Refiners - Amends the present law</u>
by requiring refiners of motor fuel as well as distributors to be licensed
by the Director of Revenue. Formerly the licenses were issued by the State
Treasurer.

Automobiles Definition of Distributor and Refiner — Amends the present law concerning the definition of a distributor by defining the same as any one who first receives motor fuel in the state or one who first uses, sells, or offers for sale in this state any motor fuel. Adds a definition of refiner which is every person producing, refining, preparing, distilling, manufacturing or compounding motor fuel in the state.

146 Road and Highway - Creation of a County Road and Bridge Fund - Provides for the creation of a county road and bridge fund for road and bridge construction and maintenance. The County Commissioners are authorized, without limitation, to make sufficient tax levies for this purpose. Repeals the tax levy provision which limited the amount of the levy.

149 Stock - Livestock Sales Rings, Bonds of - Amends the present law which requires a bond to be executed by the operator of any livestock sales rings by exempting therefrom any livestock sales ring registered under the Packers and Stockyards Act and which has executed a bond thereunder.

Revenue - County Tax Levies — Amends the present law by increasing the maximum general fund mill levy which may be assessed by the respective counties. Provides for the creation of a county general fund which comprises all county revenue, except specific allocations, and a public works levy, limited to three mills, which must be approved by vote of the people. Formerly county commissioners could make a levy not exceeding five-tenths mills for agricultural research work and a special levy for pest and weed control. These levies were repealed and such expenses are to be paid from the county general fund. Repeals specific mill levy for the county or district health departments and libraries, and provides for payment of such expenses out of the county general fund. All county fairs maintained and paid for out of county general fund.

156 Courts of Record - Terms of Court in Third Judicial District - Amends the present law changing the date of commencement of terms of the district court in Huerfano and Las Animas Counties.

158 <u>Automobiles - Minimum Speed Regulation - Amends the present law concerning</u> minimum speed of automobiles in that any driver who impedes traffic is required to drive to the extreme right of the highway to allow the impeded traffic to pass by.

159 <u>Butchers - Unlawful Acts</u> — Amends the present law concerning sales of beef or veal by persons other than licensed and bonded butchers in that every person having in his possession a carcass or part thereof must retain the

hide for 30 days unless inspected by the brand inspector. Penalty for violation was changed from a misdemeanor to a felony, and provision for reward to informant was removed.

161 Schools - Repeal of Statute Requiring Certain Conditions to be Met by School Districts to Receive Equalization Funds — Repeals the statute requiring school districts to have a minimum assessed valuation and requisite mill levy before any funds from the state school equalization fund are distributed to school districts.

Revenue - Duty of State Tax Commission - Re-enacts provisions of law which were repealed in 1949. The reenactment provides that the state tax commission shall determine if all real and personal property in the state is assessed at its true and full cash value and, if not, to make proper adjustments. The commission's determination is certified to the State Board of Equalization, which board shall make a record on the abstract of each county concerned.

167 <u>Appropriation-to the Colorado State Reformatory</u> — \$60,000.00 for building purposes.

172 State Institutions - Convict Labor at State Penitentiary - Amends the present law by permitting convict-made goods to be sold on the open market at prevailing market prices. Proceeds therefrom used to defray cost of operating the penitentiary. The warden is empowered to purchase machinery and equipment for the purpose of operating industrial and agricultural projects.

173 Appropriation - To the State Home for Dependent and Neglected Children - \$30,000.00 for buildings.

174 Appropriation - To the State Industrial School for Girls - \$185,000.00 for buildings.

Civil Defense — Amends the present law by expanding the provisions thereof to include the power of the Governor to authorize "lend-lease" of Colorado real and personal property and employees of the state to federal government heads of the armed forces or to the civil defense agency of the United States; creation of mobile support units to reinforce civil defense organizations in stricken areas and provision for interstate cooperation for such units. Emergency powers granted to the Governor in event of actual attack, to seize property, means of transportation, stocks of fuel, food and medical supplies. Also makes provision for temporary seizure of property and compensation therefor. Any person injured in the performance of civil defense duties is subject to workmen's compensation benefits. Makes other minor changes to permit the full exercise of authority in case of disaster.

177 <u>Civil Defense - Compensation Benefits for Volunteers - Provides that the provisions of the Workmen's Compensation Act and Occupational Disease Disability Act apply to any qualified civil defense worker or his dependents. Sets up the mechanics for obtaining said benefits out of a revolving fund in the sum of \$50,000.00.</u>

Civil Defense - Concerning Liability of State for Damages Arising out of Civil Defense Operations - Provides that the state shall be liable for personal and property claims, except personal injury claims of a bona fide civil defense worker, which claims are subject to the provisions of the Workmen's Compensation Act. No claim will be recognized if compensated by the Federal Government.

180 <u>Game and Fish - Game and Fish District and Membership of Commission — Amends</u>
the present law by increasing membership of Game and Fish Commission from seven
to nine. Provides for eight districts in the state with one member of the
Commission chosen from each district.

191 Game and Fish - Licenses - Amends the present law concerning game and fish licenses by adding the words "nor from hunting small game without a license", the effect of which is that any person under 16 years of age may hunt small game without a license.

Fire Protection Districts - Members of the Board - Amends the present law concerning the Board of Fire Protection Districts and the treasurer thereof, by adding a proviso that the district judge may dispense with the requirement that a bond be executed by each member of a first elected board and the treasurer thereof.

Schools - Limitation of Bonded Indebtedness - Amends the present law by raising the limitation of bonded indebtedness of school districts of the first and second class from 5% to 10%, with a maximum limitation of 15% if approved by the Colorado Tax Commission. Also raises limitation in third class districts from 3½% to 7%, with a maximum limitation of 10% if approved by the Colorado Tax Commission.

197 <u>Schools - Teachers Contracts -- Provides that no teacher's contract can require a teacher to become a member of or belong to any group or organization.</u>

201 Appropriation - Relief of H. W. Pride - \$745.34.

211 <u>State Institutions - University of Colorado</u> — Provides that the Department of Medicine of Colorado University includes the School of Medicine, School of Nursing, the Psychopathic Hospital of Colorado University and the Colorado General Hospital.

213 Appropriation - To the Judges Retirement Fund of the Public Employees
Retirement Association - \$15,600.00.

State Institutions - Employment of Inmates of Colorado State Reformatory
and Industrial School for Boys - Provides that all ablebodied inmates of the
Colorado State Reformatory and the State Industrial School for Boys shall be
employed in a productive capacity and that any surplus goods or wares produced
may be sold on the open market at prevailing prices. Money realized from sale
to be used to defay cost of maintenance. Wardens are empowered to set up projects to utilize the labor of inmates.

- 215 <u>Civil Service Salaries of Classified Personnel Provides for an increase of \$30.00 per month for grades 1-19, inclusive, and \$20.00 per month for grades 20-24, inclusive.</u>

216 Medicine - Powers and Duties of Board of Medical Examiners - Supplants the present law concerning the Board of Medical Examiners, its powers, duties and functions, by a complete revision of the present sections of the law. A new board was created in lieu of the old board, consisting of nine members, two of whom are to be osteopaths. Duties and powers of the new board are expanded to include assistance to District Attorneys in enforcement, prescribing rules and regulations to administration of the act, and power to conduct full hearings. Definition of practice of medicine redefined which clarifies specifically what acts constitute the practice of medicine and what acts are exempted from the definition thereof. The requirements for a license were rewritten to include reciprocity provisions for granting of licenses and additional requirements to be granted on initial license, which include an approved period of interneship. "Unprofessional conduct" of a practitioner is defined specifically and the board may revoke or suspend a license, after hearing, if the licensee indulges in any unprofessional conduct as defined. The board may reconsider any prior action taken and restore or reinstate any license. The board also has the power to order certain disciplinary action in proper cases. Provides for more severe penalties in cases of "splitting fees". Prohibits advertising of curatives and provides penalties for violation thereof. Makes many minor changes in administrative procedure.

Advertising - Powers and Duties of Colorado Advertising and Publicity

Committee - Amends the present law concerning the Advertising and Publicity

Committee and the method and means by which it may advertise by granting power

to so advertise in any manner deemed advisable by the Committee. Removes the

statutory number and salaries of employees of the Committee and gives author
ity to the Director to employ and fix salaries, subject to approval by the

Governor. Provides that the Committee shall consist of five rather than three

members. Of the five members, one shall be from each congressional district

and one at large.

224 <u>Funeral Directors and Embalmers - To Whom Act Applies - Repeals the provision of 1945 law providing that the act does not apply to any person who was previously qualified and made application within six months after the termination of the present war.</u>

225 Courts of Record - Salaries of Judges - Amends the present law concerning salaries of judges of courts of record by increasing the salary of judges of the Supreme Court from \$7,500.00 to \$8,500.00; the salary of judges of District Courts from \$6,000.00 to \$7,500.00; the salary of a judge of a Juvenile Court from \$6,000.00 to \$7,500.00; and increases the salary of the Denver County judge from \$7,000.00 to \$7,500.00. All other salaries of county judges in the state were increased to some extent.

228 Fair Employment Practice Act — Creates an Anti-Discrimination Division under the jurisdiction of the Industrial Commission, which division is headed by a director appointed by the Governor. Function of this division is to receive, investigate, hold hearings and pass on complaints alleging discrimination in employment or the existence of an unfair employment practice by a public employer; also to formulate plans for the elimination of unfair labor practices by education or other means. "Unfair employment practices" are defined as

(1) refusing to hire or discharging any person solely because of race, creed, color or national origin; (2) refusal by an employment agency to list any person for a known available job solely because of race, creed, color or national origin; (3) refusal by a labor organization to include for membership any person because of race, creed, color or national origin; (4) concerted action on the part of any group of employees to prevent employment or cause discharge of any person because of race, creed, color or national origin. The director is empowered to conciliate and settle, if possible, any complaint received; otherwise a suit may be filed in the district court. The court may enter a "close and desist" order if evidence warrants same.

Revenue - Sale of Real Estate by County - Amends the present law concerning public sale of real property by slightly changing the time when published notice of sale shall appear. Eliminates the requirement of prior deposit of cost of advertising before sale. Validates all prior sales, either public or private, but allows any interested party to file suit to set aside such sale within six months. Tax deeds are issued by a Commissioner to Convey rather than the county treasurer.

Insurance — Mutual Benefit Associations — Amends the present law concerning mutual benefit associations by requiring a minimum deposit with the Insurance Commissioner of \$25,000.00 cash or securities, rather than \$10,000.00. Must have \$50,000.00 on deposit before business can be done outside of Colorado. Eliminates provision that additional requirements imposed on Colorado associations by other states shall likewise be imposed by Colorado on foreign associations. Increases the monthly rate which may be changed on policies. Advance of money to an association to enable it to comply with the requirements must be made out of the expense fund instead of the Guaranty Reserve Contingency Fund. Other provisions concerning the funds maintained by associations are in the bill.

247 State Institutions - Release of Prisoners from Colorado State Reformatory - Provides that any person released from the Colorado State Reformatory shall be entitled to \$25.00, suitable clothing and a railroad ticket to place of residence.

255 <u>Game and Fish - Distribution of Game and Fish Publication</u>— Authorizes Game and Fish Department to distribute a conservation magazine on a paid subscription basis, the funds from which are to be used for the publication of such magazine.

258 Water Conservancy Districts - Lands Included in Districts - Amends the present law concerning the method of changing boundaries of a water conservancy district by providing an addition procedure to include other areas in said district. Said procedure requires the submission of a petition signed by freeholders in the area affected which is filed in the district court in the county where the affected land is located. Notice of hearing is given by publication. The court to decree what lands are to be included in the district.

282 <u>State Institutions - Name of State Agricultural College -- Provides that the state Agricultural College at Fort Collins, in addition to all other statutory designations, be also designated as the "Colorado Agricultural and Mechanical College".</u>

Public Housing - Creation of County Housing Authority to Acquire Federal Labor Camps — Creates a county housing authority to acquire federal labor camps to be used for housing for agricultural workers. Such authority may be established after a hearing to determine the need for such additional housing. If such county authority is established, the membership thereof shall consist of five commissioners who are empowered to buy or lease any federally owned labor camp on terms agreeable to the federal government. Any such camps so acquired may be rented to persons engaged in agricultural labor and persons of low income.

284 Courts of Record - Service Benefits and Retirement of Judges - Amends the present law concerning membership of the Public Employees Retirement Association of Colorado by including therein all county judges in counties of more than 10,000 population and less than 20,000 population.

286 Wills and Estates - Determination of Interests - Amends the present law concerning procedure to determine descent of real property of person dying intestate by eliminating the requirement of waiting until after final settlement of an estate before filing such petition in the district court. Formerly the petition required a statement of the residence of any person entitled to an interest in such property. The word "residence" was stricken and the word "address" inserted therefor. The former requirement was to state in the petition the names and addresses of guardians of any minors or persons under legal disabilities. This requirement was eliminated. Formerly the petition must allege names of grantees of alleged heirs. Present requirement is the allegation of only the record owner of such property. Only a copy of notice of hearing need be served on all interested persons. It is no longer necessary to serve a copy of the petition. Requires that the clerk of the court mail a copy of the notice to all persons named in the petition at least thirty days prior to entry of decree. Formerly only out-of-state addresses received a copy of mail. This act eliminates the provision that waiver could be signed in open court. The court may fix a day for hearing after twenty days from date of last service upon application by petitioner, but any interested person objecting must be given notice of such application. Provides that the decree recite the present owner of the property in addition to presently required recitals. Changes period within which decree may be reopened from two years to six months. This type proceeding may now be joined with any action affecting real property. Makes a change in the title of the proceed-

287 Conveyances - Recording Extension of Mortgage or Deed of Trust — Amends the present law concerning the manner in which the lien of a deed of trust or mortgage may be extended by providing that the trustee named in the instrument may sign and record an extension of the lien of the instrument. Trustees and owner of the property may agree concerning extension.

291 Appropriation - To the Colorado Metal Mining Fund Board of Directors - \$12,500.00

Insurance - Investment of Funds - Amends the present law concerning investment of insurance company funds by permitting investment in any certificate or savings account in any state or federal chartered building and loan association in addition to other provisions of the present law. Maximum amount to be invested in any one association is changed from \$5,000.00 to the maximum amount insured by the Federal Savings and Loan Insurance Corporation.

- 296 Courts of Record Expenses of District and County Judges Provides that district and county judges serving temporarily out of their own jurisdiction may receive compensation therefor based on actual personal maintenance plus ten cents a mile for the round trip. However, if by law a higher rate prevails, judges are entitled to such higher rate.

303 <u>Labor - Occupational Disease Disability Benefits</u> — Amends the present law concerning the aggregate amount of payments for total disability caused by occupational diseases by increasing the aggregate payment from \$4,375.00 to \$8,764.00. Also increases the death benefits in a like amount.

Accountancy - Qualifications and Fees of Applicants — Adds to the present law other requirements for applicants for certificate for a certified public accountant and exempts from examination, in the discretion of the board, those applicants who are possessed of the qualifications required by the present law and those added by the bill. Also makes a change in the requirements for a certificate to practice as a registered accountant. Also the fees charged for all types of examinations were changed.

318 Fees and Salaries - Salaries of Civil Service Employees - Amends the present law concerning the salaries of officers and employees in the classified civil service by deleting the four professional grades and adding four new grades numbered 29 to 32, inclusive, with salaries fixed at the same amount of the four grades eliminated. Salaries of the four new grades shall be fixed at the minimum and increases shall be made by the Governor, after consultation with the Civil Service Commission.

320 Revenue - Assessment of Mining Claims -- Amends the present law concerning assessment of producing mines by changing the period in which the owner submits his report to the assessor from the first fifteen days in January to the full month of January of each year.

322 Corporations - Organization and Powers of Non-Profit Corporations - Amends the present law pertaining to formation of non-profit corporations by requiring a copy of the certificate to be recorded in the county in which the corporation may own real estate. Incorporators need not be residents of Colorado. Powers of such a corporation were enlarged to include amendment of certificate, consolidation or merger, classes of members and all other rights incident to the stated objects. Provides in detail the facts required to be stated in the certificate or by-laws. Adds new sections concerning the power of amendment of certificate and the filing thereof with the Secretary of State.

Trade Marks - Registration and Protection of Trade marks - Repeals all of the present law pertaining to trade marks and provides a new procedure for the registration and protection of trade marks. Application for trade mark is to be filed with the Secretary of State setting forth all of the pertinent facts. The certificate of registration is issued by the Secretary of State, which is good for ten years and renewable for a like period. Any registered trade mark may be assigned by the owner. The Secretary of State shall cancel all old registrations of more than ten years which have not been renewed. Provides for an action in district court if any person is aggrieved by any registration and for classification of goods and services for which registration is sought. Provides penalties for fraudulent registrations and infringements.

- 324 <u>Wills and Estates Petition to Sell or Mortgage Amends the present law concerning sale or mortgage of real estate of an estate by providing that any such petition filed after a will is admitted need only recite the names, residences and post office addresses of the demisees of the property to be sold.</u>

325 Conveyances — Repeals certain sections of the law pertaining to redemption of real property sold upon foreclosure of a deed of trust and provides that any certificate of purchase shall be assignable by endorsement and the assignee shall be entitled to a deed. Provides for the form of sheriff's deed in case of sale by virtue of execution and levy, and that such deed shall be prima facie evidence of compliance with all statutory requirements and of the recitals therein contained.

335 Corporations - Issuance of Duplicate Certificate of Corporate Stock - Provides that the owner of capital stock in a ditch or water corporation may acquire a duplicate certificate if the original is lost by filing with the secretary of the corporation, any time after three years, of the notice of loss, a verified statement concerning the loss. After publication of said matter, a duplicate certificate will be issued, if no claim or bona fide objection has been made to the secretary.

337 Schools - Acceptance of Federal Aid Concerning School Facilities in Areas
Affected by Federal Activities - Provides for the acceptance of the provisions
of the federal act concerning schools in areas affected by federal activities.

359 <u>Game and Fish - Prohibition of Game Killing Contests - Provides that it is unlawful to conduct any contest which requires the killing of animals or birds.</u>
Violation is punishable by fine and jail sentence or both.

Schools - Limitation of Bonded Indebtedness - Amends the present law concerning the limitation of bonded indebtedness for county and union high school districts by raising the limitation for county high school districts from 2% to 5% of the assessed valuation, but not to exceed 10% if approved by the Colorado Tax Commission. Limitation concerning union high school districts is raised from 3% to 5%, but not to exceed 10% if approved by the Colorado Tax Commission. The limitations, as raised, apply only until December 31, 1953.

361 <u>Civil Defense - Repeal of Time Limitation</u> — Repeals the temporary proviso in the 1950 law and makes the Civil Defense Act permanent.

Automobiles - Records of Auto Camps - Amends the present law concerning records kept by operators of auto camps of all automobiles kept or stored by providing an alternate method of keeping such records on cards approved by the state auto theft department and that the same must be kept for a period of five years.

General Assembly - Call of the Houses to Order - Amends the present law relating to calling the House and Senate to order by providing that the Lieutenant Governor or President pro tem or the member having the longest service shall call the Senate to order; and the Speaker or the member having the longest service shall call the House to order. Additional penalty prescribed is revocation of hunting license for three years.

Engineers - Regulation of Practice of Engineering — Repeals all of the present law concerning the practice and regulation of engineers and provides a complete revision of the repealed sections to the end of acquiring interstate reciprocal benefits for all licensed engineers. A state board of engineers is created with power to issue and suspend licenses, hold hearings, subpoena witnesses and make necessary rules and regulations. Requires annual publication of a roster of all licensed engineers. Prescribes the minimum requirements of applicants for license and the fees therefor. Provides penalties for violation.

14 <u>General Assembly - Ordinary Expenses of Thirty-eighth General Assembly - Appropriates \$294,000.00 for the ordinary expenses of the first regular session of the Thirty-eighth General Assembly.</u>

17 <u>Courts of Record - Terms of Court in Fourteenth Judicial District -- Amends</u> the present law concerning terms of court in the fourteenth judicial district by changing the date of commencement of terms in the counties of Grand, Moffat and Routt.

Colorado State Fair - Transfer of Funds - Authorizes the transfer of \$50,000.00 from the State Fair Tax Fund to the Colorado State Fair Improvement Fund, which fund was created.

March 28 March 28

23 Appropriation - To the Secretary of State -- \$8,190.00.

25 <u>Schools - Extension of Time for Post-War Improvements - Amends the present law concerning the funds for post war building and improvement programs of school districts and junior colleges by extending the time for a period of five years.</u>

26 <u>Counties - Extension of Time for Post-War Improvements --</u> Amends the present law concerning post-war improvement funds of counties and city and counties by extending the effective date with reference to a city and county or city or town for a period of five years.

27 <u>Courts of Record - Additional Judge in Twelfth Judicial District -- Provides</u> that there shall be two judges in the twelfth judicial district and that the Governor appoint such extra judge as soon as practicable.

Natural Resources - Duty of Owner to Preserve Soil to Prevent Erosion — Provides the owner of land from which the soil is blowing shall upon the order of the county commissioners, cultivate the land and do all other things ordered by the board to prevent soil erosion. If the owner refuses to perform the requirements, the land will be treated and the owner assessed \$1.00 per acre for each operation. Any owner aggrieved by such order or assessment may file a suit in the district court and the same shall be tried as are other civil actions. Provisions of the act do not apply to lands within any city or town or to public lands.

Insurance - Purpose of Organization of Insurance Companies — Amends the present law concerning the purpose of organization of insurance companies by expanding the purposes of fire and marine insurance to include personal injury liability coverage. Also provides for reinsurance in connection with life policies. Adds title insurance and full coverage for motor vehicles as risks which may be insured or reinsured. Further provides for multiple lien cover of any of the risks set forth in the act, provided the carrier has the proper authority and capital.

Insurance - Reinsurance of Risks -- Amends the present law concerning the reinsurance of risks by companies authorized to do business in Colorado by providing that such companies may take credit for reserves on risks reinsured except if reinsurer is not authorized to do business in at least one state, or if reinsurer is not obligated because of possible insolvency of ceding insurer, or if reinsurer does not have a designated agent for service of process, or if there is only contingent liability on the part of the reinsurer, or if there is the possibility of repayment of tentative commissions by the ceding insurer. Makes further provision concerning insolvency of ceding insurer. Repeals sections of the law in conflict.

Workmen's Compensation - Tax Imposed for Safety Devices and Methods - Amends the present law pertaining to assessment of tax for development of safety devices and methods by providing that such tax be abated when the fund reaches \$20,000.00 and to revive when the fund becomes less than \$20,000.00

Insurance - Information and Rate Filings - Amends the present law pertaining to filing of fire and marine rate schedules with the Insurance Commissioner. Formerly all rate filings had to be accompanied by supporting information. Now such information need not be filed, but the Commissioner may request and obtain such information if needed.

Insurance - Regulation of Casualty Rates -- Amends the law pertaining to the filing of casualty rates with the Insurance Commissioner by providing that the Commissioner may require the filing of supporting information such as loss experience and statistical data. Also provides for a waiting period of twenty days before a filing becomes effective except with respect to a special filing regarding a surety bond required by law. Requires the Commissioner to review filings as soon as reasonably possible. Also provides for a new procedure in connection with disapproval of filings by providing that the Commissioner may

give notice of disapproval, without hearing, if done within the waiting period. After the review period, the Commissioner may disapprove the filing, after hearing, and any applicant may request a hearing if he feels aggrieved by any order of the Commissioner.

Insurance - Capital or Guaranty Fund Requirements - Amends the present law concerning cash capital or guaranty fund requirements to do business by providing for an unemcumbered surplus for each type of company in addition to the minimum capital or guaranty fund, and provides for minimum requirements of casualty and multiple line companies. Repeals the sections of the law pertaining to mutual companies and mutual fire insurance companies.

Courts of Record - Number of Judges in the Eighth Judicial District - Provides that the three judges presently authorized on a temporary basis for the eighth judicial district shall become permanently authorized.

Adds a provision for escheat proceedings wherein unclaimed funds, after liquidation, which have been in the possession of the Commissioner for at least six years shall, after advertising, be paid to the State Treasurer and held in the escheat fund for the statutory period.

67 Children - Eligibility for Assistance — Amends the present law concerning eligibility requirements for aid to dependent children by providing that assistance will be given if the parent or other relative with whom the child is living has resided in the state for more than one year immediately preceding the birth of the child. Formerly this requirement pertained just to the mother of the child. Adds a provision that aid will be furnished with reasonable promptness to all eligible individuals.

Income Tax - Rates and Exemptions - Amends the present law by making thirtyone different changes, the chief of which are as follows: Raises the surtax

\$10,000.00. Also provides that no recovery may be had on both provisions and that the plaintiff must elect the provision under which he will proceed.

Adams and Otero counties were reclassified as Class II B counties. Delta County was reclassified as a Class III A County.

86 <u>Courts of Record - Terms of Court in Fifteenth Judicial District - Amends the law relating to the commencement of terms of court in the fifteenth judicial district by changing the dates of commencement in the counties of Baca, Bent, Kiowa, Prowers and Cheyenne.</u>

Administrative Code - Duty of State Purchasing Agent to Operate State Car Pool - Provides that the state purchasing agent shall operate a state car pool system for the use of state-owned vehicles. He may require use of vehicles in the pool in lieu of use of vehicles in possession of any state department, or use of privately owned vehicles, and assign vehicles to the various departments. The agent must provide for storage and repair of all pool vehicles, and effect economies wherever possible. He has the power to prescribe rules and regulations for operation of the car pool. No claim will be approved for operation of a state pool car. A revolving fund of \$100,000.00 is appropriated to implement the act for a period of five years.

90 <u>Irrigation - Contents of Report of Water Commissioners - Amends the law relating to the annual report of the water commissioners to the irrigation division engineer by requiring additional information to be furnished with reference to the number of ditches, canals and the amount of water stored in reservoirs.</u>

Agriculture - Definition of Agricultural Commodity and Administration of Funds Collected - Amends the present law concerning agricultural marketing by redefining "Agricultural commodity". Poultry and poultry products, wheat, rye and livestock or livestock products are now included in said definition, as well as all articles manufactured from said commodities. Also provides that the commissioner will not issue a marketing order unless 2/3 of the producers who participated in a referendum on the question favor the order. Requires that funds collected are to be deposited in a depository designated by the State Treasurer instead of in the state treasury. Funds may be disbursed for necessary expenses of the board of control and the commissioner.

Soldiers' and Sailors' Home - Eligibility for Admission to Soldiers' and Sailors' Home - Amends the present law concerning eligibility requirements for admission to the Soldiers' and Sailors' Home by adding a requisite that the applicant be one requiring care and treatment or unable to provide for himself. Also provides that all able-bodied members participate in some useful function in maintaining the institution. Also makes a change in membership of the board of commissioners.

110 <u>Jurors - Salary of Juror Commissioners - Amends</u> the present law concerning the salary of jury commissioners and deputy jury commissioners by removing the statutory limitation and providing that the appointing authority fix and determine such salaries.

March 28 March 28

Banks and Banking - Examination of Bank's Records - Amends the present law concerning the examination of a bank's records at the monthly meeting of the board of directors by providing that a certified public accountant or clearing house examiner may make such examination. Eliminates the provision that the commissioner may waive one of the required reports.

Banks and Banking - Branch Banking - Amends the present law which prohibits branch banking in that "branch banking" is defined with particularity. Branch banking prohibition does not apply to the United States Treasury Department.

March 28 July 1

Banks and Banking - Reports to be Furnished Bank Commissioner - Amends the law concerning reports to be furnished the bank commissioner with respect to the signing of such reports. Formerly the report was required to be signed by two officers of the bank. The amendment provides that either the president, vice-president, cashier or secretary may sign the report.

120 Banks and Banking - Consolidation, Merger and Conversion of Banks - Repeals the present law relating to the consolidation of banks, trust companies and banking associations and provides a new procedure for the merger and conversion of banks. State and national banks may enter into a merger agreement, which must be approved by a 2/3 vote of the stockholders and by the bank commissioner. State banks may convert to a national bank and vica versa.

Banks and Banking - Loans on Real Estate - Amends the present law concerning the maximum loans which may be made on real estate by savings banks.

Formerly a savings bank was restricted in that real estate loans could not exceed fifty percent of its savings deposits. Now the restriction is sixty percent of the bank's time and savings deposits.

Banks and Banking - Certificate of Authority of Industrial Banks - Provides that the state bank commissioner shall issue a certificate of authority before any newly organized industrial bank is permitted to do business. If the commissioner refuses to issue a certificate, a board consisting of the Governor, Attorney General and State Treasurer may hold a hearing to determine to question of issuance of said certificate. Also makes provision for the filing of amendments to the certificate of incorporation.

In cases of multiple election of candidates, the instruction on the ballot will read, "Vote for not more than four" and the like. No title or degree of a candidate may appear on the ballot. In cases where two rows of names of candidates appear on the ballot, the rows are to be alternated in the even and odd numbered precincts.

155 <u>Irrigation - Retirement of Irrigation District Bonds -- Provides for an action to be filed in district court whereby an irrigation district may be dissolved and the bonds retired, if the bonds are unregistered and the holders thereof are unknown. After notice published, the court may order dissolution and cancel the bonds. Unpaid funds are distributed to any person presenting the bonds on a pro rata basis after a ninety-day notice.</u>

170 Chattel Mortgages - Filing of Mortgage Statement — Provides for the filing of a chattel mortgage statement by a person contemplating receiving a chattel mortgage on items held for sale or to be processed and become component parts of another product, except agricultural products, in which event, any chattel mortgages subsequently executed within one year from the filing of the mortgage statement on property described therein are valid without the necessity of filing or recording the same, but a purchaser in the ordinary course of business acquires title free and clear. Further provides for the release of such statements and the fees to be charged.

171 Corporations - Purchase of Own Stock - Amends the present law concerning the purchase by a corporation of its own stock by expanding the provisions of the law with respect to retirement of preferred or special stock. Such stock may be redeemed if done so in accordance with the conditions and limitations set forth in the act.

172 <u>Corporations - Preferred Stock Voting Power -- Amends the present law concerning amendment of certificate which would change the preferences of classes or special stock by providing that only the holders of the series of such stock affected by the proposed amendment shall be entitled to vote on its adoption.</u>

173 Corporations - Mortgage and Deeds of Trust Executed by Non-Profit Corporations and Cooperatives — Provides that any mortgage or deed of trust executed by a non-profit corporation or cooperative to secure a debt to the United States shall apply equally to the personal property. All after-acquired real and personal property shall be subject to the lien of any prior valid instrument and shall constitute notice with respect thereof to third parties.

174 <u>Corporations - Organization and Operation of Corporations - Adds a new sub-division with respect to cooperatives and provides for the organization and powers of the board of directors of a cooperative association relative to</u>

executing mortgages on real estate and amending the certificate of incorporation. Also amends the law concerning the corporate powers to be exercised by the board of directors of any corporation by providing that the members of the board of directors need not be stockholders in said company.

199 Racing - Length of Time of Racing Meets - Amends the present law concerning the length of time of holding a horse race meet by changing said period from twenty days to twenty-five days.

200 Revenue - Method of Assessment of Personal Property - Provides that livestock products temporarily sotred for hire in the course of trade shall not have a situs in such county for purposes of assessment for taxation and that no agent, bailee or consignee or such products shall be liable for such tax. 201 Statutes - Revision and Codification — Provides for a committee on statute revision, which committee shall apoint a revisor of statutes and the necessary associates to compile, edit and prepare for publication all laws of the state, annotations and indices. A report of the work done shall be made to the General Assembly in 1953 and the copyright of the 1953 Revised Statutes shall vest in the Secretary of State. Thereafter timely pocket supplements shall be prepared. A tax of\$1.00 is levied on each civil actions filed to finance such revision.

203 <u>Game and Fish - Reallocation of Game and Fish Funds -- Provides for a reallocation of appropriations to the Game and Fish Department from the Game Cash Fund.</u>

205 Bees and Beekeeping - Removal of Bees — Amends the present law concerning the removal of bees into Colorado by eliminating the provisions relating to state inspection, quarantine periods and inspection fees. At the present time, only a sixty-day certificate of inspection from the state of origin is necessary to bring bees into Colorado.

Provides that members of the State Board Commissioners shall receive an annual salary of \$5,500.00.

Revenue - Limitation of Action to Recover Land Sold for Taxes - Amends the present law pertaining to the rights of persons under disability to commence an action for the recovery of land sold for non-payment of taxes by providing that any person under legal disability, whether or not he resides in the United States, may bring a suit for the recovery of such lands within the period during which he had the right to redeem the land from the tax sale. Formerly the person under legal disability could commence such suit any time within one year after the disability was removed.

208 <u>Colorado State Patrol - Qualification of Patrolmen - Amends the present law concerning the qualifications of patrolmen of the Colorado State Patrol by extending the maximum age limitation of appointees from 33 to 36 years.</u>

Revenue - Redemption of Lands of Persons under Legal Disabilities Sold for Taxes - Repeals the present law which provides that persons who were under legal disabilities at the time the land was sold for taxes could recover the same at any time within one year from the removal of the legal disability, but provides for a six-month period from effective date during which recovery may be had in accordance with the section repealed.

212 <u>Mine and Minerals - Coal Mining Code</u> - Repeals all of the present statutes relating to coal mines and provides a completely revamped enactment in this respect. The act is 101 pages in length, and for that reason, a digest thereof would be impractical.

Insurance - Sickness and Accident Insurance -- Repeals the present law regarding sickness and accident insurance and provides complete regulations for sickness and accident policies and provides penalties for violations. Makes changes concerning the recitals to be contained in the policy, issuance of a policy to a non-resident assured, printing of the various provisions in the policy and other minor changes.

214 Income Tax - Exempt Organizations — Amends the present law concerning organizations exempt from income tax by adding a new subsection which provides that trusts which are exempt from federal income tax and which are created by employers as part of a bonus or pension plan for the exclusive benefit of the employees are exempt from taxation. Also provides that amounts distributed to any employee from such trust shall be included by the employee when reporting income.

216 <u>Trusts - Rule Against Perpetuities Not Applicable -- Provides that no trust created as part of a pension or bonus plan for the exclusive benefit of employees shall be invalid by reason of the application of the rule against perpetuities or any existing law.</u>

219 Children - Relinquishment of Children - Amends the present law concerning the relinquishment of minor children by providing that all relinquishments must be in accordance with the provisions of law. Provides that violations shall be a misdemeanor and punishable as such.

Adoption - Adoption of Minor Children - Amends the present law regarding adoption of minor children by eliminating the necessity for consent by natural parents in cases where there has been a voluntary failure to provide for a period of one year. Further provides that a decree may be granted forthwith in cases of a stepchild or grandchild being adopted or if the child being adopted is under the supervision of a child placement agency. Also gives the court discretionary power as to the time of granting a final decree of adoption. Provides that no natural parent shall be divested of any legal right or obligation when a child is adopted by a stepparent who is married to said natural parent. Records are no longer required to be sealed, but are confidential records of the court.

221 <u>County Government</u> - <u>Microfilming Records by County Recorder</u> -- Provides that the county recorder in counties over 100,000 in population may, with authority of the county commissioners, preserve all instruments filed for record by microfilming such records.

222 <u>Fees and Salaries - Fees of County Clerk and Recorder — Amends the present law concerning the fees to be charged by a county clerk and recorder by increasing such fees for filing papers, taking affidavits, recording town plats and the like.</u>

223 <u>Chattel Mortgages - Fees for Recording and Filing Chattel Mortgages - Amends</u> the present law concerning the fee to be charged for filing a chattel mortgage by increasing such fee from 50 cents to 75 cents.

Intoxicating Liquors - Regulation of 3.2 Beer -- Provides that the Secretary of State shall be in charge of enforcement of the provisions of law relating to the manufacture, sale and distribution of fermented malt beverages, which includes licensing power, authority to make general rules and regulations for proper regulation, but no power to fix prices or prevent advertising. Provides penalties for violations which are a maximum fine of \$300.00 or one year in jail or both, and discretionary power to revoke license.

228 <u>Crimes - Prohibits Possession and Sale of Push-Button Knives -- Provides that the sale, use and possession of pocket knives which have a mechanical contrivance that extends the blade is unlawful. Penalty for violation is \$300.00 fine or one year in jail or both.</u>

230 <u>Credit Unions - Merger of Credit Unions - Adds a provision to the present law concerning credit unions whereby two or more credit unions may merge upon</u>

approval thereof by 2/3 of the entire membership of each credit union concerned and the Bank Commissioner. Also makes minor changes with respect to the amount of the fee charged by the Bank Commissioner for examining books and records of credit unions. Also permits destruction of records after six years have elapsed and requires biennial verification of members' accounts.

236 Schools - Mill Levy -- Amends the present law concerning the maximum mill levy for support of county and union high schools by providing that such mill levy shall not exceed eight mills on the dollar for the years 1951-1953, inclusive, and that after 1953, such mill levy shall revert to a maximum of five mills.

Automobiles - Certificate of Title Act - Amends the present "Certificate of Title Act" pertaining to titles and mortgages of automobiles by providing that a duly executed copy of a certified copy of any mortgage may be presented to be recorded on the title. An application for re-issue of a lost title shall be made to the director rather than the agent. Fees for applications are increased from \$1.00 to \$1.25. A minor change is made in the disposition of fees collected.

247 Public Welfare - Allocation of Public Welfare Funds - Amends the present law concerning the allocation of public welfare funds by reducing the amount allocated to the Aid to Dependent Children account from \$1,800,000.00 to \$1,250,000.00, and by making increases in the Aid to the Blind account and the Child Welfare Services account. Also provides for \$500,000.00 per year for the Needy Disabled account.

248 <u>Public Land - Sale of Land of Soldiers' and Sailors' Home</u> — Authorizes the sale of 40 acres of farm land belonging to the Board of Commissioners of the Soldiers' and Sailors' Home. Proceeds to be paid into the general fund.

Weather Modification - Control of Artificial Weather Modification Practices - Provides for the creation of a five-member commission to make rules and regulations to control weather modification practices. The licensee must first report all weather modification operations. Provides for severe penalties for violations.

- 258 Game and Fish Control of Beavers Amends the present law concerning the control of beavers by providing that landowner may capture and pelt beavers on his own land if the Game and Fish Department does not make such capture within 24 hours after requested to do so. Provides that it shall be unlawful to Sell Filled Dairy Products —

Crimes - Insanity in Criminal Prosecutions -- Amends the present law concerning insanity of a person occurring subsequent to the commission of a crime, pronouncement of judgment and execution thereof by providing that the question of insanity be tried by a jury, and if the defendant be found to be insane, he shall be committed to an appropriate institution. If the head of the institution to which any such person is committed subsequently believes the person to be sane, such issue shall again be tried by a jury. Such trials are deemed civil proceedings and are governed by the applicable rules. Also provides for the instructions which shall be given the jury in each case. Further provides for the procedure to be taken in case of a plea of not guilty by reason of insanity at the time of the commission of the alleged offense, together with a plea of not guilty, in which case the defendant, after being examined by the authorities at the Colorado Psychopathic Hospital, shall be tried on the merits of the case. If found guilty, he shall then be tried on the issue of sanity and if found insane, he shall be committed to the Colorado State Hospital. If the defendant subsequently becomes sane, and is so determined by a court or jury, he shall thereupon be discharged.

285 <u>Drainage and Drainage Districts - Expenses of Directors of Drainage Districts</u>
Amends the present law concerning the per diem allowance for directors of the Grand Junction Drainage District while performing business of the district by increasing the same from \$4.00 to \$8.00 per day.

Automobiles - Temporary Certificates of Public Convenience and Necessity - Amends the present law concerning the issuance of certificates of public convenience and necessity by providing for the issuance of a temporary certificate not to exceed 90 days in cases in which the applicant desires to transport agricultural products to market or place of storage.

Schools - Education of Physically Handicapped and Mentally Retarded Minors - Amends the present law pertaining to the education of all handicapped children by providing that the Commissioner of Education may by regulation establish eligibility requirements for participants in program and make determination of the transfer of students between school districts. Reduces the amount of reimbursement for excess costs from \$500.00 per child in average daily attendance per year to \$100.00, and provides that all approved reimbursements be pro rated in case of insufficient appropriations.

Public Employees - Social Security Benefits - Enables the employees of any political subdivision to become entitled to the benefits conferred by the Federal Social Security Act, provided the plan submitted is approved by the Department of Unemployment Security and the Governor. Pertains to public employees except those covered by an existing retirement plan, elected officials, employees paid on a fee basis, certain officials and those employees not contemplated by the Federal Act. Provides complete procedure for administration.

Junior Colleges - Organization of Districts — Amends the present law concerning the organization of a junior college district by providing in detail the manner in which the election of members of the Junior College Committee shall be elected, the qualification of voters, judges for the election, ballots, notice of election and nomination of candidates. Repeals the provision providing for special assistants to the commissioner. Provides for an additional matter to be considered in the plan; that is, the director districts are to be provided to insure complete representation. Provides that the plan need not be approved by the commissioner before being submitted to a vote. If any plan is amended by the commissioner, the county committee shall have the right of final approval. Provides that only those districts voting affirmatively for the plan will become a part of the new district. Also if a majority vote in a school district included in the plan shall be not in favor of reorganization, continued efforts shall be made to provide a feasible plan. Any new district created shall have a board consisting of five members. Provides for the terms of the members of the board of directors of a new school district. Also makes several minor changes correcting mistakes in grammar and punctuation.

330 Schools - Pension for School District Employees - Provides for the extension of the provisions of the Public Employees Retirement Act to every school district in the state except those who have established a local retirement plan or who have previously affiliated with the state-wide retirement plan. 332 <u>Automobiles - Regulation of Installment Selling and Financing of Motor Vehicles</u> - Provides that all sales finance companies shall be licensed in order to do business. License may be revoked or suspended after proper hearing for violation of

the provisions of the act. Provides for requirements of all retail installment contracts, the main provisions of which are that no such contract shall be signed in blank, no provision for confession of judgment or power of attorney shall be contained therein, and limitation on amounts which can be collected for expenses and delinquencies. The contract must also recite the complete transaction including the amount and type of insurance coverage. Also provides that a retail buyer may at any time pay in full the balance of the contract price and receive credit for the unearned cost. Provides that violations shall be a misdemeanor and punishable by fine of not more than \$500.00.

334 <u>Public Employees - Credit for Military Service for Retirement Purposes - Provides that any member of the Public Employees Retirement System shall receive credit for retirement purposes for all the time spent on active service, if such employee returns to his former employment.</u>

Fugitives - Uniform Extradition Act - Repeals all of the present law relating to fugitives and enacts the Uniform Extradition Act which provides for a complete procedure for the arrest, confinement, and rendition of fugitives from justice. It is now possible for this state to surrender to the demanding state a person who was not present in the demanding state at the time of the commission of the crime. Preserves the right of the fugitive for application for a writ of habeas corpus. Also, any prisoner may be admitted to bail pending extradition proceedings.
