Review of the Statutory Revision Committee's Work³

The SRC met twice during the 2023 legislative session (March 9, 2023, and April 13, 2023). The members considered 11 bills; seven were approved for introduction and six were passed by the General Assembly and signed into law by Governor Polis.

Descriptions of Bills Approved for Introduction

S.B. 23-204 – Recommended by: Office of Legislative Legal Services

<u>H.B. 22-1301</u> enacted a property tax exemption for agricultural equipment that is used in any controlled environment agricultural facility; the bill states that the exemption is available "on and after January 1, 2023, but prior to January 2, 2028." However, the intent of the General Assembly was to allow the exemption for only five years. S.B. 23-204 bill corrects the defective date reference by changing the date from "prior January 2, 2028," to "prior to January 1, 2028." S.B. 23-208 – Recommended by: Department of Revenue

The bill corrects several defective cross references in the tax statutes. For a detailed description of the changes, see the <u>memo</u> distributed at the March 9, 2023, SRC meeting.

S.B. 23-209 – Recommended by: Office of Legislative Legal Services

The bill corrects an error made by <u>H.B. 22-1328</u> by removing the date restriction in the definition of "eligible borrower" used to determine a business's eligibility for a small business recovery loan under the "CLIMBER Act". SB 23-300 - Recommended by: Office of Legislative Legal Services

<u>H.B. 22-1034</u> merged three retirement plans administered by the fire and police pension association, the statewide defined benefit plan, the statewide hybrid plan, and the social security supplemental plan, into a single statewide retirement plan. The bill corrects certain statutory cross references that were not properly updated to reflect the repeals and relocations caused by this merge. While SB 23-300 was approved for introduction by the SRC, the Senate State, Veterans, and Military Affairs Committee postponed the bill indefinitely.

HB 23-1250 - Recommended by: Mr. Frank Sturgell, a private citizen

The bill corrects an incorrect citation concerning the attorney general's concurrent jurisdiction with the relevant district attorney over the regulation of architects. For a detailed explanation of the bill, see the memo distributed at the March 9, 2023, SRC meeting.

HB 23-1251 – Recommended by: Department of Revenue

The bill repeals several obsolete provisions in title 39, Colorado Revised Statutes. For a detailed description of the changes, see the <u>memo</u> distributed at the March 9, 2023, SRC meeting.

HB 23-1297 – Recommended by: Colorado Bar Association

The bill repeals the allowance for a corporation to issue a scrip in bearer form upon the holder surrendering enough scrip to equal a full share. For a detailed description of the issue, see the <u>memos</u> distributed at the April 12, 2023, SRC meeting.
