EXECUTIVE ORDER

STATE ADVISORY AND PLANNING COUNCIL TO THE COLORADO DEPARTMENT OF LABOR AND EMPLOYMENT, DIVISION OF EMPLOYMENT AND TRAINING



- WHEREAS, pursuant to the terms of the Comprehensive Employment and Training Act (CETA) of 1973 (P.L. 93-203), 29 U.S.C. 814, the State as the Prime Sponsor for the Balance of State (BOS) is required to establish a planning council to provide recommendations, monitoring and evaluations of employment and training programs in the BOS areas and for continuing analyses of needs for employment, training, and related services in these areas; and
- WHEREAS, under C.R.S. 1973, 8-72-105 (as amended by House Bill 1127, effective July 1, 1977) there exists an advisory council to the Division of Employment and Training, the members of which are selected to aid the Division in formulating policies and discussing problems related to the administration thereof; and
- WHEREAS, CETA requires the Governor to coordinate CETA programs and the State's manpower policies; and
- WHEREAS, it is vital that the State and its involved agencies closely coordinate all efforts to meet localized employment and training needs and that such needs be reflected in consciously integrated programs; and
- WHEREAS, confusion and duplication of efforts can be eliminated by facilitation of communication and coordination of the State's programs and planning efforts;
- NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, by virtue of the authority vested in me under the Laws of the State of Colorado, do hereby order and direct that:
1. A body known as the State Advisory and Planning Council (SAPC) to the Colorado Department of Labor and Employment, Division of Employment and Training (CDET) is hereby created whose purpose shall be to recommend policies, participate in planning and review problems relating to the administration of programs and funds administered by the CDET.

2. The SAPC shall be comprised of the members of the State Advisory Council (SAC) as established by statute, C.R.S. 1973, 8-72-105, as amended, and the members of the Balance of State/Manpower Planning Council (BOS/MPC).
3. The SAPC shall have such authority as derives from the applicable laws, rules and regulations and this Order. In any areas in which the State Advisory Council or the BOS/MPC have been given unique functions by law, e.g. approval by the SAC of expenditures out of the unemployment revenue fund, the single entity's members shall have the sole right to vote.
4. It is to be expressly understood that, without diminishing the importance of the role of the SAPC, this Order does not vitiate any of the decision-making rights or responsibilities of the Governor or the involved agency officials but is designed to create a single advisory council which can provide maximum input into the State's employment and training programs including developing recommendations for plans, in assessing the needs for services and for priorities by virtue of the consolidation of the two bodies, the SAC and the BOS/MPC.
5. The SAPC shall meet and operate in the manner and at such times as its members feel are appropriate, but either the Director of the CDET or the Governor are authorized to convene meetings or present requests for action.
6. Administrative support shall be provided through the auspices of the Director of the CDET as is deemed necessary or is appropriate recognizing budget, legal or other constraints.
