EXECUTIVE ORDER

COLORADO MAPPING ADVISORY COMMITTEE

- RECEIVED AUG COLORADO 91979 LIBRARY PROJECT MODE PROJECT
- WHEREAS, the second session of the Forty-ninth General Assembly has authorized the Division of Planning, Department of Affairs, to enter into a cooperative mapping agreement with the Geological Survey, U. S. Department of the Interior, and to contract for statewide aerial photographic coverage; and
- WHEREAS, several State, county and local agencies and regional organizations are users of cartographic and aerial photographic resources; and
- WHEREAS, there is a requirement for cartographic standards and specifications for these State, county and local agencies and regional organizations; and
- WHEREAS, there is a requirement for the standardization of Colorado geographic place and feature names; and
- WHEREAS, an advisory committee would provide appropriate coordination among interested groups and governmental agencies;

NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, by virtue of the authority vested in me under the laws of the State of Colorado, do hereby establish a Colorado Mapping Advisory Committee:

- A. The Committee would have the following responsibilities:
 - 1. Provide advice and counsel on cartographic matters to the State Cartographer who shall serve as chairman of the Committee;

- 2. Review the cartographic requirements of State agencies and make recommendations to the State Cartographer;
- 3. Assist in the development of recommendations for the standardization of Colorado geographic place and feature names;
- 4. Convene at the discretion of the State Cartographer annually in time to submit mapping priorities to the U.S. Geological Survey in compliance with OMB Circular A-16.
- B. The State Cartographer shall submit to the Governor a list of persons who would serve at the pleasure of the Governor. Said nominees to be selected from among the following agencies and organizations:
 - 1. Department of Agriculture.
 - 2. Department of Highways.
 - 3. Department of Local Affairs.
 - 4. Department of Military Affairs.
 - 5. Department of Natural Resources.
 - 6. Department of Regulatory Agencies.
 - 7. State Forest Service.
 - 8. State Historical Society.
 - 9. Regional, county and municipal organizations.
 - 10. The academic community.
 - 11. Technical organizations (private mapping sector),
- C. At least one non-voting technical advisor to be provided by the Geological Survey, U. S. Deparzment of the Interior.
