EXECUTIVE ORDER

GOVERNOR'S TASK FORCE TO IMPLEMENT SENATE BILL 79

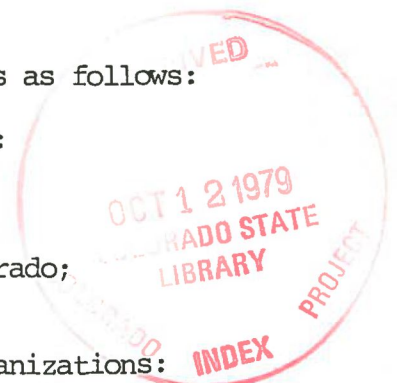
WHEREAS, Senate Bill 79, passed in 1979 by the General Assembly and signed into law on June 22, 1979, creates an independent public body corporate and politic known as the Fire and Police Pension Association, and

WHEREAS, The creation of the Association will require extensive preparations prior to January 1, 1980, (when the law becomes effective) but no provision was made in the act for pre-implementation activities; and

WHEREAS, The orderly and successful implementation of the Act is a matter of great concern to the Governor, the General Assembly, and the State;


NOW THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, by virtue of the authority vested in me under the laws of the State of Colorado, do hereby order and direct that:

1. There is hereby created a Governor's Task Force to Implement Senate Bill 79.
2. The Task Force shall receive support services from the Office of State Planning and Budgeting.
3. The Task Force shall consist of eleven members as follows:
 - A. Representing Colorado municipal employees:
 - (1.) Jerry Kempf of Denver, Colorado;
 - (2.) Cappie Fine of Boulder, Colorado;
 - (3.) John Tasker of Grand Junction, Colorado;
 - (4.) Kent Cooper of Greeley, Colorado;
 - B. Representing professional policemen's organizations:
 - (1.) Kenneth Harris of Denver, Colorado;
 - (2.) Ray Magan of Pueblo, Colorado;



- C. Representing professional firemen's organizations:
 - (1.) Richard Holck of Aurora, Colorado;
 - (2.) Fred Knowles of Grand Junction, Colorado;
 - D. Representing special districts:
 - (1.) F. A. "Bo" Frye of Evergreen, Colorado;
 - E. An individual selected from a list prepared by the representatives of municipal employers;
 - F. An individual selected from a list prepared by the representatives of professional policemen's organizations and professional firemen's organizations.
- 4. The term of the appointments shall be until January 1, 1980.
 - 5. As quickly as possible, the Task Force shall elect a chairman and vice-chairman, and appoint any necessary working committees.
 - 6. The Task Force shall meet as often as necessary to carry out their duties.
 - 7. The duties of the Task Force shall be to:
 - A. Provide policy direction to the interim administrator in carrying out his duties.
 - B. Undertake or approve the activities necessary to provide for the orderly and successful implementation of Senate Bill 79, including but not limited to:
 - (1.) A search for permanent executive staff,
 - (2.) Recommendations for the organization of the Board,
 - (3.) Recommendations for the organization of the procedure for conferring disability benefits.
