## EXECUTIVE ORDER

BOARD FOR ENERGY EFFICIENT NONRESIDENTIAL BUILDING STANDARDS TO THE COLORADO OFFICE OF ENERGY CONSERVATION

- WHEREAS, the continued conservation of energy resources accomplished in the design and construction of nonresidential buildings is of utmost importance to the people of this State; and
- WHEREAS, in 1977 the Colorado General Assembly enacted legislation establishing a Board for Energy Efficient Nonresidential Building Standards and directed it to promulgate energy efficient construction and renovation standards for nonresidential buildings, to act as a forum where construction, design and building officials meet, and to provide a complimentary program of training and technical assistance, and
- WHEREAS, the Board for Energy Efficient Nonresidential Building Standards has been a model of federal, state and local governments working in cooperation with private industry to successfully accomplish nonresidential building energy conservation; and

WHEREAS, this legislation is repealed on January 1, 1980;

NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, by virtue of the authority vested in me under the Laws of the State of Colorado, do hereby order and direct that effective immediately:

- 1. The Board for Energy Efficient Nonresidential Building Standards shall be established under the Colorado Office of Energy Conservation to advise that office, local governments, and the construction industry.
- 2. The Board shall consist of eight members appointed by the Governor to serve terms of two years each.
- 3. Membership on the Board shall be as follows: One member shall be a licensed architect, one a licensed mechanical engineer, and one a licensed electrical engineer, all of whom shall be experienced in energy efficient systems design of nonresidential buildings; one shall be a general contractor with experience in nonresidential building construction; one shall be a municipal building official; one shall be a building owner and manager with extensive knowledge of building codes; one shall be a bank, savings and loan, or mortgage banking officer with extensive knowledge of commercial loans; and one member shall be from the public at large with a general background in energy conservation.

- 4. Appointments shall be made from a list of three names submitted by each professional organization representing the professions named above, except the member representing the public at large, who shall be appointed by the Governor. If the Governor requires additional names, they may be selected from the represented professions.
- 5. The Board shall, by majority vote of all its members, elect its Chairman at its first meeting and biennially thereafter. Meetings of the Board shall be called by the Chairman.
- 6. Members shall be compensated by the Office of Energy Conservation for their services in the amount of thirty-five dollars per day and shall also be reimbursed for their actual expenses incurred while engaged in official duties.
- 7. The Board shall continue its activities subject to available appropriations.
- 8. The functions of the Board shall include:
  - A. Suggest amendments to the Energy Efficiency Construction and Renovation Standards for Nonresidential Buildings as the Board deems necessary to reflect the latest and most effective technology and design practices.
  - B. Monitor the activities of the building industry concerning energy efficient nonresidential building standards on the local, state and national levels, and act as a forum for these issues in Colorado.
  - C. Assist in the State effort to provide training and technical assistance to counties and municipalities, design professionals, construction industry, financial institutions and building owners and managers in the implementation of energy efficient construction and renovation standards for nonresidential buildings and encourage code uniformity in Colorado through the promulgation of minimum code regulations.
  - D. Assist in the State effort to develop complimentary training programs to be conducted by local governments, educational institutions and other public and private entities.
  - E. Help coordinate the development, adoption, publication, and distribution of the Colorado Model Energy Efficient Construction and Renovation Standards, and the preparation and publication of forms and procedures designed to ease the implementation process at the local level.
  - F. Monitor and evaluate effectiveness of energy standards and the program of training and technical assistance as it deems necessary.
  - G. Develop and promote recommended lighting standards for existing nonresidential buildings that reflect the latest and most efficient technology, and that are consistent with federal guidelines.
  - H. Coordinate with other buildings programs administered by the Colorado Office Of Energy Conservation to assure compatable goals, to share professional expertise, to avoid unnecessary duplication, to reduce administrative costs, and to maximize energy savings in buildings.

9. The Board for Energy Efficient Nonresidential Building Standards shall continue as established under this Order until July 1, 1985, unless otherwise mandated by the Governor or the Colorado General Assembly by appropriate action.
