EXECUTIVE ORDER

- WHEREAS, The State of Colorado is continually faced with a variety of problems as it struggles to deal with its potential growth and still maintain its unique environment; and
- WHEREAS, These problems do not exist in a vacuum, but are characterized by their complex interrelationships; and
- WHEREAS, The Governor's ability to address these issues depends upon the State's access to various scientific and technological resources; and
- WHEREAS, The Governor is committed to comprehensive solutions that incorporate long range planning systems, including secondary and tertiary results of present day decisions; and
- WHEREAS, Colorado is fortunate to have within its boundaries an excellent variety of public and private research institutions,

NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, by virtue of the authority vested in me under the laws of the State of Colorado do hereby create:

THE GOVERNOR'S SCIENCE AND TECHNOLOGY ADVISORY COUNCIL

- 1. Its responsibilities shall be as follows:
 - a. Provide a link between the scientific and technological resources available within the various public and private research institutions and state government. To that end, the members need to have specific knowledge of the expertise available at their respective institutions.
 - b. Relay to state government those issues identified within the scientific community that require the Council's attention.

- c. Establish task forces to address those issues referred by either the scientific community, state government, or the individual Council members.
- d. Designate individual members to serve as co-chairman of the various task forces in providing administrative type services, thus allowing the additional co-chairmen to be selected from the scientific community to serve as the "expert" in the appropriate field.
- e. Review the products of the task forces before they are submitted to the Governor to insure that the Council's directives have been met.

 - h. Dr. Floyd Mann Director Institute for Urban and Public Policy Research University of Colorado at Denver

- i. Dr. Robert Rycroft Assistant Professor Graduate School of International Studies University of Denver
- j. Dr. Evan Vlachos Professor of Political Science Colorado State University
- k. Dr. Richard T. Ward Professor of Plant Ecology Department of Botany and Plant Pathology Colorado State University
- 3. The Council members's terms shall expire one year from the date of this Executive Order.
- 4. Dr. Robert M. Lawrence shall serve as the Chairman of the Council.
- 5. Leonard Slosky, Assistant to the Governor for Science and Technology, will serve as Executive Director.
- 6. The staff of the Office of Intergovernmental Relations will provide administrative assistance.
