## EXECUTIVE ORDER

### COLORADO PRIVATE INDUSTRY COUNCIL

WHEREAS, the participation of private sector employers is necessary for the planning, design and operation of quality employment and training programs; and

WHEREAS, it is necessary to determine the demand for occupations in growth industries; and

WHEREAS, coordination of employment and training programs with private sector employers is an important element in the economic development of local communities; and

WHEREAS, Federal regulations encourage coordinated efforts between State and Federal agencies to establish employment training programs with private sector contractors;


NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, by virtue of the authority vested in me under the Laws of the State of Colorado, do hereby order that:

1. This order amends Executive Order #B1179 signed September 4, 1979, establishing the Colorado Private Industry Council, hereinafter referred to as the Colorado PIC.
2. The Colorado PIC shall receive support services from the Department of Labor and Employment, Balance of State/CETA Unit.
3. The Colorado PIC shall consist of not fewer than fifteen (15) members appointed by the Governor.
4. Members shall be appointed such that all members shall serve 2 year terms, with one half of the members' terms expiring September 4 of each year. Vacancies shall be filled as determined by the PIC by-laws.
5. All members serving on the Colorado PIC shall continue to serve for the remainder of their terms on the effective date of this Executive Order and may be reappointed thereafter.
6. The Colorado PIC shall elect a chairperson to serve for one year.
7. The purpose of the Colorado PIC shall be to :
  - A. Increase the involvement of the business community in the employment and training activities of the Balance of State/CETA Unit by:

- (1) Presenting the private sector's recommendations for making programs more responsive to local employment needs; and
  - (2) Advising Balance of State/CETA as to ways of increasing private sector job placements;
- B. Assist with design and development of the Title VII Program by:
- (1) Providing an analysis of private sector job opportunities by occupation, industry and location;
  - (2) Exploring training possibilities that meet long and short term local employment needs;
  - (3) Establishing specific private sector employment and training projects; and
  - (4) Encouraging a coordinated effort within the private sector for training and employment in communities that are targeted economic growth areas.
- C. Provide, on a continuing basis, a review and assessment of the activities of the Title VII Program;
- D. Coordinate planning efforts with local community development groups and other State agencies involved in the economic development of Colorado communities;
- E. Act in an advisory role in the administration of program resources including Titles II B/C and IV A of CETA regulations, duties which were previously performed by State and Area advisory councils which were abolished by Executive Order #B00381 signed February 5, 1981.
8. The expiration date of this Order shall coincide with the expiration of the Comprehensive Employment and Training Act, as amended.
