EXECUTIVE ORDER

THE ASSIGNMENT OF CARTOGRAPHIC RESPONSIBILITIES AND

INSTITUTIONALIZATION OF THE COLORADO MAPPING ADVISORY COMMITTEE

WHEREAS,

REAS, the second session of the Forty-Ninth General Assembly has authorized the Division of Planning, Department of Local Affairs, to enter into a cooperative mapping agreement with the Geological Survey, U.S. Department of the Interior, and to contract for state-wide photographic coverage; and

- WHEREAS, several State agencies and regional, county, local and private organizations are users of cartographic and aerial photographic resources; and
- WHEREAS, there is a requirement for cartographic standards and specifications for State agencies, regional, county and local organizations; and
- WHEREAS, the State Cartographer has been assigned to the Division of Planning, Department of Local Affairs;

NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, by virtue of the authority vested in me under the laws of the State of Colorado, do hereby direct:

- The Division of Planning, Department of Local Affairs, shall be responsible for the following cartographic duties:
 - a. Consult, advise and assist State agencies and regional, county and local organizations on cartographic and aerial photographic resources and provide technical assistance on the utilization of these resources;
 - b. Coordinate and monitor cooperative mapping agreements among government agencies and provide liaison between the Colorado mapusing community and the Federal map-making community.
 - c. Provide official base maps and maintain indexes of cartographic and aerial photographic resources;
 - d. Provide state-wide, high-altitude aerial photographic coverage and coordinate regional aerial photographic projects;
 - e. Coordinate high-altitude remote sensing projects;
 - f. Develop and maintain standards and criteria for the cartographic display of automated mapping and geo-coding systems; and
 - g. Coordinate the preparation of budgets for all State mapping needs.

- 2. There is hereby established a Colorado Mapping Advisory Committee with the following responsibilities:
 - Provide guidance and assistance to the State Cartographer, Division of Planning, Department of Local Affairs in cartographic and related matters;
 - b. Review mapping needs of State agencies and make recommendations to the State Cartographer;
 - c. The State Cartographer shall serve as Chairman of the Colorado Mapping Advisory Committee:
 - d. The Colorado Mapping Advisory Committee will convene annually in time to submit mapping priorities to the U.S. Geological Survey. Additional meetings will be convened at the discretion of the State Cartographer.
- 3. The State Cartographer shall annually submit to the Governor a list of persons for appointment to the Colorado Mapping Advisory Committee. Members of the Committee shall be selected from among the following agencies and organizations:
 - a. Department of Agriculture

- b. Colorado Land Use Commission
- c. Colorado State Forest Service
- d. Department of Highways
- e. Department of Local Affairs
- f. Department of Natural Resources
- g. Regional, county and municipal agencies and organizations
- h. The academic community
- i. Scientific and technical mapping societies
- j. The private mapping sector
- 4. At least one non-voting technical advisor to be provided by the Geological Survey, U.S. Department of the Interior.
- 5. This Order shall take effect of July 1, 1977.
