## EXECUTIVE ORDER

## CREATING THE OFFICE OF ENERGY CONSERVATION

WHEREAS, the demand for, and the availability of energy is an issue of vital concern to the State and Nation; and

WHEREAS, energy prices are of great concern to all sectors of the state economy; and

WHEREAS, increasing the energy efficiency in residential, commercial, industrial and governmental buildings is a cost-effective method to assure an adequate energy supply in the state; and

WHEREAS, there is needed a central agency in the state government charged with the responsibility for coordinating policy and planning aspects of energy supply and energy conservation; and

WHEREAS, such agency is needed to coordinate energy programs and information for state government; and

WHEREAS, a focus is needed for the implementation of state energy policy and state elements of national energy policy;

NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, pursuant to the power vested in me by Article IV of the Colorado Constitution, DO HEREBY ORDER THAT:

1. The Colorado Office of Energy Conservation is created within the Office of the Governor, effective July 1, 1981.
2. The Colorado Office of Energy Conservation shall be located for administrative purposes within the Department of Regulatory Agencies.
3. The functions of the Office include the following:
  - a. Administer and implement the Colorado Energy Conservation Plan, which was prepared in response to and is funded by PL 94-163 and PL 94-385 of the 94th Congress, as well as the state's energy contingency plan.
  - b. Serve as a clearinghouse and referral center for energy information, state energy data and information concerning renewable energy technologies.
  - c. Coordinate with designated departments of state government energy conservation activities internal to state government, including state buildings and purchasing.
  - d. Work with the Department of Social Services, Department of Local Affairs, Department of Labor and Employment, the Public Utilities Commission and other state agencies to develop a plan to coordinate the delivery of energy conservation programs, energy assistance programs, weatherization programs and utility conservation programs, and to develop strategies to assist homeowners, renters and landlords, as well as Coloradans on low and fixed incomes, with increasing energy costs.
  - e. Provide information, training and technical assistance to



Coloradans through the Energy Extension Centers currently located in Grand Junction, Colorado Springs, Pueblo, Aspen, Greeley, Durango, Boulder and the San Luis Valley.

- f. Assist Colorado Business for Energy Conservation, a committee of concerned businessmen, in their efforts to help small businesses cut energy consumption in small and medium-sized businesses in the state.
  - g. Maintain the Institutional Building Grants Program in an effort to provide financial assistance to schools, hospitals, local governments and health care institutions for energy conservation projects.
  - h. Provide advice and counsel to the Governor and the Colorado General Assembly regarding appropriate state policy to encourage energy conservation and alternative energy technologies.
4. There shall be a Director of the Office, to be appointed by the Executive Director of the Department of Regulatory Agencies. The Office of Energy Conservation Director is authorized to hire such staff and make other expenditures as may be allowed by funds available to the Office, including federal grants and private donations that may be received.
5. The Office shall terminate on December 31, 1982, unless extended by Executive Order.
