WHEREAS, on May 8, 1974, an Executive Order was first issued to allow the State of Colorado to participate as a Prime Sponsor under the Comprehensive Employment and Training Act of 1973 (CETA), Public Law 95-524; and

WHEREAS, the original Executive Order of May 8, 1974, and subsequent modifications thereto, were rescinded by the Executive Order of February 27, 1976, establishing the current Divisions within the Department of Labor and Employment, subsequently amended by the Executive Order of June 1, 1977, transferring the CETA Special Grant operation to the Human Service Policy Council office in the Office of the Governor; and

WHEREAS, The CETA Special Grant Program to the Governor established by the Comprehensive Employment and Training Act of 1973 and governed by federal regulations 29 CFR was transferred to the Office of the Executive Director, Department of Labor and Employment through an Executive Order dated November 1, 1977; and

WHEREAS, administrative responsibility for the CETA Governor's Special Grant established by the Comprehensive Employment and Training Act of 1973 and governed by federal regulations 29 CFR was delegated to the Office of Manpower Planning and Development, under the Office of the Executive Director, Department of Labor and Employment through an Executive Order dated February 22, 1979 (D006 79); and

WHEREAS, it is necessary to update the Executive Order dated February 22, 1979 with respect to references to Section 204 of the (CETA) Act.

NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, pursuant to authority vested in me under the statutes and constitution of the State of Colorado, DO HEREBY ORDER THAT:


1. The Executive Order dated February 22, 1979, is rescinded.
2. The CETA Special Grant Program (Governor's Coordination and Special Services, Sec. 105 CETA Amendments of 1978) shall be developed and administered by the Office of Manpower Planning and Development under the Office of the Executive Director, Department of Labor and Employment; the Colorado Employment and Training Council (CETC), (State Employment and Training Council, Sec. 110, CETA Amendments of 1978) shall be staffed by the Office of the Executive Director, Department of Labor and Employment.
3. The Office of Manpower Planning and Development shall be appropriately staffed by the Office of the Executive Director, Department of Labor and Employment, at his direction or that of his designee(s).
4. The primary responsibility of the CETC will be to advise the Governor on the development of state employment and training policies and strategies that promote effective inter-governmental and inter-agency coordination and delineate priority employment and training concerns in Colorado. The CETC shall also provide overall review and evaluation of employment and train-

ing programs in Colorado including CETA Prime Sponsors and state agencies consistent with the Comprehensive Employment and Training Act.

5. The Colorado Employment and Training Council shall continue to be appointed by the Governor pursuant to the terms and for the purposes set forth in Section 110 of the (CETA) Act.
6. The Colorado Employment and Training Council will coordinate with all other employment and training advisory councils in the State including the Statutory Advisory Council (SAC), which provides advice on all aspects of the operation of the Division of Employment and Training under the Employment Security Act; and the Private Industry Planning Council (PIPC), which provides advice to the Balance of State Program under the Office of the Executive Director, Department of Labor and Employment.
7. The Office of Manpower Planning and Development within the Office of the Executive Director, Department of Labor and Employment, shall be responsible for the development and coordination of state employment and training policies and coordination of CETA and vocational education activities, especially the Supplemental Vocational Education Program provided under the (CETA) Act; and shall administer and provide grant management of the activities covered by Section 105 and Section 204 of the (CETA) Act.
8. The Executive Director of the Department of Labor and Employment is delegated contracting authority and responsibility for all grants and agreements executed pursuant to Section 105 and Section 204 of the (CETA) Act.
