## EXECUTIVE ORDER

### EMERGENCY FOOD AND SHELTER PROGRAM

WHEREAS, the state has received \$453,100 in funds under the Emergency Food and Shelter Program from the Federal Emergency Management Agency (FEMA) under the Jobs bill of 1983 (PL 98-8) to provide emergency food and shelter services to meet urgent food and shelter needs within Colorado; and

WHEREAS, FEMA has developed an Emergency Food and Shelter Program Plan, April 1983, hereinafter referred to as the FEMA Plan, to set forth the guidelines for the program; and

WHEREAS, the FEMA Plan specifies that the state must select recipient organizations for the target areas, such organizations to be private, non-profit organizations or local units of government. In making this selection, the state must consider the demonstrated capability of the organization to provide food and shelter assistance in a timely and efficient manner; and

WHEREAS, these funds must be expended no later than September 30, 1983; and

WHEREAS, the state may expend up to 1 percent of available funds for the required federal audit of the program;

NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, by virtue of the authority vested in me under the statutes and constitution of the State of Colorado, DO HEREBY ORDER THAT:

1. The Colorado Department of Social Services shall, on my behalf, accept funds made available to Colorado under the Emergency Food and Shelter Program established by PL 98-8, and administer the program under the terms of PL 98-8 and the FEMA Plan.
2. George S. Goldstein, Executive Director of the Department of Social Services, shall be my authorized representative for the administration of this program.

3. The following counties and Indian reservations are designated as target areas for the program, based upon most critical need as demonstrated by short and long-term unemployment and poverty; each target area shall receive an allocation of funds as specified below:



4. \$4,531 is set aside for the required federal audit of the program.
5. Local agencies for administration of this program shall be the boards of county commissioners in the case of targeted counties, and tribal councils in the case of Indian tribes.
6. The Department of Social Services shall negotiate contracts with the local agency in each target area to provide for administration of this program consistent with PL 98-8 and the FEMA plan, and shall monitor the performance of the local agencies to ensure that such agencies comply with the terms of such contracts.
7. Should a county or tribe choose not to participate in this program, the Department of Social Services shall, if feasible, select another local agency in the targeted area to administer the program or shall reallocate the funds to other targeted areas.

This order shall take effect on June 6, 1983.
