## EXECUTIVE ORDER

DISTRIBUTION OF STANDARD OIL COMPANY (INDIANA) AND BELRIDGE OIL COMPANY OIL OVERCHARGE REFUNDS

- WHEREAS, the Department of Energy entered into consent agreements with Standard Oil Company (Indiana) and Belridge Oil Company which provided that states will be permitted to submit plans for the use of these funds; and
- WHEREAS, Colorado's allocation of the Standard Oil Company (Indiana) consent agreement is \$387,135; and
- WHEREAS, Colorado's allocation of the Belridge Oil Company consent agreement is \$1,254; and
- WHEREAS, the Department of Energy has indicated the plans submitted by the state should benefit purchasers of motor gasoline and middle distillate within those jurisdictions;

NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, pursuant to the consent agreements mentioned above, DO HEREBY ORDER THAT:

- 1) \$65,000 is to be used for energy conservation as it relates to utility regulation. This money will be distributed to the Department of Regulatory Agencies.
- 2) \$35,000 is to be used for policies affecting the procurement practices of the state and its political subdivisions to improve energy efficiency. This money will be distributed to the Department of Administration.
- 3) \$23,000 is to be used for projects related to improved energy efficiency as it relates to the transportation sector. This money will be distributed to the Department of Highways.
- 4) \$50,000 is to be used for projects related to the Energy Extension Service program. This money will be distributed to the Office of Energy Conservation.

- 5) \$60,000 is to be used for energy conservation projects related to improved energy efficiency in schools, as defined in the state Energy Conservation Program. This money will be distributed to the Governor's Job Training Office.
- 6) \$42,500 is to be used for a furnace retrofit program, under the guidelines of the Low Income Energy Assistance Program. This money will be distributed to the Office of Energy Conservation.
- 7) \$112,889 is to be used for programs as defined in the state Energy Conservation Program, including activities relating to energy conservation in local governments, residential buildings, state buildings, transportation and others. This money will be distributed to the Office of Energy Conservation.
- 8) These funds will be distributed in the manner outlined in this Executive Order upon approval of the State Plan by the Department of Energy. The Office of Energy Conservation is hereby directed to formulate a State Plan which incorporates the elements outlined herein and to work with the Department of Energy to obtain approval of the State Plan.
