## EXECUTIVE ORDER

TO AMEND EXECUTIVE ORDER NUMBER D0028 84 THAT  
ESTABLISHED AN ALLOCATION PROCESS FOR THE STATE CEILING  
ON PRIVATE ACTIVITY BONDS

WHEREAS, Section 7 of Executive Order Number D0028 84, dated September 5, 1984, reserved the Governor the right to modify the allocation method set forth in Section 3 of said Executive Order, so as to comply with any provision of the Federal Act, as defined in Executive Order Number D0028 84, and regulations pursuant thereto;

NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, by virtue of the authority vested in me under the Constitution and laws of the State of Colorado and under Section 621 of the Federal Act, and pursuant to regulations issued by the U.S. Treasury Department that are applicable to the Federal Act, hereby proclaim the following amendment to Executive Order Number D0028 84, dated September 5, 1984:

### Section 1

Amendment to Executive Order Number D0028 84, Dated September 5, 1984

Section 3 is amended by the addition of a new paragraph D to read:

D. ANY UNALLOCATED PRIVATE ACTIVITY BONDS ISSUANCE AUTHORITY REMAINING IN THE STATEWIDE BALANCE AS OF DECEMBER 28, 1984, SHALL BE ALLOCATED TO THE COLORADO STUDENT OBLIGATION BOND AUTHORITY FOR THE PURPOSE OF SAID AUTHORITY CARRYING FORWARD INTO CALENDAR YEAR 1985 ALL SUCH AUTHORITY FOR THE PURPOSE OF ISSUING STUDENT OBLIGATION LOAN BONDS. NO OTHER PROVISIONS OF THIS EXECUTIVE ORDER REGARDING PROCEDURE FOR APPLICATION FOR OR CARRYFORWARD OF ISSUANCE AUTHORITY SHALL BE APPLICABLE TO THIS ALLOCATION OF THE STATEWIDE BALANCE REMAINING AS OF DECEMBER 28, 1984, TO THE COLORADO STUDENT OBLIGATION BOND AUTHORITY.


