EXECUTIVE ORDER

REVISION OF STATE POLICY RELATIVE TO STATE AIRCRAFT POOL

WHEREAS, the people of Colorado require that their government continuously strive to improve and streamline the operations of state government in order that more effective service can be rendered at less cost to the taxpayer; and

WHEREAS, many agencies who do not now have assigned aircraft can make effective and economical occasional use of centrally pooled aircraft; and

WHEREAS, it is in the public interest that certain state aircraft be under central control, and all pilots of these aircraft shall have met rigid standards to assure their proficiencies to all passengers;

NOW, THEREFORE, in order to promote greater efficiency and lower operating costs, and to provide for the availability of aircraft transportation for prudent use by all state officials in the exercise of their duties, I, Richard D. Lamm, Governor of the State of Colorado, by virtue of the authority vested in me under the laws of the State of Colorado, DO HEREBY ORDER THAT:

1. The Department of Public Safety shall maintain and operate a central aircraft pool for the benefit and combined needs of all state agencies. Providing aircraft services to all state agencies in a timely, efficient, safe and economical manner shall be the principal objective of the pool. All aircraft presently owned and operated by the Department of Public Safety shall be included in the pool. Agencies using pooled aircraft are to be billed by the Department of Public Safety for service received.
2. In operating the aircraft pool, the Department of Public Safety shall: develop and promulgate operating and safety criteria for all state-owned aircraft; constantly strive to improve the pool's aircraft; negotiate and arrange for the inclusion of other state-owned aircraft into the pool; monitor the utilization and make recommendations designed to improve the operation of all state-owned or leased



aircraft; maintain records detailing the utilization and productivity of the state-owned or leased aircraft.

3. No State agency may charter aircraft without the prior approval of the Department of Public Safety. The Department of Public Safety shall approve such a request only when they are unable to provide the needed service through the resources of their aircraft pool.
4. No state agency may purchase or lease any aircraft without the prior approval of the Department of Public Safety, regardless of source of funds. This includes the purchase or lease of any replacement aircraft for those presently operated by state agencies.
5. All state departments, agencies, and institutions shall cooperate with the Department of Public Safety's efforts to accomplish the intent of this order.
6. This order supersedes my Executive Order of 1975 on this subject and shall take effect January 1, 1986.
