EXECUTIVE ORDER PROCLAMATION CALL FOR SECOND EXTRAORDINARY SESSION OF THE FIFTY-FIFTH GENERAL ASSEMBLY

WHEREAS, Section 9 of Article IV of the Constitution of the State of Colorado provides that "The Governor may, on extraordinary occasions convene the General Assembly, by Proclamation, stating therein the purpose for which it is to assemble; but at such special session no business shall be transacted other than that specially named in the proclamation," and Section 7 of Article V of the Constitution provides that "The General Assembly shall meet at other times when convened in special session by the Governor;" and

WHEREAS, in the opinion of the Governor, an extraordinary occasion has arisen because the Colorado General Assembly did not authorize the Governor by specific legislation to take actions required to finalize all accounts of the State for fiscal year 1985-86, although such accounts must be finalized within forty-five days after the end of the fiscal year as required by 24-75-102, C.R.S.; and

WHEREAS, other matters, enumerated below, require the attention of the General Assembly, and therefore, in the opinion of the Governor, represent business to be transacted during this special legislative session;

NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, do by this proclamation convene the Fifty-Fifth General Assembly of this State, and hereby summon the members thereof to meet in Special Session at the State Capitol, in the City and County of Denver, on the eighth day of August, A.D. 1986, at 10:00 a.m. and hereby designate the following subjects for your consideration and appropriate legislative action:

1. Concerning the Closing of the Books for the 1985-86 Fiscal Year of the State, Making Various Transfers Between Appropriations, and Adjusting The Federal Fund Amounts Relating To Reductions In The Federal Budget Without Affecting Total General Fund Appropriations for Said Fiscal Year.
2. Concerning Restoration of Moneys to the Severance Tax Trust Fund from the General Fund for transfer to the Capital Construction Fund.
3. Concerning a Delay in Repayment from the General Fund to the Water Conservation Board Construction Fund.

4. Concerning the Eligibility of Active Duty Members of the Armed Forces and Their Dependents Stationed in Colorado for In-state Tuition Classification at Institutions of Higher Education and Making an Appropriation in Connection Therewith.

12. Concerning Conforming the Delay for Remittance of the Excise Tax Due by Cigarette Wholesalers Using Metering Machines in Lieu of Stamps With the Delay for Wholesalers Purchasing Stamps as Enacted in House Bill 1340 at the 1986 Regular Session.


