EXECUTIVE ORDER

DISTRIBUTION OF OIL OVERCHARGE FUNDS ALLOCATED TO STATES AS THE RESULT OF STRIPPER WELL EXEMPTION LITIGATION, M.D.L. 378

WHEREAS, the United States District Court for the District of Kansas issued an Order approving the Settlement Agreement in In Re Department of Energy Stripper Well Exemption Litigation, M.D.L. 378, providing for the distribution of oil overcharge funds resulting from overpricing of petroleum products; and

WHEREAS, Colorado received \$7,817,706 under the provisions of the Settlement Agreement and Order; and

WHEREAS, the Settlement Agreement and Order provides that the funds shall be used in:

- 1) programs eligible for funding under the Exxon settlement;
- 2) programs eligible for funding under the consent order which the Department of Energy entered into in 1981 with Standard Oil Company of California (Chevron);
- 3) programs approved by the Office of Hearings and Appeals in Subpart V refund proceedings;
- 4) such other restitutionary programs as may be approved by the District Court; and

WHEREAS, the Settlement Agreement and Order provides for these funds to be distributed to the Governor or Chief Executive Officer of the states, the District of Columbia, the Commonwealth of Puerto Rico, and the territories and possessions of the United States; and

WHEREAS, it is incumbent upon the Governor or Chief Executive Officer to distribute these funds in a manner that will benefit those who may have been injured by the overcharges;

NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, pursuant to the Settlement Agreement and Order of the United States District Court for the District of Kansas, DO HEREBY ORDER THAT:

- 1) \$1,350,000 be distributed to the University of Colorado and Colorado State University to establish a joint center for energy management, with the amount reserved subject to negotiation;
- 2) \$1,250,000 be distributed to The Denver Partnership for the engineering efforts associated with the cross mall transit connections which are a part of the Downtown Area Plan, subject to the condition that privately raised funds be available for construction purposes;
- 3) \$1,000,000 be distributed to the Department of Local Affairs for low-income weatherization;
- 4) \$530,000 be distributed to Region 10 Economic Development District for an energy retrofit loan program;
- 5) \$435,000 be distributed to Longmont United Hospital for a cogeneration project;
- 6) \$326,784 be distributed to the City of Arvada for the Home Energy Savers Package loan program;
- 7) \$300,000 be distributed to the Greeley Urban Renewal Authority for a program to increase the energy efficiency of homes;
- 8) \$300,000 be distributed to the City of Ouray for a geothermal district heating project;
- 9) \$284,950 be distributed to St. Mary-Corwin Hospital Regional Health Center to retrofit hospital equipment and to install an automated building control system;
- 10) \$261,600 be distributed to North Colorado Medical Center for a cogeneration project;
- 11) \$257,660 be distributed to the University of Denver (Denver Research Institute) for remote sensing of automobile pollution levels;
- 12) \$250,000 be distributed to Indian Tribes, with the projects to be funded to be negotiated;
- 13) \$242,176 be distributed to Enertech Thermodynamics for installation of wind machines at Akron and Rocky Ford;
- 14) \$185,000 be distributed to Poudre Valley Hospital for an energy management system;

- 15) \$174,288 be distributed to Trinidad Area Health Association for a cogeneration project;
- 16) \$157,632 be distributed to St. Joseph Hospital for an energy management system;
- 17) \$150,000 be distributed to Conejos County Hospital for a senior citizen transportation program;
- 18) \$100,000 be distributed to Platte River Power Authority for a photovoltaic demonstration project;
- 19) \$63,619 be distributed to the Town of Fleming for a program which will reduce energy demand and costs for town residents;
- 20) \$56,610 be distributed to the Alamosa Community Hospital for a summer boiler;
- 21) \$50,000 be distributed to the Denver Metro Air Quality Council to continue the work of the organization in reducing energy consumption and air pollution;
- 22) \$44,800 be distributed to the Pueblo Senior Citizen Resource Development and Coordinating Agency to provide transportation services to elderly, handicapped and low-income citizens;
- 23) \$15,000 be distributed to the Roaring Fork Energy Center for a program to reduce the interest rate on energy conservation loans;
- 24) \$11,827 be distributed to Pueblo School District No. 70 for a solar greenhouse education project;
- 25) \$10,200 be distributed to the Town of Eagle to retrofit a streetlight system;
- 26) \$5,300 be distributed to Navajo Trail Campground for a geothermal demonstration project;
- 27) \$4,160 be distributed to the Town of Rico for energy-efficient doors and windows for the town fire station;
