## EXECUTIVE ORDER

DISTRIBUTION OF OIL OVERCHARGE FUNDS ALLOCATED TO STATES  
AS THE RESULT OF THE STIPULATION AND ORDER OF THE  
U.S. DISTRICT COURT FOR THE SOUTHERN DISTRICT OF OHIO  
EASTERN DIVISION OF JUNE 8, 1986

WHEREAS, the U.S. District Court for the Southern District of Ohio Eastern Division, in a Stipulation and Order of June 8, 1986, provided for the distribution of escrow funds in Diamond Shamrock Refining and Marketing Co. v. Standard Oil Co., et. al., C.A. No. C2-84-1432; and

WHEREAS, Colorado received \$523,697 under the provisions of the Stipulation and Order; and

WHEREAS, the Stipulation and Order provides that funds received pursuant to the Stipulation may be used for administrative expenses, including the payment or reimbursement of attorneys' fees, expert witness' fees, contractual obligations and other related costs incurred in pursuing claims for these and other crude oil overcharges, up to five percent of the total funds received by the state for these and other crude oil overcharges; and

WHEREAS, the amount received by Colorado under the provisions of the Stipulation and Order, with the accrued interest earnings, does not exceed five percent of the total funds received by the State for crude oil overcharges; and

WHEREAS, the Stipulation and Order provides for these funds to be distributed to the Governor or Chief Executive Officer of the states, the District of Columbia, the Commonwealth of Puerto Rico, and the territories and possessions of the United States; and

WHEREAS, it is incumbent upon the Governor or Chief Executive Officer to distribute these funds in a manner that will benefit those who may have been injured by the overcharges;

NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, pursuant to the Stipulation and Order of the United States District Court for the Southern District of Ohio Eastern Division,


