EXECUTIVE ORDER

DISTRIBUTION OF OIL OVERCHARGE FUNDS UNDER THE DECISIONS AND ORDERS OF THE DEPARTMENT OF ENERGY FOR THE COLINE GASOLINE CORPORATION, MAY 21, 1985, OKC CORPORATION, DECEMBER 13, 1985, AND STANDARD OIL COMPANY (INDIANA), APRIL 24, 1986

- WHEREAS, Colorado has received \$1,214.26 under the provision of the Decision and Order of the Department of Energy for the Coline Gasoline Corporation of May 21, 1985; and
- WHEREAS, Colorado has received \$42,792.00 under the provision of the Decision and Order of the Department of Energy for the OKC Corporation of December 13, 1985; and
- WHEREAS, Colorado has received \$402,195.00 under the provision of the Decision and Order of the Department of Energy for the Standard Oil Company (Indiana) of April 24, 1986; and
- WHEREAS, the Department of Energy has indicated the plan submitted by the State will benefit purchasers of motor gasoline and middle distillates;

NOW, THEREFORE, I, Richard D. Lamm, Governor of the State of Colorado, pursuant to the above mentioned Decisions and Orders of the Department of Energy DO HEREBY ORDER THAT:

1) \$85,000.00 is to be allocated to Special Transit Systems for a pilot program designed to demonstrate the ability of a special transit district to become more financially self-sufficient.

2) \$26,690.00 is to be allocated to Servicios de la Raza for the purchase of a 15-passenger van to be used to provide transportation services in west Denver.

3) \$89,612.00 is to be allocated to the Pueblo Senior Citizen Resource Development and Coordinating Agency to provide transportation services in Pueblo.

4) \$25,000.00 is to be allocated to the Department of Highways for signal timing improvements at County Line Road, and at Broadway, University and Quebec streets.

5) \$40,000.00 is to be allocated to the Department of Highways to install ramp metering on the eastbound on-ramp at I-270 and York Street.

6) 102,164.48 is to be allocated to the Department of Highways to purchase and install traffic signal controllers and cabinets along U.S. 285 in Englewood and at the C-470/Broadway interchange.

7) \$1,126.00 is to be allocated to the Southern Ute Tribe in accordance with the provisions of the Decisions and Orders of the Department of Energy.

8) \$1,608.78 is to be allocated to the Ute Mountain Ute Tribe in accordance with the provisions of the Decisions and Orders of the Department of Energy.

9) \$75,000.00 is to be reserved for future allocation.
