## EXECUTIVE ORDER PROCLAMATION

### EXTENDING DISASTER EMERGENCY IN DELTA, MESA AND MONTROSE COUNTIES, AND THE TOWN OF OAK CREEK IN ROUTT COUNTY

WHEREAS, spring snowmelt has caused flooding conditions to exist in Delta, Mesa and Montrose Counties, and the Town of Oak Creek in Routt County, Colorado, since May 14, 1984; and

WHEREAS, in response to the aforesaid conditions, a state of disaster emergency was declared to exist in Delta, Mesa and Montrose Counties and the Town of Oak Creek in Routt County, Colorado, by Proclamation effective May 23, 1984, and extended by Executive Orders dated June 27, 1984; July 23, 1984; August 27, 1984; September 24, 1984; October 24, 1984; November 23, 1984; December 24, 1984; January 30, 1985; February 27, 1985; March 25, 1985; April 29, 1985; May 31, 1985; July 29, 1985, nunc pro tunc to June 22, 1985; July 29, 1985, nunc pro tunc to July 22, 1985; August 21, 1985; October 16, 1985, nunc pro tunc to September 20, 1985; October 20, 1985; December 3, 1985, nunc pro tunc to November 19, 1985; December 19, 1985; January 19, 1986; February 10, 1986; March 7, 1986; April 11, 1986; May 9, 1986; June 6, 1986; July 3, 1986; August 5, 1986, nunc pro tunc to August 1, 1986; October 24, 1986, nunc pro tunc to August 31, 1986; September 29, 1986; October 29, 1986; November 28, 1986; December 26, 1986; and January 23, 1987; and

WHEREAS, the said state of disaster emergency expires after thirty (30) days unless otherwise extended by the Governor; and

WHEREAS, I, Roy Romer, Governor of the State of Colorado, do find that the aforementioned state of disaster emergency has not been dealt with to the extent that emergency conditions no longer exist within the meaning of C.R.S. 24-33.5-704;
