EXECUTIVE ORDER

RESTRICTION OF APPROPRIATION

- WHEREAS, as we look forward to investing in Colorado's future through education, infrastructure, transportation, and other investments, we must make certain that state government is wisely and efficiently spending the public funds entrusted to it;
- WHEREAS, current revenue estimates do not project sufficient revenues in fiscal year 1987-88 to carry out the functions of state government and to support its agencies and institutions;
- WHEREAS, the State of Colorado must take steps to assure that state government expenditures do not exceed revenues;
- WHEREAS, I have directed that state government use this budget shortfall as an opportunity to critically examine the functions of state government to determine where long range and permanent budget reductions can be made;
- WHEREAS, by Executive Order dated January 4, 1988, I directed the heads of the principal departments to report to me no later than Friday, January 9, 1988 on potential budget cuts, and I have now reviewed the information provided to me with the Office of State Planning and Budgeting;

NOW THEREFORE, I, Roy Romer, Governor of the State of Colorado, pursuant to the authority vested in me under the Constitution of the State of Colorado, and the statutes of the State of Colorado, including C.R.S., Sections 24-2-102(4) and 24-30-206(3), DO HEREBY ORDER THAT:
