APPOINTMENT OF A BOARD OF APPRAISERS

WHEREAS, 28-3-106(1)(s) C.R.S. 

LEGAL DESCRIPTION

Beginning at a point where South line of 4th Avenue intersects the East line of Logan Street, as now laid out and existing; thence South along said East line of Logan Street One Hundred Sixty-three and 77/100ths (163.77) Feet to a point where South line of Block Twenty (20), Arlington Park produced Westerly intersects said East line of Logan Street as now existing; thence East Two Hundred Twenty-six (226) Feet to a point where South line of Block Twenty (20), Arlington Park intersects Southwesterly line of Speer Boulevard

(also known as Forest Drive); thence in a Northwesterly direction along said Southwesterly line of Speer Boulevard Two Hundred Sixty-two and 23/100ths (262.23) Feet, more or less, to a point where South line of 4th Avenue intersects Southwesterly line of said Speer Boulevard; thence West along said South line of 4th Avenue Twenty-one and 2/10ths (21.2) Feet to point of beginning, being that portion of Block Twenty (20), Arlington Park lying West and South of said Speer Boulevard (also known as Forest Drive) and also that portion of Logan Street as shown by Original Plat of Arlington Park which has been vacated and which adjoins said Block Twenty (20) on the West, City and County of Denver and State of Colorado.

That part of the Southeast One-quarter (SE1) of the Northeast One-quarter (NE2) of Section Ten (10), Township Four (4) South Range Sixty-eight (68) West, more particularly described as follows: Beginning at a point on the North line of the Southeast One-quarter (SE $\frac{1}{2}$) of the Northeast One-quarter (NE $\frac{1}{2}$) of Section Ten (10), Township Four (4) South Range Sixty-eight (68) west, Eighty-six and 45/100ths (86.45) Feet East of Northwest corner of said Southeast One-cuarter (SE1) of the Northeast one-quarter (NE1) of said Section Ten (10), where East line of Logan Street intersects said North line of said Southeast One-quarter (SE1) of the Northeast One-quarter (NE+) of Section Ten (10); thence South along East line of Logan Street three hundred forty-one and 77/100th (341.77) feet, more or less, to North line of 3rd Avenue; thence East along said North line of 3rd Avenue Five Hundred Minety-two (592) Feet, more or less, to West line of Pearl Street; thence North Forty-four and 44/100ths (44.44) Feet, more or less, to Southwesterly line of Speer Boulevard; thence Northwesterly along said Southwesterly line of Speer Boulevard to the North line of said Southeast One-quarter (SEE) of the Northeast One-quarter (NEt) of said Section Ten (10); thence West along said North line Two Hundred and Twenty-six (226) Feet, more or less, to the place of beginning, City and County of Denver and State of Colorado.
