EXECUTIVE ORDER

PROCLAMATION CALL FOR FIRST EXTRAORDINARY SESSION OF THE FIFTY-SEVENTH GENERAL ASSEMBLY

- WHEREAS, Section 9 of Article IV of the Constitution of the State of Colorado provides that, "The Governor may, on extraordinary occasions, convene the General Assembly, by proclamation, stating therein the purpose for which it is to assemble; but at such special session no business shall be transacted other than that specially named in the proclamation," and Section 7 of Article V of the Constitution provides that, "The General Assembly shall meet at other times when convened in special session by the Governor;" and
- WHEREAS, in the opinion of the Governor, an extraordinary occasion has arisen because the immediate transportation needs of this state must be addressed; and
- WHEREAS, the State of Colorado must take emergency action to address the backlog of adult prisoners in county jails; and
- WHEREAS, other matters enumerated below require the attention of the General Assembly, and in the opinion of the Governor represent business to be transacted during this special legislative session;

NOW THEREFORE, I, Roy Romer, Governor of the State of Colorado, convene the Fifty-Seventh General Assembly of this State with this proclamation and summon the members of the Fifty-Seventh General Assembly to meet in Special Session at the State Capitol, in the City and County of Denver on the twenty-first day of June, 1989, at 10:00 a.m. and designate the following subjects for your consideration and appropriate legislative action:

- 1. Concerning surface transportation and increased funding to adequately finance surface transportation needs of the State of Colorado including but not limited to extension of current gasoline and special fuels taxes, providing a mechanism for financing transportation needs of the Denver metropolitan area, and providing for state and local government cooperation on transportation financing;
- 2. Concerning adult correctional facilities and programs and funding for those purposes;

- 3. Concerning application for a federal waiver to allow provision of long-term care services to persons with health conditions related to acquired immune deficiency syndrome in home and community-based settings, when such services are less costly than institutional care, and making an appropriation for this purpose;
- 4. Concerning revision of the public assistance system for families with dependent children to foster and support family self-sufficiency through education, training and employment opportunities and, in that connection, making other amendments to the public assistance system in order that such families avoid long-term welfare dependency, and making an appropriation for this purpose;
- 5. Concerning actions required for state compliance with the federal "Omnibus Budget Reconciliation Act of 1987," as amended;
- Concerning telephone service assistance programs for low-income individuals;
- 7. Concerning additional district court judges in the First Judicial District, the Fourth Judicial District and the Twenty-First Judicial District; and
- 8. Senate consideration for confirmation of gubernatorial appointments to boards and commissions.
